

# **Violence Prevention**

**About SHPPS:** SHPPS is a national survey periodically conducted to assess school health policies and practices at the state, district, school, and classroom levels. SHPPS was conducted in 1994, 2000, and 2006. The 2012 study collected data at the state and district levels only. School- and classroom-level data collection will take place in 2014.

#### **Health Education**

79.6% of states and 82.7% of districts provided funding for professional development or
offered professional development to those who teach health education on violence prevention
during the 2 years before the study.

About Violence Prevention at Each School Level

### **Health Services**

- Between 2000 and 2012, the percentage of districts that required schools to provide violence prevention in one-on-one or small-group sessions increased from 59.2% to 77.9%.<sup>1</sup>
- 11.8% of districts had arrangements with any organizations or healthcare professionals to provide violence prevention at other sites not on school property.
- 80.4% of states and 49.3% of districts provided funding for professional development or
  offered professional development to school nurses on violence prevention during the 2 years
  before the study.

#### **Mental Health and Social Services**

 During the 2 years before the study, 93.9% of states and 86.8% of districts provided funding for professional development or offered professional development to mental health or social services staff on violence prevention.

<sup>1</sup>Regression analyses were performed that took all available years of data into account. To account for multiple comparisons, selected changes are included if only if the p-value from the trend analysis was less than .01, and either the difference between the two endpoints (2000 and 2012) was greater than 10 percentage points or the 2012 estimate increased by at least a factor of two or decreased by at least half as compared to the 2000 estimate.

## **Safe and Healthy School Environment**


• The percentage of districts that had adopted a policy prohibiting gang activity increased from 62.5% in 2000 to 73.0% in 2012.
