
CDC Clinician Outreach and Communication Activity (COCA) conference call on April 16, 2020

Staff from the Mortality Statistics Branch, including Lee Anne Flagg, Farida Ahmad, Margaret Warner, and Bob Anderson, participated in a CDC Clinician Outreach and Communication Activity (COCA) conference call on April 16, 2020. The topic of the COCA call was "Guidance for Certifying Deaths Due to Coronavirus Disease 2019 (COVID-19)." The group presented information on how to certify cause of death properly, especially in cases where death was due to COVID-19, and shared provisional data on COVID-19 deaths to illustrate how the data are being used. <u>Deaths of Despair: Story on How Connecting Opioid</u> Data Extends the Possibilities for Suicide Research

Suicide, drug overdose, and alcohol-related deaths – known together as "deaths of despair" – are increasing across the United States.

The National Institute of Mental Health (NIMH), often uncovers clues – and new questions – by examining mortality data from the National Vital Statistics System (NVSS).

2019 Data Year Close-out Dates

As a reminder, the table below includes the contract closeout and file release dates for 2019 data. Note that to include a jurisdiction's most current information in the file release, all corrections and final file deliverables are due no later than the target dates listed. The target dates are highlighted in red, as are the contract closeout dates and the dates for final updates. The dates for final updates are subject to change and may be earlier, depending on the quality of the national file.

2019 Fetal Death File

(States) Contract closeout for 2019 fetal deaths	May 1, 2020
(States) Last date 2019 fetal death file updates accepted	June 26, 2020
(DACEB) Release final 2019 fetal death file to Hyattsville	August 27, 2020



2020 Mortality Transmissions during COVID-19

During this pandemic, our ability to quickly publish data about COVID-19 is greatly enhanced because more than half of the jurisdictions transmit mortality records to NCHS five or more times each week. While we know that not all jurisdictions have that capacity, if you have the capability to increase your frequency of transmission, it will improve the timeliness and completeness of the data we are publishing each weekday. Most of our tabulation processes run overnight, so transmission more frequently than daily is not necessary, but our system is generally available to accept data 24 hours a day, 7 days a week, and those with the STEVE ThinClient installed are often able to schedule their transmissions without manual intervention.

We can also work with you to change the frequency with which we send you reports from our Specialist teams. Many jurisdictions that submit daily elect to receive their checklists and other routine reports on a weekly basis; just contact your assigned DACEB staff to figure out what will work best for your situation.
