7. SUMMARY OF DEC. 5, 2002 ICF MEETING FOR FEDERAL AGENCIES. The December 5 meeting for federal agencies on "The ICF: Potential Influence on Disability and Rehabilitation in Federal Agencies" took place as scheduled, despite a surprise 9" snow storm that reduced agency attendance substantially. The meeting was sponsored by the Interagency Committee on Disability Research, and provided an opportunity to introduce agencies to the International Classification of

Functioning, Disability and Health (ICF) and to reinforce and explore ICF's potential for those already aware of the classification. There were a number of excellent presentations, including those by Dr.Somnath Chatterji of the World Health Organization, Dr. Mary Chamie of the United Nations Statistics Division, Dr. Geoffrey Reed of the American Psychological Association, and Dr. Lisa Iezzoni of Harvard Medical School and former member of the National Committee on Vital and Health Statistics, as well as remarks by two disability advocates. After lunch, participants broke into two groups to discuss possible agency applications of the ICF. There was general consensus that ICF, as a framework and as a classification system, could be used in addressing a wide-range of programmatic and research issues related to functioning, disability and access. Several agencies talked about incorporating ICF into their data gathering and data analysis. The full 15 page report is attached as "DEC5ICFMTG...".

8. MARCH 11, 2003 DEADLINE TO APPLY FOR GRANTS (Feb. 11 Letter of Intent requested). In 2003, \$1.5 million will be available to split up for up to 10 grants, and faith-based, foreign, domestic, university, government entities may apply. Awards will be made in December 2003. Some suggested topics are: Processes Underlying Self-Report; Processes Underlying Observation Measures; Research Design; Measurement Issues; Data Collection Techniques; Analytic Methods; and Data Display. The "Dynamic Health Assessments for Medical Rehabilitation Outcome" awards seem suited to many ICF projects, which we are told would be welcome submissions. The "Helpful Hints" attachment will be a guide for applicants. 9. DID YOU KNOW THAT THE ICF WAS UNANIMOUSLY APPROVED? The World Health Assembly UNANIMOUSLY (nearly 200 countries) approved the resolution on May 21, 2001, including approval by the U.S. and Canadian representatives. Sixteen countries took the floor and made very positive comments. Here is exactly what was approved: "WHA Resolution Text: The Fifty-fourth World Health Assembly,

ENDORSES the second edition of the 'International Classification of Functioning, Disability and Health' (ICF).
URGES Member States to utilize the ICF in their research, surveillance and reporting as appropriate, taking into account specific situations in

Member States, and , in particular, in view of potential future revisions; (3) REQUESTS the Director General to assist Member States, on request, to make use of ICF."

11. ASHA ADOPTS ICF FRAMEWORK. Check out an article in "Speech Pathology Online" at www.speechpathology.com by Travis Threats, "The Conceptual Framework of ASHA's New Scope of Practice for Speechlanguage Pathology". We quote: "In 2001, ASHA decided to use the World Health Organization's International Classification of Functioning, Disability and Health (WHO, 2001) as the framework for the profession it its Scope of Practice for Speech-Language Pathology (ASHA, 2001)...what is needed is not standardization of therapeutic approaches, which still need to be individualized to the client, but a standardized way of documenting and reporting results according to the components of the ICF."
