- **Asthma and the Environment: A Strategy to Protect Children.** This document, prepared by the Presidential Task Force on Environmental Health and Safety Risks to Children, describes environmental factors associated with the onset of asthma and triggers of asthma attacks. - **Asthma and Physical Activity in the School.** This easy-to-read booklet, designed by the National Asthma Education and Prevention Program (NAEPP), is for teachers and coaches who want to help students with asthma participate in sports and physical activities. It covers the causes of asthma, symptoms of an asthma attack, how to avoid and control asthma triggers, how to help students who take medications, and how to modify activities to match children's current asthma status. - **How Asthma-Friendly Is Your School?** This questionnaire and checklist developed by the NAEPP features seven items that can be used by parents, teachers, and school nurses to help pinpoint specific areas that may cause problems for children with asthma.
