
Enhanced Meningococcal Disease Surveillance Report, 2020



Confirmed and Probable Cases Reported to the National Notifiable Diseases Surveillance System, 2020



As part of Enhanced Meningococcal Disease Surveillance (EMDS)*, additional data and isolates were collected from 50 state and 3 large jurisdiction health departments. In 2020, the population under surveillance was 329,484,123 (the full United States population). EMDS focuses on: (1) collecting isolates from all cases; and (2) collecting complete case information, with an emphasis on college attendance for cases in people aged 15–24 years; history of sex with men for cases in males aged ≥16 years; and information on homelessness for all cases.

CSTE case definition: A confirmed case was defined as isolation of *Neisseria meningitidis* or detection of *N. meningitidis* by PCR from a normally sterile body site.

A probable case was defined as detection of *N. meningitidis* antigen by latex agglutination or immunohistochemistry.

Laboratory Confirmation Method

88.3% ($204/23\overline{1}$) of confirmed cases were confirmed by culture; of those 158 (77.5%) had isolates submitted to CDC.

8.7% (20/231) of confirmed cases were confirmed by PCR.

3.0% (7/231) of confirmed cases had unknown laboratory confirmation method.

Outbreaks

95.3% (224/235) of cases had information on association with an outbreak; of those, 2 (0.9%) were part of an outbreak.

Complement inhibitor use

68.1% (160/235) of cases had information on use of a complement component inhibitor; of those, 4 (2.5%) were taking a complement inhibitor.

Homelessness

96.2% (226/235) of cases had information on homelessness; of those, 14 (6.2%) were among people experiencing homelessness.

History of sex with men among cases in men

Among cases in men aged \geq 16 years, 47.0% (39/83) had information on history of sex with men; of those, 1 (2.6%) was identified as men who had sex with men (MSM).

Symptoms

80.4% (189/235) of cases had symptom information available; of those 0 had gastrointestinal symptoms (nausea, vomiting, or diarrhea) in the absence of typical meningococcal symptoms (headache, fever, neck stiffness, rash).

Antibiotic-resistant serogroup Y

50 NmY cases were reported. 41 (82.0%) had isolates available for characterization at CDC; of those, 8 (19.5%) were found to be ciprofloxacin- and penicillin-resistant, and 13 (31.7%) were found to be penicillin-resistant only. 2 additional penicillin-resistant only cases were identified in non-United States residents who sought care in the United States.

College attendance among cases in people aged 18-24 years

Among cases in people aged 18-24 years, 90.0% (27/30) had information on college attendance; 10 (37.0%) were in people attending college.

Vaccination Status among cases 18-24 years

MenACWY (meningococcal conjugate vaccine) receipt:

College students: 70.0% (7/10) had information on MenACWY receipt; of those 85.7% received ≥1 dose of MenACWY.

Persons not attending college: 76.5% (13/17) had information on MenACWY receipt; of those 69.2% received ≥1 dose of MenACWY.

MenB (serogroup B meningococcal vaccine) receipt:

College students: 70.0% (7/10) had information on MenB receipt; of those 14.3% received \geq 1 dose of MenB.

Persons not attending college: 64.7% (11/17) had information on MenB receipt; of those 18.2% received ≥ 1 dose of MenB.



HIV Infection among Meningococcal Disease Cases

Data collected on HIV status will allow CDC to assess the impact of the recent Advisory Committee on Immunization Practices recommendation for use of MenACWY vaccination in people with HIV (PWH)²

52.3% (123/235) of cases had information on HIV status; of those, 6 (4.9%) were identified as PLWH.
