Vital Statistics Modernization Community of Practice

The NVSS Modernization Community of Practice successfully organized the fourth and final formal NCHS-organized testing event of 2023 on December 4th -5th. The focus was on advancing jurisdictional capabilities to exchange mortality

data using FHIR. NVSS CoP is proud to report that 26 of 57 (or 46%) of the jurisdictions participated in the testing event, with seventeen (17) jurisdictional Vital Records Offices and their respective technical partners as testers. This included Idaho, Kentucky, Oregon, Nevada, Alaska, Iowa, Illinois, Florida, Arkansas, Kansas, Washington (new), Vermont, Alabama (new), Northern Mariana Islands, Mississippi, District of Columbia, and Maine.

Additionally, nine (9) jurisdictions, including Texas, American Samoa (new), Pennsylvania, Montana, New Hampshire, New York City, North Carolina, New York, and Guam participated as observers.

Key takeaways from the testing event include:

- Jurisdictional focus primarily on later testing plan tiers suggests advances in system maturity and notable progress through modernization pathway. Several states decided to bypass earlier tiers because they had completed them at past events.
- The community was very engaging and supportive of each other with issues they encountered.
- No bugs that would require code fixes were identified, and there were no blocking issues with the libraries, Canary, or the IGs that would prevent a VRO from completing the tests.
- Over 3,000+ messages were successfully transmitted to NCHS during the testing event, per ITB.

NVSS has announced the new testing event dates for 2024: February 26-27, June 3-4, September 9-10, and December 2-3. We encourage stakeholders to please mark your calendars and plan accordingly. Any jurisdictions interested in participating as an observer or tester are encouraged to email the NVSS CoP mailbox (nvssmodernization@cdc.gov).


The NVSS Modernization CoP continues to work towards 75% of jurisdictions completing FHIR Certification by the end of 2024. Jurisdictions must remember that **precertification and certification** are required steps in the NVSS FHIR Certification Pathway. The overarching goal of the precertification process is to ensure a jurisdiction's readiness for certification. A successful precertification effort should provide a problem-free path through the final certification process. As a reminder, the six steps of the NVSS Certification Pathway include enhancing systems, informal testing, formal testing, precertification, certification, and production. NCHS would

like to offer special thanks to its technical partners, CTE, Ruvos, NAPHSIS, and MITRE for their ongoing collaboration in the modernization efforts. Their valuable contributions have been instrumental in the success of our recurring meetings and organized testing events.

Notable Publications/Data Briefs

Provisional Life Expectancy Estimates for 2022



This report was released November 2023 and can be found at this <u>link</u>. It presents life expectancy at birth by year, Hispanic origin and race, and sex. In 2022, life expectancy at birth was 77.5 years, increasing by 1.1 years from 76.4 in 2021. Life expectancy at birth for males in 2022 was 74.8 years, representing an increase of 1.3 years from 73.5 in 2021. For females, life expectancy increased to 80.2 years, increasing 0.9 year from 79.3 in 2021. Other notable results can be found within the report.
