The Danish Institute for Human Rights is an independent state-funded institution. Our mandate is to promote and protect human rights and equal treatment in Denmark and abroad.

DISABILITY

Vision:

We will ensure that persons with disabilities enjoy the same human rights as everyone else.

Our goal is to:

- always refer to the ten greatest challenges that exist for implementing UN's Convention on the Rights of Persons with Disabilities in Denmark
- remove the barriers that prevent people with disabilities from full and effective participation in society.

To do so we focus on:

- ensuring that Denmark introduces a general prohibition against discrimination based on disability
- ensuring that the use of force in psychiatry is reduced and that compulsive restraint in excess of 48 hours is abolished
- ensuring that the state ceases to provide support to pay off mortgage loans for the construction of new large institutions
- changing the electoral legislation so people with disabilities do not lose their right to vote when put under guardianship.

THE GOLD INDICATORS

EQUALITY & NON-DISCRIMINATION



INDICATOR 1 – ARTICLE 5:

Percentage of persons with and without disabilities who, during the last year, have experienced discrimination due to sex, age, ethnicity, disability, religion, sexual orientation, height or weight



AWARENESS-RAISING

INDICATOR 2 – ARTICLE 8:

Percentage of persons with and without disabilities, who within the last week have experienced at least one person with a disability expressing an opinion or otherwise participating in a broadcast/segment/interview in radio, TV or other news media

ACCESSIBILITY



INDICATOR 3 – ARTICLE 9:

Percentage of persons with and without disabilities who, during the last week, have experienced problems of accessibility to public transportation such as local buses, train, motorised vehicles, taxi, etc.

PERSONAL INTEGRITY



INDICATOR 4 – ARTICLE 17:

Percentage of persons with and without disabilities, under the age of 30 who have been detained in a prison/detention centre or a psychiatric facility



INDEPENDENT LIVING

INDICATOR 5 – ARTICLE 19:

Percentage of persons with and without disabilities who feel strongly or very strongly that they have influence on their own lives



EDUCATION

INDICATOR 6 – ARTICLE 24:

Percentage of persons with and without disabilities under the age of 25, who leave school early (and thus fall within the EU classification 'early school leavers')

HEALTH



INDICATOR 7 – ARTICLE 25:

Percentage of persons with and without disabilities, who state that they are in good physical and/or mental health



EMPLOYMENT

INDICATOR 8 – ARTICLE 27:

Percentage of persons with and without disabilities who in a selected week had at least a few hours of paid employment



SOCIAL PROTECTION

INDICATOR 9 – ARTICLE 28:

Percentage of persons with and without disabilities who, during the last three years, have been substantially prevented from living what they consider a normal life, due to economic reasons

POLITICAL PARTICIPATION



INDICATOR 10 – ARTICLE 29:

Percentage of persons with and without disabilities who voted in the most recent election to the Danish Parliament (Folketinget)

10 REDUCED INEQUALITIES 

PRIORITY INDICATOR (FOR TARGET 10.3):

Percentage of population reporting having personally felt discriminated against or within the last 12 months on the basis of a ground of discrimination prohibited under international human rights law *

11 SUSTAINABLE CITIES AND COMMUNITIES 

PRIORITY INDICATOR (FOR TARGET 11.2):

Proportion of the population that has a public transit stop within 0.5 km *

16 PEACE AND JUSTICE 

PRIORITY INDICATOR FOR TARGET 16A):

Percentage of victims who report physical and/or sexual crime to law enforcement agencies during past 12 months *

4 QUALITY EDUCATION 

PRIORITY INDICATOR (FOR TARGET 4.7):

Percentage of 15-year old students enrolled in secondary school demonstrating at least a fixed level of knowledge across a selection of topics in environmental science and geoscience. [...] Disaggregation: sex and location (and others where data are available) *

3 GOOD HEALTH 

PRIORITY INDICATOR (FOR TARGET 3.4):

Probability of dying of cardiovascular disease, cancer, diabetes, or chronic respiratory disease between ages 30 and 70 *

8 GOOD JOBS AND ECONOMIC GROWTH 

PRIORITY INDICATOR (FOR TARGET 8.5):

Unemployment rate by sex, age-group and disability *

10 REDUCED INEQUALITIES 

PRIORITY INDICATOR (FOR TARGET 10.2):

Proportion of people living below 50% of median income disaggregated by age and sex *

16 PEACE AND JUSTICE 

PRIORITY INDICATOR (FOR TARGET 16.7):

Proportions of positions (by age, sex, disability and population groups) in public institutions (national and local legislatures, public service, and judiciary) compared to national distributions *
