SC&A Handout Sites with Unreviewed DR Methodology Templates and Reports Meeting of the Subcommittee for Procedure Reviews November 16, 2023

The National Institute for Occupational Safety and Health's (NIOSH's) development of a dose reconstruction (DR) methodology for many smaller sites under the Energy Employees Occupational Illness Compensation Program Act did not consist of the standard technical basis document (TBD) or site profile approach. In lieu of a TBD, NIOSH has developed for these sites a DR methodology guideline document and a DR template that contain facility-specific data, assumptions, and list of documents that provide the basis for the facility-specific data and assumptions. The Subcommittee has been provided separately an example of these documents from the Peek Street Facility, which have been reviewed by SC&A.

At the request of the Subcommittee for Procedure Reviews (SPR), NIOSH provided SC&A on July 7, 2022, with the list of facilities where DRs are completed using the DR methodology guidance and template. Table 1 lists the sites, current and previous versions of the templates, and current review status.
