Changes from version 7.0 to 7.1:

Enhancements:

1. **VFC Setup custom questions sort order** - Changed the order in which the questions are displayed on the Data Entry Screen and the Questionnaire Setup Screen. Removed the validation that was reordering the questions created based on the text and added the new Sort Order to order the questions in the order in which the questions were entered by user. **CMT 773**
2. **HPV Report Changes** – Checkbox added to allow user to include or exclude list of missing immunizations. List of missing immunizations caused delays in running the report for users running large assessments with many missing immunizations. A checkbox was added to the settings that are saved when the user saves report criteria for later use. **CMT 828**
3. **VIS ‘order’ request - Part I** – Allows users to an option to ‘check all’ for the VIS date question. **CMT 829**
4. **Create "Progress Status Bar" for Annual VFC Management Survey - Part I** - Created a progress bar status for when users run this report. The progress bar would indicate how far the report completed (to help show users that the report is running and to please wait). **CMT 831**
5. **Create CoCASA DB Backup Data Management tool** - Will prompt the user every two weeks to do a backup. If the user refuses, will prompt again in another two weeks. Also added a menu item to allow the user to delete old backups. **CMT 803**
6. **Create CoCASA DB Backup Data Management Instructions** – Created instructions on how to backup database. **CMT 837**

Bug fixes:

1. **Enable users to document adolescent coverage levels for site visits dated pre-2012** – Users in v7.0 attempting to add adolescent coverage information for a date in 2011 could not. Per a change request from user, added code and validation to enable users to enter Adolescent Coverage Levels from 09/01/2011 onwards. **CMT 823**

Changes from Version 6.2 to 7.0:

Enhancements:

1. **Need One Dose report enhancement** - The report "Need One Dose" enhanced to include dose/antigen name along with patient name and DOB. **CMT 727**



2. **Calculating the 4-day grace period in CoCASA** - The 4-day grace period was not calculating correctly in some scenarios where the period spans months and the beginning month has 31 days and the ending date has 30. Issue resolved. **CMT 768**
3. **Have another Submenu to show database location** - Added a submenu to Utilities > Database functions to show current database location. **CMT 771**
4. **Change how UTD status is counted** - For diseases where we've allowed a history of disease, lab evidence of disease or MD diagnosis of disease count as being UTD, it should be counted as such regardless of whether the ACIP recommendation box is selected or not. Currently, this is only the case when the box is selected. Change made. **CMT 772**
5. **Track Clinics** - Track clinics which have been entered into secondary or tertiary education. Renamed reports – **CMT 782**
6. **Allow non-VFC sites a way to use VFC site visit questionnaire, update reports to include Non-VFC Providers** - In Provider setup tab, change to remove lockout for VFC visit; however do not count 'non-VFC providers' in two reports used for VFC Management Survey. Currently, if a user indicates the provider is not a VFC provider on the provider tab, they are locked out from entering a VFC site visit questionnaire. Allow non-VFC providers to have a site visit questionnaire entered. However, the Core VFC/AFIX Activities Report and the Site Visit Questionnaire Report for CDC should only reflect providers enrolled in VFC. **CMT 784**
7. CoCASA Site Visit Questionnaire 2012 – CMT 790. Updates are as follows:
 - Inactivated Influenza = 7/26/11
 - Live Intranasal Influenza = 7/26/11
 - Human Papillomavirus = 5/3/11
 - Hepatitis A = 10/25/11
 - Meningococcal = 10/14/11
 - Polio = 11/08/11
 - Changes to Question 35.
 - Changes to Question #4, 14(B) and 35. Included following footnote under 14(B): "Note: Each vaccine storage unit requires one primary thermometer with a current certificate of calibration"
8. **Texas - TWICES Template** - Added template changes to version 7.0. Texas Medicaid and History of Varicella. Template added to NewDB.cocasa and added code to DBUpdate to the production database. **CMT 791**

9. **New filter feature for VFC Aggregated Noncompliant Summary Report** - Added new filter feature for VFC Enrollment feature. Added two dropdown boxes to get existing list of Counties and Regions from the database and create filter feature for the user to be able to filter the records using these two fields. **CMT 795**
10. **Two New reports that will list Providers who did and did not get a VFC Follow-up by the Initial Follow up date specified on the Documentation Tab of a Site Visit** - Created two List reports that report the Providers who received and yet to receive Initial Follow-up On Time. Created new filter feature to filter/include Non-VFC Providers. **CMT 796**
11. Reverting back a part of previously implemented change, as a result of requests from several users. **CMT 728** - Purpose of Contact Changes - User should be able to select VFC Secondary Educational Follow-up in combination with a VFC Site Visit. **CMT 797**
12. **Separate “Number of age eligible children in practice” and “Number of charts analyzed” for each age groups assessed** - Allowing the user to enter separate values for “Number of age eligible children in practice” and “Number of charts analyzed” for each age groups assessed, Childhood and Adolescent, on the Visit Information Tab under AFIX Visit. **CMT 798**
13. **Rename the “Providers Enrolled in Secondary/Tertiary Education Program” reports, since list reflects providers who have ‘received’ the visit – not ‘enrolled’.** - Rename the “Providers Enrolled in Secondary/Tertiary Education Program” reports, since list reflects providers who have ‘received’ the visit – not ‘enrolled’. Report titles changed to “Providers receiving a Secondary Educational Follow-up” and “Providers receiving a Tertiary Educational Follow-up.” **CMT 799**
14. **Add “Routine Follow-up Letter” back as an option choice for #35 in 2012 Questionnaire** - Added “Routine Follow-up Letter” back as an option choice for #35, where it asks “Please indicate how your initial follow-up interaction will occur.” **CMT 800**
15. **Registry (IIS): CVX - Vaccines Administered (HL7 Standard Code Set) for CDC** – link CVX for 90654 to 144. Correct spelling for CVX 144 (interdermal to intradermal), Td (adult) tetanus and diphtheria toxoids, not adsorbed, for adult use. 138 Active 9/30/2010. Note that this Td is not adsorbed. **CMT 802**
16. **Change VFC reports to include Non-VFC enrolled Providers** - These reports should include Non-VFC Enrolled Providers so grantees can also manage their “317/state” visits. Lists reports under the Questionnaire Reports. All reports under “VFC Questionnaire” section except VFC Questionnaire Results for CDC. **CMT 805**
17. Add new filter feature for VFC Site Visit Questionnaire Results report - Add a filter option to filter Providers based on their VFC Enrollment Status. **CMT 806**
18. **New vaccine and CVX codes (145 and 146)** - New vaccine and CVX (145 and 146). New NDC for 2011-2012 flu vaccines, minor corrections to CPT and trade name tables. **CMT 807**



19. **HPV Report** – New report added. Option to run report for females, males, or all. **CMT 810**

20. Template - "NJIS-CoCASA" – Template added. CMT 812

21. New CPT code 138 for Td – Added. CMT 813

Bug fixes:

1. **Replacing single Quotes while updating VFC Setup Custom Questions is the addition of multiple Single Quotes to the Question.** The Replace function to replace single quotes with two single quotes should only be used for SQL Queries directly to the database and not when using a dataset to update the database. The code was changed to include Replace function based on previous decision regarding using Single quotes in SQL Queries. But this is adding multiple Single quotes every time user imports the custom Questions. After a certain number of times, the Custom Question Text is increasing and crossing the limit set for the Text field (255). This Replace function should be removed while using Datasets to update database. This is not needed when using Datasets. This is required only when a Query is directly issued to the Database. **BUG 808**
2. Export Query for Exporting VFC Custom Questions is failing when large number of Questionnaires are using the Custom Questions - Updated Queries and the grouping and joining in the query so that only needed records are pulled from the join tables. Tested queries for Custom Questions and Multiple Choice Answers, tested the changes with test data and tested the import of Setup and CoCASA Data. **BUG 811**

1. **Incomplete Questionnaires Report Change for Question 35** - Change report so that Question 35 does not require an answer to be considered as complete if user selects option "Provided technical assistance at the time of the site visit, no further follow-up is needed" for Question 34. **Description:** If in #34 the "provided technical assistance..." is combined with any other of the 4 options, there should be an answer in #35. Question 36 requires an answer when Question 35 requires one. **CMT 779**

Bug fixes:

1. **Import process with Exclude patients with no immunizations fixed** - Import using template with "Exclude Patients with no Immunizations" is skipping all patient's records when first record in a file is invalid. **CMT 774**
2. **VFC Non-Compliant Providers report - Index out of bounds error** - Getting Index Out of bounds error for 2011 year report. The report is checking for the 5th option which is not present for Question 34. **CMT 780**
3. **Need One Does Report is missing Patient's Names** - Report was working in past versions. Report already has a name field, it is displaying blank patient's name. **CMT 785**
4. **Imported Patients Have No Shots When They Should** - Reported that some of the patients in a comma-delimited import file showed up in CoCASA with a blank immunization history. **CMT 786**
5. **Question 23 - Provider site visit summary Report** - Question 23 is not getting printed in the Summary of Non-Compliant High Risk Questions section of the report although it is getting counted as non-compliant in the number of non-compliant questions. **CMT 787**

1. Modified the Invalid Doses Report and the Missing Immunizations Reports to exclude a fourth dose of DTaP that was given between 4 months and 6 months after dose 3. That patient will, however, still be counted as incomplete and Not Up-To-Date on reports that show Up-To-Date status as a 4 month interval is not considered standard of practice. (CR-176)
2. The Missing Immunizations Report - Overdue report was modified to include two overdue sections. The first section will list patients that are eligible and are on or past the recommended age. The second section will list patients that are eligible and on or past the minimum age. The Missing Immunizations Report – Missing Any Doses report was modified to include a section to list all patients that received a fourth dose of DTaP between 4 months and 6 months after dose 3. (CR-177)
3. Updated the HIB and PCV algorithms to better accommodate the different schedules resulting from different brands of vaccine, of children that start late or schedules for those who take fewer doses as a result of advancing in age. (CR-178)
4. Enhancements for the Educational visit type. The changes include a new VFC Secondary Educational Follow up visit type, a new VFC Tertiary Educational Follow up visit type, and two new reports specifically to list those visits. (CR-179)
5. Changes were made to enhance the adolescent capabilities in CoCASA. The changes include age categories for AFIX visits, a new Feedback Method field, a new AFIX Visit Follow up visit type, along with corresponding modifications to the VFC reports. Additionally, the Adolescent Coverage report was modified to specify “Td OR Tdap” instead of “Td AND Tdap” on the summary line when both Td and Tdap are chosen in the report criteria. (CR-180)

74. Importing a VFC Setup does not overwrite any existing VFC Setup for that same year as it should. (527)

Bug fixes:

1. Address2 was still being set to "required" for users that upgraded to 1.2 before upgrading to 1.3.
2. Provider notes was still being set to "required" for users that upgraded to 1.2 before upgrading to 1.3.
3. The Total # Patient Records text box on the Summary Report flow chart had no border.
4. VFC custom question IDs were getting reversed when creating a new VFC setup.
5. Importing a CPT code of 90669 or a CVX code of 100 was automatically saving Prevnar as the brand name.
6. The width of the columns on the Single Antigen Report Childhood would not allow more than 2 digits.
7. The Individual Immunization History report would not run in cases where antigens were selected that were not 'recommended'.
8. The "As of" date on the Assessment Setup criteria tab would not accept future dates.
9. The User Profiles module in the Course had a script error.
10. The CoCASA Data export/import did not allow for special (Unicode) characters.
11. CoCASA Data could not always be successfully imported for users that had no custom questions in the VFC setup.

22. Added the MOVE button for assessments.
23. MMR and Varicella were not showing correctly on the Missing Immunizations reports.
24. Importing a CPT code of 90715 or CVX code of 115 was not getting the brand name of Boostrix.
25. An OLEDB error message was shown when no patients were imported from a text file.
