Persons aged 65 years and over not reporting Medicare coverage were asked explicitly about Medicare coverage, and persons aged under 65 years with no reported coverage were asked explicitly about Medicaid coverage. In 2006, NHIS underwent a sample redesign. The impact of the new sample design on estimates presented here is expected to be minimal.
