

## Prevalence of Low Weight-for-recumbent Length, Recumbent Length-for-age, and Weight-for-age Among Infants and Toddlers From Birth to 24 Months of Age: United States, 1999–2000 Through 2017–2018

Undernutrition in children is defined using weight-for-recumbent length, recumbent length-for-age, and weight-for-age. The Centers for Disease Control and Prevention (CDC) recommends using the World Health Organization (WHO) growth standards to monitor growth in children under age 2 years in the United States (1). The recommended definition of low values in infants is  $-2 z$  scores (corresponding to less than the 2.3rd percentile) on the WHO sex-specific growth standards (2). Less than the 5th percentile on the corresponding CDC sex-specific growth charts (3) also has been used as a cut point. Consequently, this report presents estimates using both definitions.

Based on the WHO growth standards, results from the 2017–2018 National Health and Nutrition Examination Survey (NHANES), using measured recumbent lengths and weights, indicate that an estimated 0.2% of infants and children under age 24 months have low weight-for-recumbent length, 2.9% have low recumbent length-for-age, and 0.9% have low weight-for-age. Based on the CDC growth charts, 2.9% of infants and toddlers have low weight-for-recumbent length, 5.0% have low recumbent length-for-age, and 8.3% have low weight-for-age. Differences between the WHO and CDC growth charts are described in the references below.

Table 1 shows the unweighted sample sizes for infants and toddlers with measured recumbent length or weight for each survey cycle from 1999–2000 through 2017–2018. Table 2 shows the prevalence of low weight-for-recumbent length, recumbent length-for-age, and weight-for-age among infants and toddlers from birth to 24 months for each survey cycle from 1999–2000 through 2017–2018. The variability of the 2-year estimates over time is consistent with what might be observed in the smaller sample size of infants and toddlers in NHANES. Estimates are not shown for individual age groups due to low prevalence for some measures.

NHANES uses a stratified, multistage probability sample of the civilian noninstitutionalized U.S. population. Since 1999, data have been collected on persons of all ages beginning from birth. A household interview and a physical examination are conducted for each survey participant. During the physical examination, conducted in a mobile examination center, recumbent length and weight are measured as part of a more comprehensive set of body measurements. These measurements are taken by trained health technicians, using standardized measuring

procedures and equipment. Observations for persons missing a valid recumbent length or weight measurement are not included in the data analysis.
