

## **Notable Publications/Data Briefs**

Births in the United States, 2020



This NCHS Data Brief accompanies the release of the public use birth file for 2020 and shows selected birth highlights for 2020. The general fertility rate declined 4% to another record low for the US in 2020. Birth rates declined among women of all age groups 15-44 with the largest declines for women under age 25. The low-risk cesarean delivery rate rose from 2019 to 2020 with increases for each race and Hispanic origin group. The U.S. preterm birth rate declined from 10.23% in 2019 to 10.09% in 2020, with declines among both early and late preterm births.
