


Figure 7.1. Percentage of adults aged 18 years and over who met the 2008 federal physical activity guidelines for aerobic activity through leisure-time aerobic activity: United States, 1997–March 2011





- In early 2011, 45.8% (95% confidence interval = 44.27%–47.40%) of U.S. adults aged 18 and over met the 2008 federal physical activity guidelines for aerobic activity (based on leisure-time activity), which was not significantly different than the early 2010 estimate of 46.0%.
- The annual percentage of adults aged 18 and over who met the 2008 federal physical activity guidelines for aerobic activity (based on leisure-time activity) was lowest in 1998 (40.3%) and highest in 2009 (47.0%).





- The age-sex-adjusted percentage of adults who met the 2008 federal physical activity guidelines for aerobic activity (based on leisure-time activity) was 35.0% for Hispanic adults, 50.2% for non-Hispanic white adults, and 39.2% for non-Hispanic black adults.
- Non-Hispanic white adults were more likely to meet the 2008 federal physical activity guidelines for aerobic activity (based on leisure-time activity) than Hispanic adults and non-Hispanic black adults.

- In early 2011, 21.2% (95% confidence interval = 19.85%–22.47%) of U.S. adults aged 18 and over met the 2008 federal physical activity guidelines for both aerobic and musclestrengthening activities (based on leisure-time activities), which was the same as the early 2010 estimate.
- The annual percentages of adults aged 18 and over who met the 2008 federal physical activity guidelines for both aerobic and muscle-strengthening activities (based on leisure-time activities) was lowest in 1998 (14.5%) and highest in 2010 (20.4%).





- Non-Hispanic white adults were more likely to meet the 2008 federal physical activity guidelines for both aerobic and muscle-strengthening activities (based on leisure-time activities) than Hispanic adults and non-Hispanic black adults.
