
General health status

Figure 11.1. Percentage of persons of all ages who had excellent or very good health: United States, 1997–September 2017



NOTES: Data are based on household interviews of a sample of the civilian noninstitutionalized population. Health status data were obtained by asking respondents to assess their own health and that of family members living in the same household as excellent, very good, good, fair, or poor. The analyses exclude persons with unknown health status (about 0.1% of respondents each year). See Technical Notes for more details.

- For January–September 2017, the percentage of persons who had excellent or very good health was 66.5% (95% confidence interval = 65.81%–67.13%), which was not significantly different from the 2016 estimate of 66.4%.
- The percentage of persons who had excellent or very good health decreased, from 68.5% in 1997 to 65.9% in 2006. Since 2006, the percentage of persons who had excellent or very good health has remained stable.





Figure 11.2. Percent distribution of respondent-assessed health status for all ages, by sex: United States, January–September 2017

- For both sexes combined, most persons' health was either excellent (35.3%) or very good (31.2%). A smaller percentage of persons had good (23.5%), fair (7.8%), or poor (2.2%) health. This pattern held for males and females.
- Men were more likely to have excellent health compared with women. Women were more likely than men to have fair or poor health.


Figure 11.3. Percentage of persons of all ages who had excellent or very good health, by age group and sex: United States, January–September 2017

- For both sexes combined, the percentage of persons with excellent or very good health decreased with age, 85.0% for those under age 18 years to 64.7% for those aged 18–64, and 46.0% for those aged 65 and over. This pattern was observed in both men and women.
- For persons of all ages and adults aged 18–64, males were more likely than females to have excellent or very good health.

Estimates are age-sex-adjusted using the projected 2000 U.S. population as the standard population and three age groups: under 18 years, 18–64, and 65 and over. See Technical Notes for more details.

- After adjustment for age and sex, the percentage of persons by race and ethnicity who had excellent or very good health was 61.8% for Hispanic persons, 71.0% for non-Hispanic white persons, and 59.8% for non-Hispanic black persons.
- Of the three race and ethnicity groups, non-Hispanic white persons were more likely to have excellent or very good health compared with non-Hispanic black persons and Hispanic persons.
