

## **Health Insurance Coverage: Early Release of Quarterly Estimates From** the National Health Interview Survey, January-June 2019

Since 2001, the National Center for Health Statistics (NCHS) National Health Interview Survey (NHIS) Early Release Program has released selected estimates of health and health care for the civilian noninstitutionalized U.S. population. This table presents quarterly estimates of health insurance coverage disaggregated by age group and poverty status for the civilian noninstitutionalized U.S. population based on data from the January-June 2019 NHIS. These estimates are being published prior to final data editing and final weighting to provide access to the most recent information from the NHIS. This table accompanies a more detailed report that provides cumulative estimates for January-June 2019 entitled "Health Insurance Coverage: Early Release of Estimates From the National Health Interview Survey, January-June 2019" available from the NHIS website at https://www.cdc.gov/nchs/nhis.htm.

Poverty categories are based on the ratio of the family's income in the previous calendar year to the appropriate poverty threshold (given the family's size and number of children), as defined by the U.S. Census Bureau for that year. Persons categorized as "poor" have a ratio less than 1.0 (i.e., their family income is below the poverty threshold); "near poor" persons have incomes of 100% to less than 200% of the poverty threshold; and "not poor" persons have incomes that are 200% of the poverty threshold or greater. The remaining group of respondents were "unknown" with respect to poverty status and are not shown separately in the table but are included in the totals for each age group. The percentage of respondents with unknown poverty status in the first quarter of 2019 was 9.0% and in the second quarter of 2019 was 8.8%. Estimates may differ from estimates that are based on both reported and imputed income.

NOTES: These health insurance estimates are being released prior to final data editing and final weighting to provide access to the most recent information from the National Health Interview Survey. Occasionally, due to decisions made for the final data editing and weighting, estimates based on preliminary editing procedures may differ from estimates based on final files. The estimates are based on a sample of the population and therefore are subject to sampling error. Quarterly estimates have wider confidence intervals than annual estimates due to smaller sample sizes, and this should be taken into account when evaluating the statistical significance of differences between groups and changes over time. Data are based on household interviews of a sample of the civilian noninstitutionalized population.

<sup>&</sup>lt;sup>2</sup>A person was defined as uninsured if he or she did not have any private health insurance, Medicare, Medicaid, Children's Health Insurance Program (CHIP), state-sponsored or other government-sponsored health plan, or military plan. A person was also defined as uninsured if he or she had only Indian Health Service coverage or had only a private plan that paid for one type of service, such as accidents or dental care.

<sup>&</sup>lt;sup>3</sup>Public health plan coverage includes Medicaid, CHIP, state-sponsored or other government-sponsored health plan, Medicare, and military plans. A small number of persons were covered by both public and private plans and were included in both categories.

<sup>&</sup>lt;sup>4</sup>Private health insurance coverage includes any comprehensive private insurance plan (including health maintenance and preferred provider organizations). These plans include those obtained through an employer, purchased directly, purchased through local or community programs, or purchased through the Health Insurance Marketplace or a state-based exchange. Private coverage excludes plans that pay for only one type of service, such as accidents or dental care. A small number of persons were covered by both public and private plans and were included in both categories.
