


Figure 14.1. Prevalence of diagnosed diabetes among adults aged 18 and over: United States, 1997–2011





- For 2011, 8.9% (95% confidence interval = 8.51%–9.30%) of adults aged 18 and over had ever been diagnosed as having diabetes, which was not significantly different from the 2010 estimate of 9.2%.
- The prevalence of diagnosed diabetes among adults aged 18 and over increased from 5.4% in 1999 to 9.2% in 2010.

NOTES: Data are based on household interviews of a sample of the civilian noninstitutionalized population. • Prevalence of diagnosed diabetes is based on self-report of ever having been diagnosed with diabetes by a doctor or other health professional. Persons reporting "borderline" diabetes status and women reporting diabetes only during pregnancy were not coded as having diabetes in the analyses. • The analyses excluded persons with unknown diabetes status (about 0.1% of respondents each year). • See "Technical Notes" for more details.



Figure 14.2. Prevalence of diagnosed diabetes among adults aged 18 and over, by age group and sex: United States, 2011





- For both sexes combined, the prevalence of diagnosed diabetes increased with age. Adults aged 65 and over (20.6%) were more than eight times as likely as adults aged 18–44 (2.4%) to have been diagnosed with diabetes.
- For the age groups 55-64 and 65 and over, men had a higher prevalence of diagnosed diabetes than women.

- The age-sex-adjusted prevalence of diagnosed diabetes was 12.0% for Hispanic persons, 7.0% for non-Hispanic white persons, and 12.4% for non-Hispanic black persons.
- The prevalence of diagnosed diabetes was higher among non-Hispanic black persons and Hispanic persons than among non-Hispanic white persons.
