



Figure 11.1. Percentage of persons of all ages who had excellent or very good health: United States, 1997–March 2015

- For January–March 2015, the percentage of persons who had excellent or very good health was 66.7% (95% confidence interval = 65.49%–67.99%), which was not significantly different from the 2014 estimate of 66.5%.
- The percentage of persons who had excellent or very good health decreased from 68.5% in 1997 to 65.9% in 2006.






NOTES: Data are based on household interviews of a sample of the civilian noninstitutionalized population. Health status data were obtained by asking respondents to assess their own health and that of family members living in the same household as excellent, very good, good, fair, or poor. The analyses excluded the 0.1% of persons with unknown health status. See Technical Notes for more details.

- For both sexes combined, most persons' health was either excellent (36.6%) or very good (30.1%). Smaller percentages of persons had good (23.3%), fair (7.6%), or poor (2.4%) health.
- Women were more likely than men to have fair health.





NOTES: Data are based on household interviews of a sample of the civilian noninstitutionalized population. Health status data were obtained by asking respondents to assess their own health and that of family members living in the same household as excellent, very good, good, fair, or poor. The analyses excluded the 0.1% of persons with unknown health status. See Technical Notes for more details.

- For both sexes combined, the percentage of persons with excellent or very good health decreased with age: 85.3% for those under age 18, 64.8% for those aged 18–64, and 45.3% for those aged 65 and over. This pattern was seen in both men and women.
- For persons of all ages combined, men were more likely than women to have excellent or very good health.




Figure 11.4. Age-sex-adjusted percentage of persons of all ages who had excellent or very good health, by race/ethnicity: United States, January–March 2015

Estimates are age-sex adjusted using the projected 2000 U.S. population as the standard population and using three age groups: under 18, 18–64, and 65 and over. See Technical Notes for more details.

- After adjustment for age and sex, the percentages of persons who had excellent or very good health were 59.1% for Hispanic persons, 71.5% for non-Hispanic white persons, and 59.7% for non-Hispanic black persons.
- Of the three race/ethnicity groups, non-Hispanic white persons were most likely to have excellent or very good health followed by non-Hispanic black and Hispanic persons.
