

Figure 14.1. Prevalence of diagnosed diabetes among adults aged 18 and over: United States, 1997– June 2017



NOTES: Data are based on household interviews of a sample of the civilian noninstitutionalized population. Prevalence of diagnosed diabetes is based on self–report of ever having been diagnosed with diabetes by a doctor or other health professional. Persons reporting "borderline" diabetes status and women reporting diabetes only during pregnancy were not coded as having diabetes in the analyses. The analyses exclude persons with unknown diabetes status (about 0.1% of respondents each year). See Technical Notes for more details.

- For January–June 2017, 9.8% (95% confidence interval = 9.22%–10.31%) of adults aged 18 and over have been diagnosed with diabetes. This percentage was not significantly different from the 2016 estimate of 9.4%.
- The prevalence of diagnosed diabetes among adults aged 18 and over increased from 5.1% in 1997 to 9.2% in 2010, and then more slowly from 2010 through January–June 2017.




Figure 14.2. Prevalence of diagnosed diabetes among adults aged 18 and over, by age group and sex: United States, January–June 2017

- For both sexes combined, the prevalence of diagnosed diabetes increased with age. Adults aged 65 and over (20.1%) were more than seven times as likely as those aged 18–44 (2.8%) to have been diagnosed with diabetes. Men aged 65 and over (23.3%) were more than nine times as likely as men aged 18–44 (2.4%) to have been diagnosed with diabetes, while women aged 65 and over (17.5%) were more than five times as likely as women aged 18–44 (3.2%) to have been diagnosed with diabetes.
- For adults aged 18 and over, 55-64 and 65 and over, women were less likely than men to have been diagnosed with diabetes.

- The age-sex-adjusted prevalence of diagnosed diabetes was 13.0% for Hispanic adults, 7.2% for non-Hispanic white adults, and 11.4% for non-Hispanic black adults.
- The prevalence of diagnosed diabetes was lower among non-Hispanic white adults compared with Hispanic adults and non-Hispanic black adults. The prevalence of diagnosed diabetes among non-Hispanic black adults was not significantly different from Hispanic adults.
