Cumulative reach: 662 individuals trained


Implemented the Comprehensive School Physical Activity Program (CSPAP)

Communication and Data Products

Year 1: 21 products- including diabetes information and prevention guides, FL transportation guides, physical activity and healthy eating tips for children with disabilities, etc.

Year 2: 19 products- including handouts for parents of CSPAP schools, domestic violence (DV) and PWD handout in partnership with a local DV shelter, etc.

Year 3: 19 products- including school reports and educational materials, school community resource guides, etc.

Year 4: 22 products- including ADA Anniversary poster, AUCD Conference poster, service animal self advocacy resource, etc.

Year 5: 21 products- including DCPG Partner expansion and engagement plan, COVID-19 vaccine and prevention information, resources for veterinarians, etc.
