**Program Description:** In spring 2019, Stratis Health, served as the Federal Office of Rural Health Policy (FORHP) Rural Quality Improvement Technical Assistance Center (RQITA). They convened a series of antibiotic stewardship focus groups with high performing critical access hospitals (CAH). The purpose of this webinar is the focus groups who identified and compiled strategies and best practices from CAH that have successfully implemented all seven of the core elements of antibiotic stewardship. Specific attention was paid to the barriers CAHs face in addressing antibiotic stewardship, including limited resources, competing priorities, and low patient volumes. In this presentation "The ABCs of ASPs for CAHs: Tips for Implementing Antibiotic Stewardship in a Critical Access Hospital", Dr. Michele Evink, Dr. Melissa Toon, and Sarah Brinkman will discuss findings from the focus groups, including identified barriers and suggested strategies for implementing and enhancing antibiotic stewardship in CAHs. Drs. Evink and Toon will share from their personal experience as pharmacy leaders of antibiotic stewardships at their own CAHs
