

















# CDC FY 2021 Sustainability Scorecard

Data as of 9/30/2021

	<p><b>Facility Energy Efficiency</b>                  Reduced energy intensity in goal-subject facilities by 30% compared to FY 2003 and reduced energy intensity from the prior year. FY 2021 actual reduction was <b>29%</b> to FY 2003 and <b>2.6%</b> decrease to FY 2020.</p>	
	<p><b>Efficiency Measures/Investment</b>                  Evaluated 90% of EISA-covered facilities for efficiency opportunities and utilized performance contracting. As of FY 2021, <b>0%</b> of facilities have been evaluated and <b>\$0</b> of performance contracts was awarded.</p>	
	<p><b>Renewable Energy</b>                  Used at least 7.5% percent electricity from renewable sources as a percentage of facility electricity use. FY 2021 renewable electricity use was <b>13.5%</b>.</p>	
	<p><b>Water Efficiency</b>                  Reduced potable water intensity by at least 20% from FY 2007 baseline and reduced water intensity from the prior year. FY 2021 actual reduction was <b>37.2%</b> and <b>15.8%</b> decrease to FY 2020.</p>	
	<p><b>Transportation/Fleet Management</b>                  Achieved a 20% reduction in petroleum use compared to FY 2005 and is reduced petroleum use from the prior year. FY 2021 GSA FAST data is inaccurate and will not be used (complete data was not reported).</p>	
	<p><b>High Performance Sustainable Buildings</b>                  Achieved 15% compliance with sustainable building criteria in owned buildings or GSF and increased the percentage of sustainable buildings or GSF from the prior year. FY 2021 actual was <b>29.6%</b> GSF and <b>0%</b> GSF increase from FY 2020.</p>	
	<p><b>Sustainable Acquisition</b>                  Percentage of sustainable acquisitions of total actions (both number of actions and dollar value) increased from prior year percentages. FY 2021 actual was <b>1.6%</b> of contract actions and <b>5.3%</b> of dollar value contained statutory environmental requirements. This is an <b>increase</b> to last year's percentages of <b>0.2%</b> and <b>3.9%</b>, respectively.</p>	
	<p><b>Scope 1&amp;2 GHG Emission Reduction</b>                  Scope 1&amp;2 GHG reduction from FY 2008 = 45.8%.</p>	

\*FY 2020 fleet petroleum use was abnormally low due to reduced travel.

<b>Reduction in Energy Intensity</b>
<b>GREEN:</b> Agency achieved >30% reduction compared to 2003 AND achieved a reduction in energy intensity from the prior year.
<b>YELLOW:</b> Agency achieved >30% reduction compared to 2003 OR achieved a reduction in energy intensity from the prior year.
<b>RED:</b> Agency did not achieve a 30% reduction in energy intensity compared to 2003 AND did not achieve a reduction in energy intensity from the prior year.
<b>Efficiency Measures/Investment</b>
<b>GREEN:</b> >90% of facility evaluations completed/updated within last 4 years AND awarded performance contracts in the fiscal year.
<b>YELLOW:</b> >75% facility evaluations completed/updated within last 4 years OR awarded performance contracts in the fiscal year.
<b>RED:</b> <75% of facility evaluations completed/updated within last 4 years & agency did not award any performance contracts in the fiscal year.
<b>Renewable Energy</b>
<b>GREEN:</b> Renewable electricity comprised >7.5% of total electricity use.
<b>YELLOW:</b> Renewable electricity combined with non-electric renewable energy sources (thermal + mechanical) comprised >7.5% of total electricity use.
<b>RED:</b> Renewable electricity combined with non-electric renewable energy sources (thermal + mechanical) comprised <7.5% of total electricity use.
<b>Water Efficiency</b>
<b>GREEN:</b> Agency achieved >20% reduction in potable water use intensity compared to 2007 AND reduced its potable water use intensity from the prior year.
<b>YELLOW:</b> Agency achieved >20% reduction compared to 2007 OR achieved a reduction in potable water intensity from the prior year.
<b>RED:</b> Agency did not achieve a 20% reduction compared to 2007 AND did not reduce potable water use intensity from the prior year.
<b>Transportation/Fleet Management</b>
<b>GREEN:</b> Agency achieved >20% reduction in petroleum use compared to 2005 AND achieved a reduction in petroleum use from prior year.
<b>YELLOW:</b> Agency achieved >20% reduction in petroleum use compared to 2005 OR achieved a reduction in petroleum use from prior year.
<b>RED:</b> Agency did not achieve a 20% reduction in petroleum use compared to 2005 AND did not achieve a reduction in petroleum use from prior year.
<b>High Performance Sustainable Buildings</b>
<b>GREEN:</b> At least 15% of agency owned buildings or GSF meet sustainable building criteria and the agency increased percentage of sustainable buildings or GSF from the prior year.
<b>YELLOW:</b> At least 15% of agency owned buildings or GSF meet sustainable building criteria OR the agency increased percentage of sustainable buildings or GSF from the prior year.
<b>RED:</b> Less than 15% of agency's inventory meets sustainable building criteria AND the agency decreased percentage of sustainable buildings or GSF from the prior year.
<b>Sustainable Acquisition</b>
<b>GREEN:</b> Agency increased percentage of sustainable acquisitions of total actions (both number of actions & dollar value) from prior year percentage levels.
<b>YELLOW:</b> Agency increased percentage of sustainable acquisitions of total actions (either number of actions or dollar value) from prior year percentage levels.
<b>RED:</b> Agency's percentage of sustainable acquisitions from total actions (number of actions & dollar value) remained the same or decreased from prior year.
