Data Quality Alerts: Weekly COVID-19 Vaccination Modules

Purpose

The NHSN application was updated on July 8, 2021 to create new data quality alerts for the Weekly COVID-19 Vaccination Modules within the long-term care (LTC), Dialysis, and Healthcare Personnel Safety (HPS) Components. These data quality alerts generate within the application for Weekly COVID-19 Vaccination Modules data for residents in LTC facilities, healthcare personnel (HCP) in LTC facilities, HCP in non-LTC facilities (e.g., hospitals), and patients in outpatient dialysis facilities.

NHSN regularly reviews data reported through the Weekly COVID-19 Vaccination Modules to understand trends and to identify potential reporting errors. Data that were potentially entered in error are flagged by the NHSN application and an alert is automatically displayed on the application landing page. Alerts for the Weekly COVID-19 Vaccination Modules are generated when vaccination rates for a reporting week are less than or equal to 10 percent. This guide provides instructions to help users locate data alerts and correct or confirm flagged data.

Brief Description

When a Vaccination Coverage Rate Alert is selected, a "Manage Alerts" page shall be displayed.

- 1. The week start date and week end date columns provide information on the reporting week that received the data flag.
- 2. The vaccination form type provides information on which module is producing the report.

Correcting Data that are Flagged for Potential Errors:

 Once you log into NHSN, the alerts page will appear with the number of COVID-19 vaccination data alerts. Click on the box. Otherwise, the alerts page can be accessed by clicking on "Alerts" on the left-hand navigation bar.
