Disclaimer

Issues Matrix Pertaining to the Review of OCAS-PR-012, Worker Outreach Program, and ORAUT-PROC-0097, Conduct of the Worker Outreach Program Procedure

This latest revision of the OCAS-PR-012 issues matrix follows the format and issue numbering established in Revision 4 (SC&A 2012b), including a table of abbreviated summaries of issues and action items. Revision 4 incorporated all previously identified action items and commitments from previous issues matrices, DCAS formal written responses, and less formal venues, such as Work Group discussions (as documented by meeting transcripts) or e-mail communication. For each Finding or Observation, SC&A stated the original finding/observation from its *Review of OCAS-PR-012: Worker Outreach Program* (SC&A 2010a) and provided a brief summary of the Work Group resolution history, including a numbered list of "Work Group Recommended Action Items" and "Other Actions Proposed/Considered" (if applicable).

The final column of the matrix contains SC&A's assessment of the status of each action, which has been updated following Work Group meetings on August 29, 2012, and November 8, 2012. The most recent updates to matrix items are marked in blue font.

A revised draft of OCAS-PR-012 (OCAS 2012c) was reviewed at the November 8, 2012, Work Group meeting. All findings specific to the procedure have been resolved to the Work Group's satisfaction.

Three issues remain in progress at this time: Finding 3, Finding 4, and Observation 3. None of these issues impact the revision and issuance of OCAS-PR-012.
