

# Active Bacterial Core Surveillance (ABCs) Report Emerging Infections Program Network group B streptococcus, 2008



# **ABCs Areas**

California (3 county San Francisco Bay area); Colorado (children < 1 year in 5 county Denver area); Connecticut (children < 1 year); Georgia (20 county Metro area); Maryland; Minnesota; New Mexico; New York (15 county Rochester and Albany areas); Oregon (3 county Portland area); Tennessee (11 urban counties)

## **ABCs Population**

The surveillance areas represent 28,338,691 persons and 473,736 live births. Source: National Center for Health Statistics bridged-race vintage 2008 postcensal file and 2007 state vital records

# **ABCs Case Definition**

Invasive group B streptococcal disease: isolation of group B streptococcus from a normally sterile site in a resident of a surveillance area in 2008. Early-onset cases occur at < 7 days of age and late-onset occur between 7 and 89 days of age.

# **ABCs Methodology**

ABCs personnel routinely contacted all microbiology laboratories serving acute care hospitals in their area to identify cases. Standardized case report forms that include information on demographic characteristics, clinical syndrome, and outcome of illness were completed for each identified case. Regular laboratory audits assessed completeness of active surveillance and detected additional cases.

Rates of early-onset and late-onset group B streptococcal disease were calculated using estimates of **live births for 2007**. All other rates were calculated using population estimates for 2008. For national estimates of cases, raceand age-specific rates of disease were applied from the aggregate surveillance area to the age and racial distribution of the 2008 U.S. population and to the **2007 live births** for early-onset and late-onset disease. Cases with unknown race were distributed by area based on reported race distribution for known cases within the eight age categories.

 Early-Onset Cases: 1,200 (0.28/1,000 live births)

 Late-Onset Cases: 1,125 (0.26/1,000 live births)

 Total Cases: 22,500 (7.4/100,000 population)

 Deaths: 1,600 (0.53/100,000 population)

Objective: Decrease the incidence of invasive early-onset group B streptococcal disease to 0.5 cases per 1,000 live births.
