¹ In addition, the FY 2016 Zika Response and Preparedness Act (P.L. 114-223) provided \$397 million to CDC for Zika preparedness and response.

² FY 2016 Immediate Zika Response amounts are consistent with Congressional Notifications of transfer authority, prior to the enactment of the Zika supplemental appropriation.

³ The FY 2016 appropriation included a total of \$60 million in additional, one-time funding to Diabetes and Heart Disease and Stroke to facilitate the close-out of the Partnerships to Improve Community Health (PICH) program. The FY 2017 report language indicates that Diabetes and Heart Disease and Stroke funding should not support continuation of PICH activities.

⁴ FY 2017 Enacted totals include funding for Flint, Michigan response, which includes \$15 million for Lead Poisoning Prevention (available through FY 2018) and \$20 million for a Lead Exposure Registry and Advisory Council (available through FY 2020).

⁵ FY 2016 totals reflect CDC's reprogramming of \$148 million from the FY 2015 Ebola emergency appropriation to fund Immediate Zika Response within the Cross-Cutting Activities and Program Support account, prior to enactment of the Zika supplemental appropriation.
