


# FRIDAY UPDATE


## PHEP Cooperative Agreement Updates

### Registration Now Open for July 13 HPP-PHEP Recipient Meeting

CDC and the Office of the Assistant Secretary for Preparedness and Response (ASPR) will host a virtual joint HPP-PHEP recipient business meeting from **1 p.m. to 4 p.m. EDT on Wednesday, July 13**. Joint agenda topics include the future of preparedness and response post-COVID-19. As this will be a discussion-based meeting, recipients should come prepared to discuss the challenges they're facing and how HPP and PHEP can work together to address these issues. In addition to joint topics, discussions will be held on HPP- and PHEP-specific topics. **[Registration is required to attend this event.](#)** Upon registering, recipients will receive an email with the Zoom event link as well as a calendar placeholder. ASPR and CDC will email the final agenda to HPP and PHEP recipients.

### PHEP BP4 Begins July 1

Today, July 1, is the start of PHEP Budget Period 4 (BP4), which provides a total of **[\\$651,788,620](#)** in fiscal year 2022 funding to 62 PHEP recipients. Recipients should closely review the terms and conditions outlined in their Notices of Awards. The terms and conditions of the awards and the technical review summaries of the funding applications may include budget or programmatic conditions of award that recipients must address. Recipients must respond to these conditions by **Monday, August 15**, in the PERFORMS BP4 Program Management Module and, if applicable, GrantSolutions. # Emergency Response Activities

## CDC Activates Emergency Operations Center for Monkeypox Response

On June 28, CDC activated its Emergency Operations Center (EOC) in response to the monkeypox outbreak. CDC's activation of the EOC allows the agency to further increase operational support for the response to meet the outbreak's evolving challenges. This action stands up CDC's command center for monitoring and coordinating the emergency response to monkeypox and mobilizing additional CDC personnel and resources. The activation of the EOC will serve to further supplement the ongoing work of CDC staff to respond to this outbreak.

## Guidance Now Available on Using CDC Funding for STLT Monkeypox Response

CDC understands that jurisdictional health departments may have questions about resources or existing funds that could be used to support monkeypox response activities. To assist health departments in their planning, CDC has compiled the following short list of cooperative agreements or grants that may be options to support monkeypox activities. However, recipients should contact the appropriate project officers to discuss these options, given the jurisdiction's specific identified needs, and seek CDC approval for the use of the existing funds and any change in planned budgets or actions.

- PHEP Cooperative Agreement
- Strengthening STD Prevention and Control for Health Departments Cooperative Agreement
- [Epidemiology and Laboratory Capacity Building for the Prevention of Emerging Infectious Disease \(ELC\) Cooperative Agreement](#)
- Community Health Workers (CHWs) for COVID Response and Resilient Communities (CCR)

PHEP recipients must coordinate with their PHEP project officers prior to redirecting their PHEP funds to support monkeypox response activities. Additional details related to use of PHEP funds for monkeypox response activities can be found in the May 27, 2022, issue of the DSLR Friday Update.

## New and Updated Monkeypox Resources Available Online

CDC has provided several new and updated resources regarding the 2022 monkeypox outbreak.

- On June 23, CDC Director Dr. Rochelle Walensky sent a [Dear Colleague Letter](#) for clinicians, providing critical information regarding the monkeypox outbreak. Recipients are encouraged to share the letter with clinicians in their jurisdictions.
- CDC updated the [Clinician FAQs | Monkeypox](#) to include updated information on pre-exposure prophylaxis (PrEP).
- CDC updated the [Diagnostic Process for Monkeypox Virus Testing](#) flowchart to:
  - clarify that concurrent diagnostic testing can occur while *Orthopoxvirus* (OPXV) testing is completed;
  - emphasize that public health laboratories do **not** have to seek CDC approval for OPXV testing; and to
  - include after-hours health department contacts so that clinicians can more easily connect when OPXV consultations are needed.

## WHO Releases Report on June 23 Meeting on Monkeypox Outbreak

The World Health Organization (WHO) has made available a report on the June 23 meeting of the International Health Regulations (2005) (IHR) Emergency Committee regarding the monkeypox outbreak in several countries. ## HHS Provides New Pediatric COVID-19 Vaccination Toolkit

The U.S. Department of Health and Human Services' (HHS) public education campaign, [We Can Do This](#), recently launched the [Pediatricians and Family Physicians Toolkit](#) to help physicians increase confidence in and uptake of COVID-19 vaccines among their patients and in the communities they serve. Developed in partnership with the American Academy of Pediatrics, the toolkit includes information from CDC and new, culturally tailored materials. Toolkit contents include a sample letter to parents, pediatrician talking points, and posters and flyers for offices and waiting rooms, as well as social media posts and sample text messages.

In addition to the new toolkit, HHS has released a new public service announcement in [English](#) and [Spanish](#) on the new vaccine authorization for children 6 months and older. Also available is a [one-pager](#) that describes some of the most effective messages when communicating with parents about the importance of the COVID-19 vaccine. ## Updated COVID-19 Resources Available Online

Following are updated resources on the shelf-life extension of specific COVID-19 therapeutics.

- On June 28, the Assistant Secretary for Preparedness and Response (ASPR) and the Food and Drug Administration (FDA) announced the authorization of a shelf-life extension—from 18 months to 24 months—for specific lots of the refrigerated AstraZeneca monoclonal antibody, Evusheld (tixagevimab co-packaged with cilgavimab). Evusheld is currently authorized for emergency use for pre-exposure prophylaxis of COVID-19 in certain adults and pediatric individuals. - On June 27, the FDA authorized a shelf-life extension—from 24 months to 30 months—for specific lots of the refrigerated Regeneron monoclonal antibodies, casirivimab and imdevimab, administered together or REGEN-COV. Speakers also discussed why robust and sustainable federal funding is necessary to continuously protect the health of Americans.

### **FEMA Seeks Feedback on National Continuous Improvement Guidance**

The Federal Emergency Management Agency (FEMA) seeks input on the draft "National Continuous Improvement Guidance," including edits and suggestions for additional resources and real-world examples that can be incorporated into the guidance. The guidance provides a consistent and rigorous framework to conduct continuous improvement initiatives before, during, and after real-world incidents for the whole community, including state, local, tribal and territorial partners, nongovernmental organizations, private sector, and emergency management organizations. The input period **closes at 11:59 p.m. EDT on July 31**.
