A new funding opportunity announcement (FOA) issued by the Centers for Disease Control and Prevention (CDC) this week invests over \$60 million from the Secretary's Minority AIDS Initiative Fund (SMAIF) in a four-year demonstration project designed to improve HIV outcomes for gay, bisexual and other men who have sex with men (MSM) of color. Up to eight health departments in jurisdictions with a high burden of HIV among Black and/or Latino MSM will receive funding to establish collaboratives with community-based organizations, clinics and other health care providers, and behavioral health and social services providers to deliver comprehensive HIV prevention and care services for MSM of color.

To improve the performance of the HIV prevention workforce by increasing the knowledge, skills, technology, and infrastructure necessary to implement and sustain science-based, culturally appropriate HIV prevention interventions and strategies.

### Purpose

To strengthen the capacity of PS15-1509 funded health departments and their collaborative partners to plan, implement, and sustain comprehensive prevention, care, behavioral health, and social services models for MSM of color at risk for and living with HIV infection.

- Increased availability and accessibility of competency-based training and technical assistance for the delivery of comprehensive HIV prevention, care, behavioral health, and social services for MSM of color;

# Strategy #1

During Year 1, develop a competency-based training program to build capacity within PS15-1509 funded health departments and their partner organizations in the collaborative to provide HIV prevention, care, behavioral health and social services for MSM of color at risk for and living with HIV infection.

- For <u>training staff</u> within PS15-1509 funded health departments and others

### Strategy 1 Activities (slide 1 of 2)

1.A: Assess target audience needs to inform appropriateness of and any necessary modifications to existing curricula to be used in developing the TOP curriculum

1.B: Develop competency-based TOP curriculum and performance support tools for PS 15-1509 funded health departments and their partners to deliver HIV services to MSM of color at risk for and living with HIV infection.

# Strategy 1 Activities (slide 2 of 2) 1.C: Develop a competency-based TOT curriculum for 15-1509 funded health department trainers and other staff

1.D: Develop a plan to deliver the TOP and TOT curricula to PS15-1509 funded health departments and others

# Strategy #2

Years 2 and 3, provide competency-based training and technical assistance to health department trainers and staff to deliver the TOP curriculum to provider staff (e.g., CBOs, clinics, others) participating in local collaborative as described in PS15-1509.

### **Strategy 2 Activities**

2.A: Deliver the TOP and TOT curricula to PS15-1509 funded health departments and others

2.B: Provide intensive and tailored technical assistance to PS15-1509 funded health departments and their local organizational partners as needed

## **Training Program Model**



### **Delivery Mechanisms slide 1 of 3**

#### Information Dissemination:

- Collection, packaging, and distribution of information
- Current state-of-the-science information and best practices related to the core competency categories
- Develop or use existing printed materials, didactic presentations, panel discussions, demonstrations, conference calls, listservs, websites, mass media, etc.
- Information should be accessible to both speakers of English and Spanish.

## **Delivery Mechanisms (Slide 2 of 3)**

### **Training:**

- Defined as a complete set of learning experiences, including classroom, experiential and self-guided, that taken altogether lead to the achievement of the desired set of competencies.
- Further develop and/or implement <u>existing</u> training curricula
- To further develop existing training curricula, applicants should utilize an instructional design process which includes (1) planning, (2) analysis, (3) design, (4) development), (5) implementation, and (6) evaluation

## **Delivery Mechanisms (Slide 3 of 3)**

#### Technical assistance (TA):

- Provision or facilitation of expert programmatic, scientific, or technical consultation or services related to the core competency categories
- TA should allow for mentoring or advisory relationships
- Guidance, materials, tools, etc. are negotiated and tailored to meet the specific needs of the requesting PS15-1509 funded health department jurisdiction.
  - E.g., site-specific technical consultation or tailored materials to address delivery of culturally competent prevention and care services for specific subpopulations of MSM of color.

Years 1-3, conduct monitoring and evaluation of training and technical assistance provided to PS15-1509 funded health departments and their local organizational partners

## **Strategy 3 Activities**

3.A: Develop a monitoring and evaluation plan to assess process and outcome of training and technical assistance provided to PS15-1509 funded health departments and their local organizational partners (Year 1)

3.B: Implement monitoring and evaluation activities for ongoing PS15-1509 program improvement and to address additional capacity building needs of PS15-1509 funded health departments and their local organizational partners

### **Funding Restrictions**

- May not use funds for research
- May not use funds for clinical care
- May only expend fund for reasonable program purposes
- Generally, may not use funds for the purchase of furniture or equipment
- Reimbursement of pre-award costs is not allowed
- May not use funds for any kind of impermissible lobbying activity
- Direct and primary recipient in a cooperative agreement program must perform a <u>substantial</u> role in carrying out project outcomes
