Anticipated award levels to support an integrated HIV surveillance and prevention program are based on the proportionate share of each eligible jurisdiction to the number of people living with diagnosed HIV infection in 2014. Prevalence was determined based on most recent known address as of year-end 2014. Awards to eligible jurisdictions were calculated for both surveillance and prevention by multiplying their prevalence proportion by the total amount available to support Component A: Core Program activities. CDC adjusted the allocation to ensure an established floor of \$1,000,000 to each jurisdiction.

New award levels will be implemented in the first year of award funding, and remain over the course of five years (FY 2018 – FY 2022). Anticipated funding ranges (i.e., total, surveillance and prevention) are listed by each eligible jurisdiction in the tables below. All amounts presented in the table are estimates based on current resources and are subject to change depending on the annual availability of funds.
