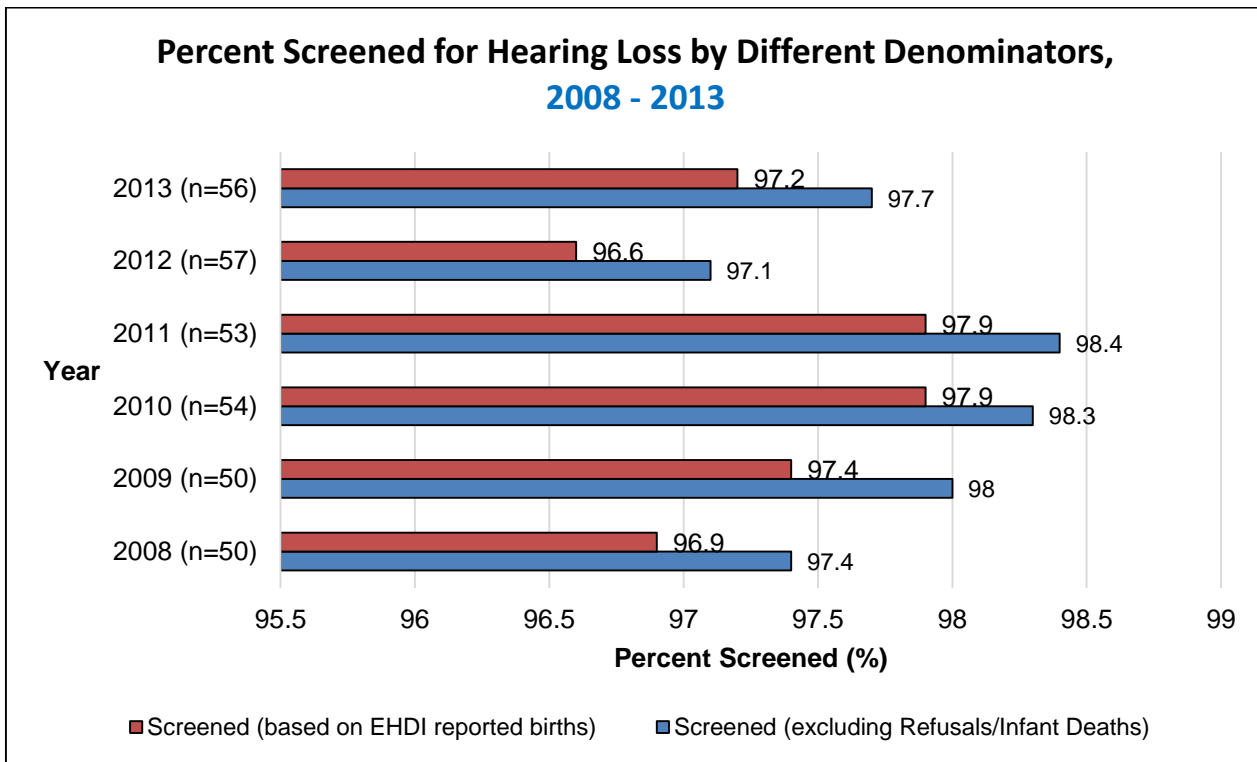

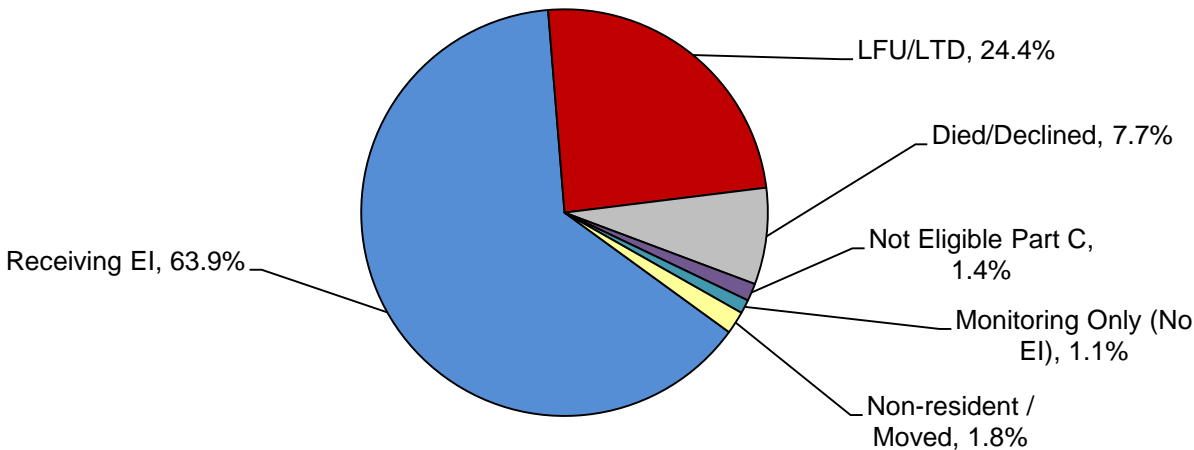

## Summary of 2013 National CDC EHD Data

### Data Notes

- HSFS data reflects information that states and territories have reportedly **documented** without estimation. As a result, data reported by CDC EHD Data may differ from other sources.
- Some respondents only provided partial data (e.g. hearing screening data only). As a result the number of reporting states and territories and denominators varies for some of the data sections.
- This data is subject to change if additional states and/or territories report data for year 2013.
- **In Process:** Respondents were advised that to be reported in this category each infant must have been seen for diagnostic testing at least one time and have a follow-up appointment already scheduled.
- **LFU (Loss to Follow-up) / LTD (Loss to Documentation):** Sub group of “No Documented Diagnosis / Undetermined” and “No Intervention Services.” Includes instances where infant’s families were *Unable to be contacted or Unresponsive*, and *Unknown cases*.

### Explanation of 2013 Calculations

#### Documented Hearing Screening (based on data from 56 States & Territories)

##### Percent Screened

$3,805,631$  (# screened) /  $3,915,861$  (occurrent births reported by EHD programs) x 100 = 97.2%

##### Percent Screened (excluding infant deaths & parental refusals)

$3,805,631$  (# screened) /  $3,894,020$  (occurrent births excluding infant deaths & parental refusals) x 100 = 97.7%

##### Percent Screened Before 1 Month of Age

$3,490,133$  (# Pass and # Not Pass before 1 Month of Age) /  $3,805,631$  (# Pass + # Not Pass) x 100 = 91.7%

##### Percent Not Passing final / most recent hearing screening

$61,653$  (# not pass) /  $3,805,631$  (# screened) x 100 = 1.6%

##### Percent Not Passing Inpatient (IP) Screen and Not Receiving an Outpatient (OP) Screen

$9,040$  (# not passing IP screen and not receiving an OP screen) /  $61,653$  (# not pass) x 100 = 14.7%

#### Documented Diagnosis (based on 53,572 infants not passing / data from 53 States & Territories)

##### Percent Diagnosed

$26,447$  (# w. no hearing loss) +  $5,246$  (# with diagnosed permanent hearing loss) /  $53,572$  (# not pass) x 100 = 59.2%

##### Percent with No Hearing Loss (i.e., no diagnosed hearing loss)

$26,447$  (# w. no hearing loss) /  $53,572$  (# not pass) x 100 = 49.4%

##### Percent Hearing Loss

$5,246$  (# with diagnosed permanent hearing loss) /  $53,572$  (# not pass) x 100 = 9.8%

##### Percent Diagnosed before 3 Months of Age

$21,904$  (# diagnosed with no hearing loss + # with permanent hearing loss before 3 Months) /  $31,693$  (# diagnosed with no hearing loss + # with permanent hearing loss) x 100 = 69.1%

#### Prevalence of Hearing Loss

$5,246$  (# with diagnosed permanent hearing loss) /  $3,454,678$  (# screened) x 1,000 = 1.5 per 1,000 screened

#### No Documented Diagnosis (based on 53,572 infants not passing / data from 53 States & Territories)

##### Percent with No Documented Diagnosis (of those Not Passing)

$21,879$  (# with no documented diagnosis) /  $53,572$  (# not pass) x 100 = 40.8%

$993$  (# in process) /  $53,572$  (# not pass) x 100 = 1.9%

2,397 (# receiving Part C EI before 6 months + # receiving Non-Part C EI before 6 Months) / 3,486 (# receiving Part C EI + # receiving Non-Part C EI) x 100 = 68.8%

### **No Documented Enrollment in EI** (*based on 5,459 infants w. hearing loss / 54 States & Territories*)

#### Percent Receiving No EI Services (*of those with hearing loss*)

1,915 (# not receiving any EI services) / 5,459 (# w. permanent hearing loss) x 100 = 35.1%

#### Percent Infant Died / Parents Declined (*of those with hearing loss*)

421 (# infant died / parents declined services) / 5,459 (# w. permanent hearing loss) x 100 = 7.7%

#### Percent Non-Resident / Moved (*of those with hearing loss*)

99 (# non-resident or moved out of jurisdiction) / 5,459 (# w. permanent hearing loss) x 100 = 1.8%

#### Percent Not Eligible for Part C Intervention
