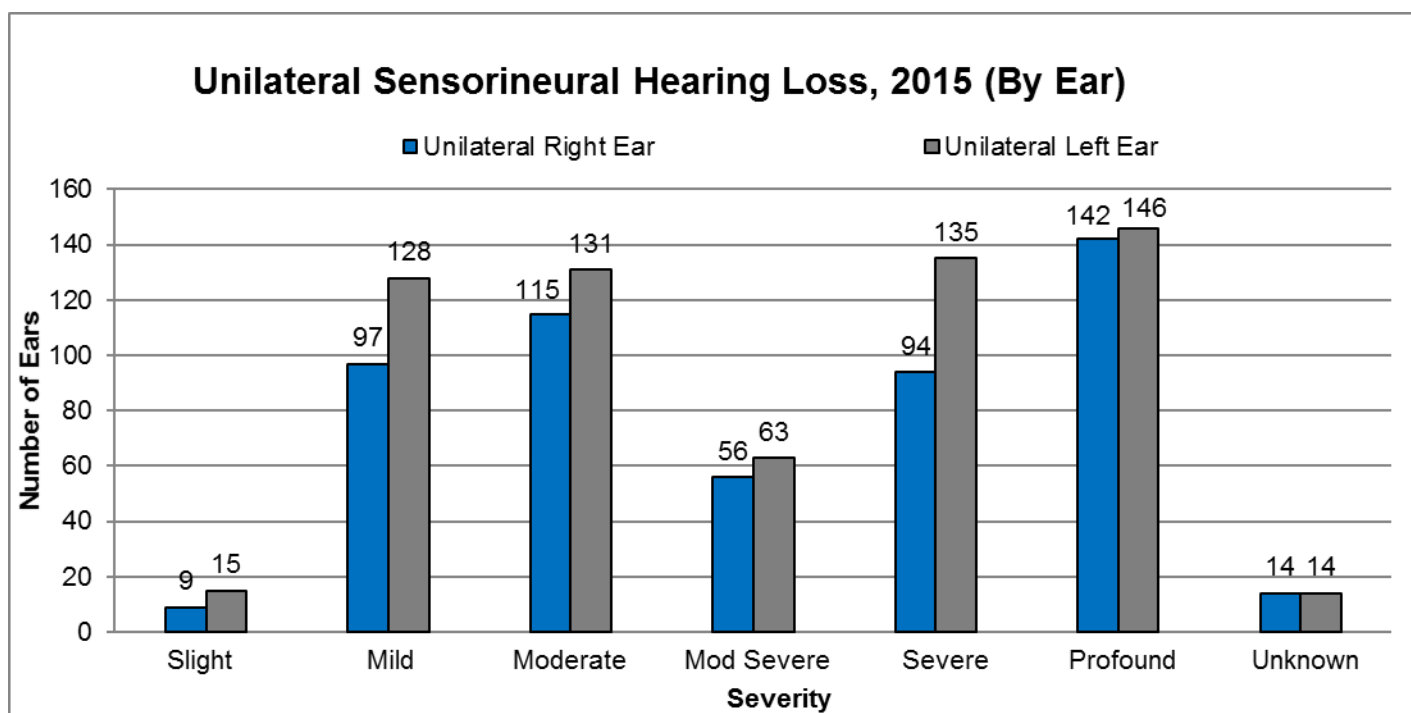

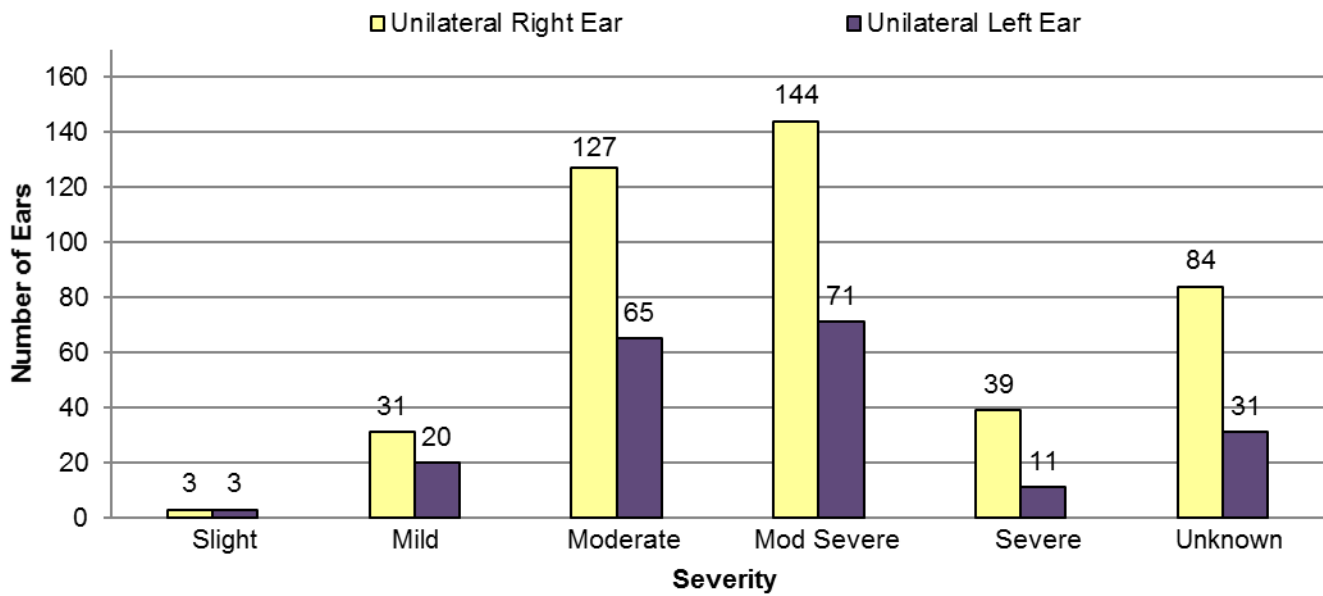

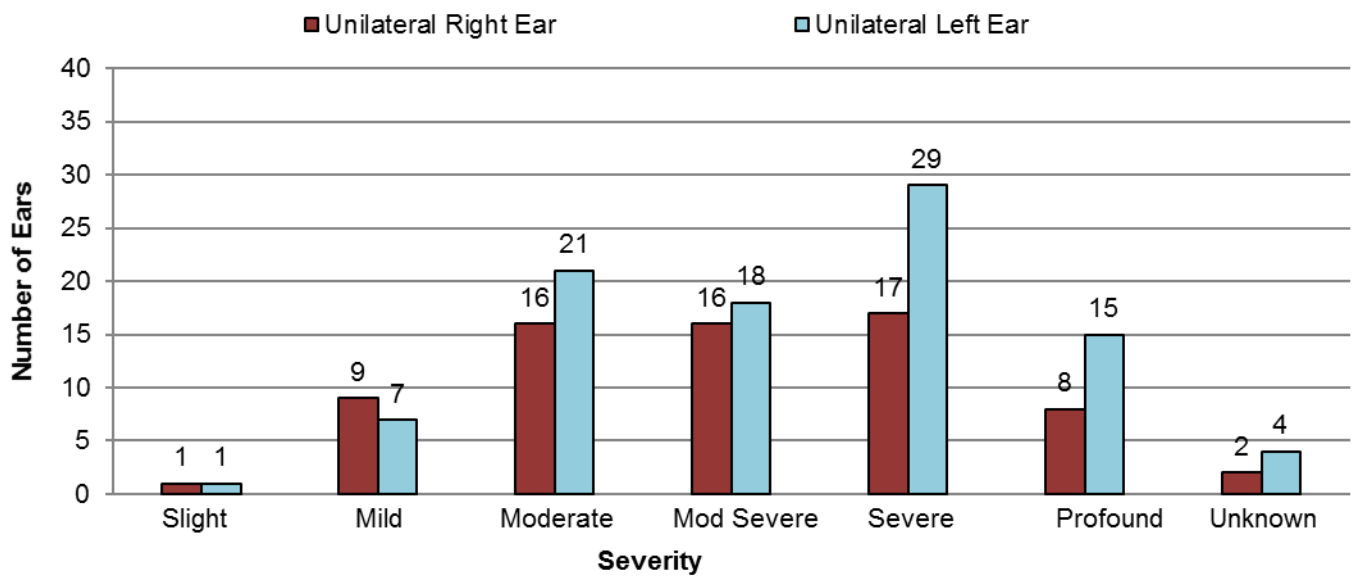

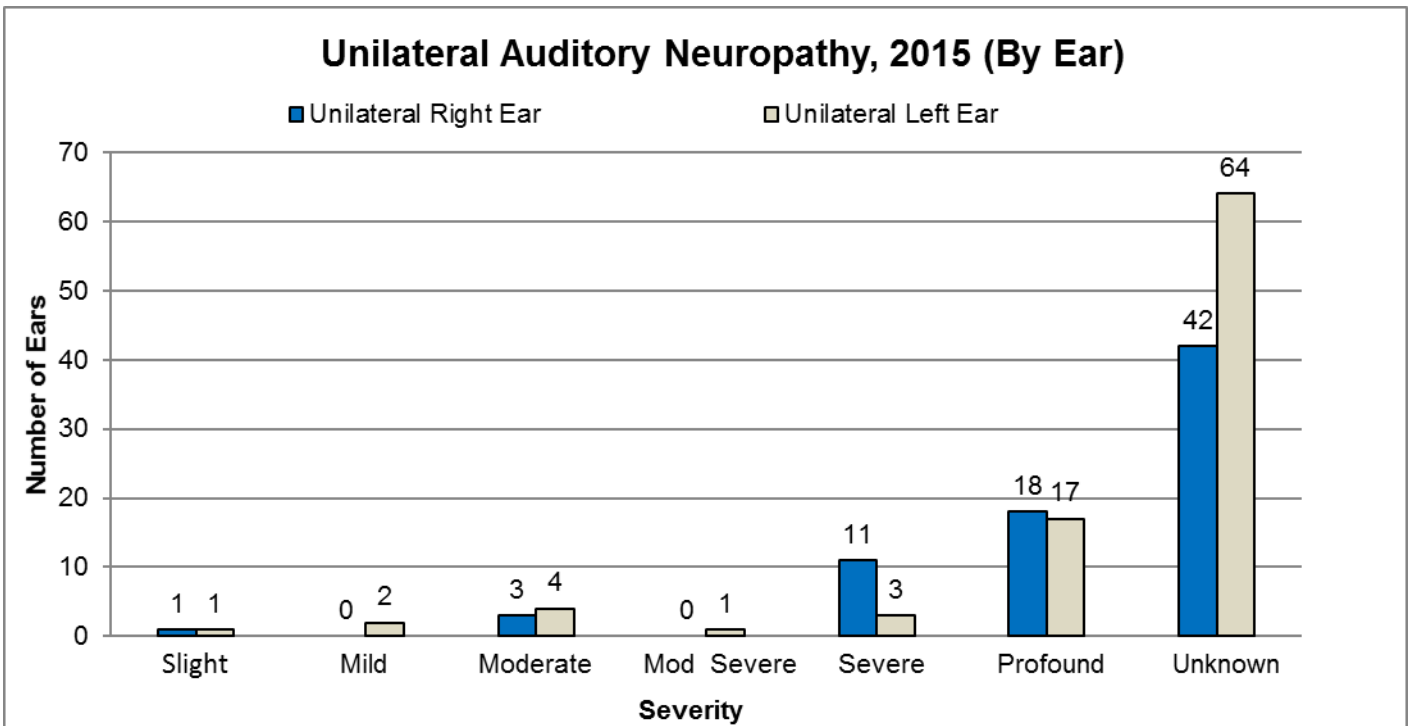
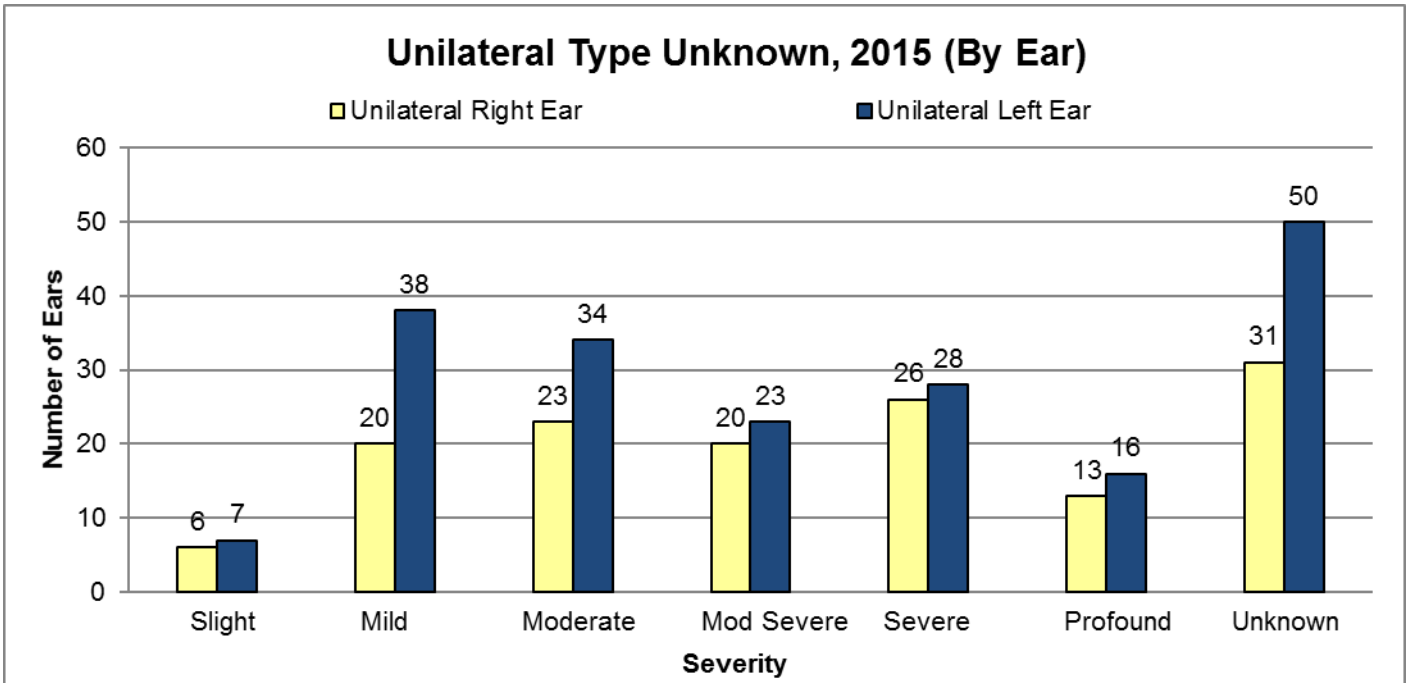
Unilateral Conductive Hearing Loss, 2015 (By Ear)



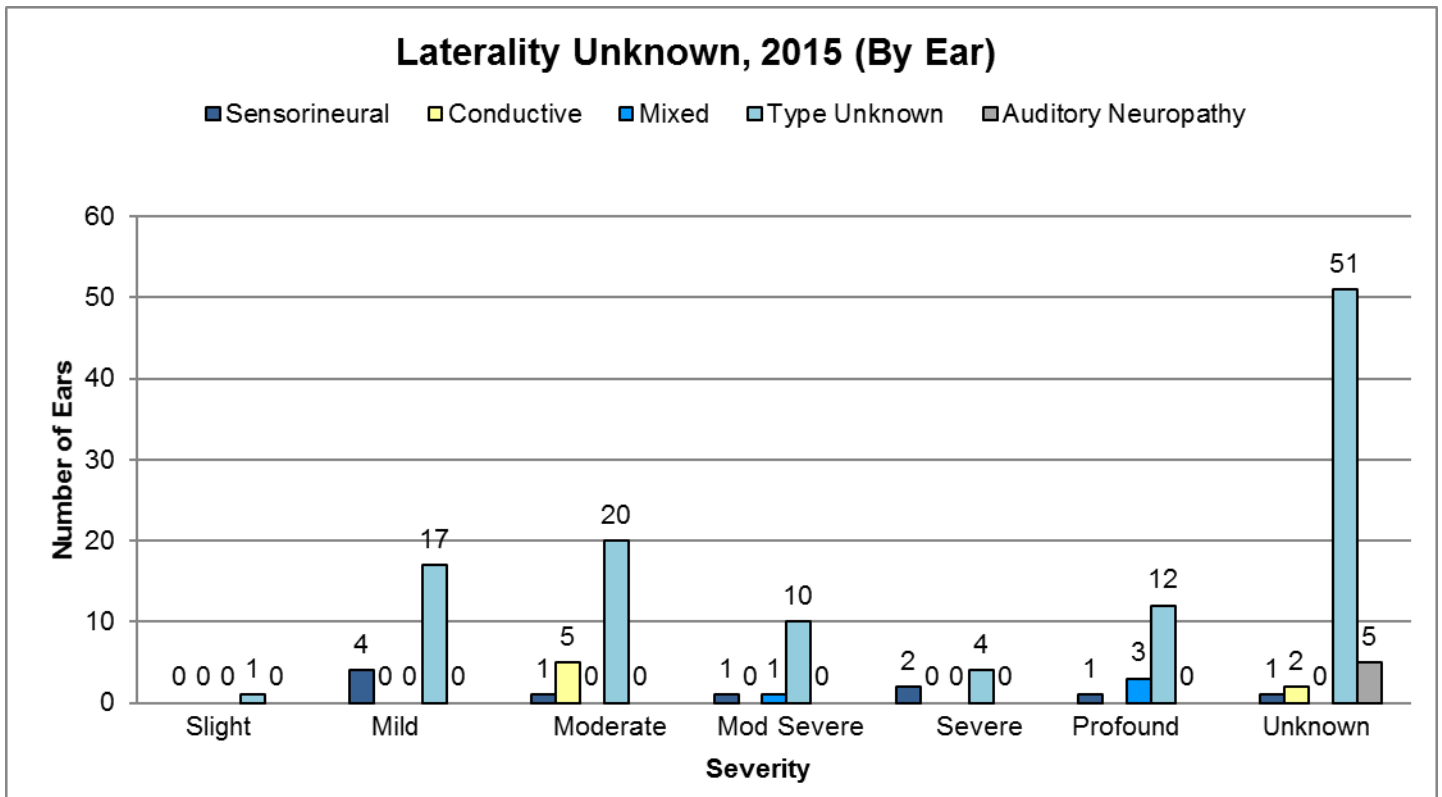
Unilateral Mixed Hearing Loss, 2015 (By Ear)
