# Nebraska - State Nutrition, Physical Activity, and Obesity Profile

Many American communities lack environments that could support healthy diets and regular physical activity. Healthy dietary and physical activity practices can lower the risk for heart disease, type 2 diabetes, and some cancers.<sup>1,2</sup>

In addition, excess calorie intake and physical inactivity contribute to obesity, which is associated with some of the leading preventable chronic diseases, including heart disease, stroke, type 2 diabetes, and some cancers. Among adults, the medical costs associated with obesity are an estimated \$147 billion.<sup>1,2,3</sup>

Public health approaches can help make healthy options available, accessible, and affordable. The Centers for Disease Control and Prevention's Division of Nutrition, Physical Activity, and Obesity (DNPAO) supports the nation to establish sustainable programs to improve dietary quality, increase physical activity, and reduce obesity and overweight. DNPAO funds and works with state health departments through a cooperative agreement ([State Public Health Actions to Prevent and Control Diabetes, Heart Disease, Obesity and Associated Risk Factors and Promote School Health program](#)).

## Population Statistics

Estimated Population of Nebraska: 1,896,190<sup>4</sup>

### Adult Statistics

#### Dietary Behaviors<sup>5</sup>

- 39.7% of adults reported consuming fruit less than one time daily.
- 23.3% of adults reported consuming vegetables less than one time daily.

#### Physical Activity<sup>5</sup>

- 50.1% of adults achieved the equivalent of at least 150 minutes of moderate intensity physical activity per week.

#### Overweight and Obesity<sup>5</sup>

- 36.5% of adults were overweight.
- 30.2% of adults had obesity.

### Adolescent Statistics

#### Dietary Behaviors<sup>5</sup>

- 37.8% of adolescents reported consuming fruit less than one time daily.

- 38.6% of adolescents reported consuming vegetables less than one time daily.

#### Physical Activity<sup>5</sup>

- 32.3% of adolescents were physically active at least 60 minutes per day on all 7 days in the past week.

#### Overweight and Obesity<sup>5</sup>

- 13.8% of adolescents were overweight.
- 12.7% of adolescents had obesity.

### Child Statistics

#### Breastfeeding<sup>5</sup>

- 83.5% of infants were ever breastfed.
- 60.0% of infants were breastfed for at least 6 months.

#### Overweight and Obesity<sup>5</sup>

- 18.0% of children aged 2 to 4 years in the Special Supplemental Nutrition Program for Women, Infants, and Children (WIC) program were overweight.
- 17.2% of children aged 2 to 4 years in WIC had obesity.

## State Activities

Nebraska worked on the following select activities during the first 2 years of the State Public Health Actions program.

- Implemented the Snack and Go intervention, a project that helps customers identify healthier snack options in retail food stores. As of March 2015, the program has been pilot-tested in eight locations throughout the cities of Lincoln, Omaha, Springfield, and Louisville.
- Implemented the Community Breastfeeding Initiative Project in at least two communities outside of Lincoln and Omaha. The project provides training to area birthing hospitals on maternity care practices that align with Baby-Friendly's® Ten Steps to Successful Breastfeeding and the Joint Commission Perinatal core measure set.
