



- Systematic process to plan, implement and evaluate health communication programs







### CDCynergy: Basic Edition

#### Basic model

- Input from 65+ professionals across PH disciplines
- Builds on standard public health model context
- A protocol familiar to both PH scientists and health educators/communicators
- Incorporates practices, models, frameworks, and theories at steps in process and in the resources
- Endorsed by SOPHE is the core health communication training










### CDCynergy Environmental Health Edition

#### Tailoring the product to support site work

- First release: will focus on supporting Superfund sitework
- Second release: opportunity to expand beyond site-work to other environmental health promotion activities





### Environmental Health Site Work

#### Intended Users

- Environmental health professionals tasked with designing, developing, and evaluating health communication education actions/ interventions for site work
  - 1043 partners (primary)
  - Other state and federal environmental and health agencies
  - National Organizations
  - ATSDR DHAC, DHEP, DHS, DT, DRO



### Supporting Site Work

- Fit with health assessment, exposure investigation, consultations, & health study processes
- Risk communication principles to be emphasized
- Community engagement/participation steps & principles worked into most Phases
- Bottom Line: not your CDC information campaign model (big budget, lots of time).






#### **Overview of Framework - Revisited**


### User Scenario: Quick Response

 Needs to put together quick community info & input materials

Sandy works in an environmental health department. Because of local news coverage of EPA monitoring activities for wells near a waste site, she needs to schedule a public meeting. She wants info on the contaminant of concern to create some talking points, and to have on hand guides for collecting community concerns.






### User Scenario: End-to-End Planning & Delivery

 Needs to put together a draft communication/ education plan to guide actions

Erica was recently assigned to a large state health department in which there is a "hot site" with multiple contaminants for which there are years-long health assessments underway. The community is very active and concerned. It appears that it will be determined that there is a public health hazard. She needs to organize this project so that she can work with state and federal partners to address the community's concerns, to work with the media, and to provide effective health education activities over time to both public and professional audiences.
