
Invoicing for 2024 VSCP and NDI Data

Notable Publications/Data Briefs

Trends in Births and Deaths in the United States: 2010-2023



This report was published in August and can be found at this link: National Vital Statistics Reports Volume 74, Number 11 August 27, 2025 Trends in Births and Deaths: United States, 2010–2023. According to the findings of the report, the number of births in the United States declined by 10% from 2010 through 2023. In contrast, the number of deaths generally increased from 2010 through 2023, by a total of 25%. The crude birth rate decreased 18% while the crude death rate increased by 15%. The birth-to-death ratio declined 28% overall from 2010 through 2023 and generally declined for the three largest race and Hispanic-origin groups. The differences in the ratios among the groups narrowed during this time period. The birth-to-death ratio declined for both urban and rural counties, with differences between ratios narrowing.

Vital Statistics Modernization Community of Practice



The Vital Statistics Modernization Community of Practice (NVSS COP) is a collaborative space for learning and innovation. It provides a setting for jurisdictions and their partners to collaborate in the modernization space.

The NVSS Modernization Community of Practice hosted the 3rd quarter NCHS-organized testing event of 2025 on September 8th-9th. The focus was on advancing jurisdictional capabilities to exchange mortality, fetal death, and natality data using FHIR. We are excited to report that 13 of 57 (or 22%) jurisdictions participated in the testing event, with twelve (12) jurisdictional Vital Records Offices and their respective technical partners as testers. These included Alabama, American Samoa, Arizona, Connecticut, Indiana, Louisiana, Missouri, New Hampshire, Pennsylvania, Rhode Island, Utah, and

Wyoming. Additionally, New York State participated as an observer. All participants' feedback was instrumental in the success of the event.

Key takeaways from the testing event include:

- The jurisdictions came prepared and were able to assist other jurisdictions even more effectively. Many jurisdictions successfully tested interjurisdictional exchange with one another.
- CTE, SAMS, and STEVE resources were readily available and on-call during the testing event, which helped resolve connectivity issues swiftly.
- Six jurisdictions (Alabama, Arizona, Indiana, Missouri, New Hampshire, Pennsylvania) successfully worked on pre-certification
- Arizona and Indiana successfully tested the EDRS-->STEVE-->NCHS mortality flow for the first time.
- Five jurisdictions (American Samoa, New Hampshire, Rhode Island, Utah, Wyoming) successfully tested data exchange with natality.
- American Samoa, New Hampshire, Rhode Island, and Wyoming tested fetal death data exchange.
- Some discrepancies were found with the natality and fetal death test cases and Canary testing tools, which will require minor fixes. We appreciate the jurisdictions who identified those and brought them to our attention so they can be addressed. Such feedback is valuable, especially for the less mature natality and fetal death workflows, as it helps us strengthen the systems, tools, and documentation.

Jurisdictions should remember that pre-certification and certification are essential steps in the NVSS FHIR Certification Pathway. The primary aim of the pre-certification process is to ensure that a jurisdiction is fully prepared for certification. A well-executed pre-certification effort should facilitate a smooth final certification process.

Jurisdictions are encouraged to sign up for FHIR validation by emailing the NVSS mailbox, contacting CTE

through the #deathonfhir stream on Zulip (chat.fhir.org), or selecting the self-service option available on GitHub. Please note that while FHIR validation is optional, it is highly recommended as a prerequisite for precertification. The primary goal of FHIR validation is to assess the jurisdiction's ability to analyze the structure of FHIR messaging and generate FHIR records in accordance with the Vital Records Death Reporting Implementer Guidance standard.

NVSS encourages jurisdictions to utilize our peer-to-peer connection to share announcements that may benefit the community of practice, such as job vacancies and upcoming conferences.
