## Notable Publications/Data Briefs

### **Births: Provisional Data for 2021**

This report was released May 24<sup>th</sup> and can be found at this [link](#). It presents provisional 2021 data on U.S. births and shows the number of births rose 1% from 2020 for the first increase since 2014. The general fertility rate and the total fertility were also up 1% between 2020 and 2021. The cesarean delivery rate rose to 32.1% in 2021; the low-risk cesarean delivery rate also rose to 26.3%. The preterm birth rate rose 4% in 2021 to 10.48%, the highest rate reported since at least 2007. Other notable results can be found within the report.

### **Maternal and Infant Characteristics and Outcomes Among Women with Confirmed or Presumed COVID-19 During Pregnancy: 14 states and DC**

It describes characteristics and pregnancy outcomes among mothers with and without confirmed or presumed COVID-19 during pregnancy by maternal age, educational attainment, race and Hispanic origin, and source of payment for the delivery for a 14-state (Alabama, Alaska, Arkansas, California, Idaho, Maine, Maryland, New Hampshire, North Dakota, Ohio, Oklahoma, Oregon, Tennessee, and West Virginia) and DC reporting area between April 2020 and December 2021. ## Vital Statistics Modernization Community of Practice



[The Vital Statistics Modernization Community of Practice \(NVSS COP\)](#) is a shared space for learning and innovation and provides a forum for jurisdictions and their partners working in the modernization space to come together on topics of mutual interest.

### **Minnesota Launches API Gateway and FHIR**

Leveraging the advancements from its NVSS NCHS special project funded in the Fall of 2019 and building upon the successes of Georgia and Michigan, the Minnesota Department of Health, Office of Vital Records and Minnesota Information Technology Services welcomed interoperability with a medical examiner case management system (CMS) last month. *“We kept the momentum going beyond our 24-month task order project knowing that with a little more effort and time, we could implement HL7 FHIR,”* commented Molly Crawford, Minnesota State Registrar, about their partnership with

the Mayo-based Southern Minnesota Regional Medical Examiner’s Office and their CMS vendor. Southern’s Chief Medical Examiner and forensic pathologist, R. Ross Reichard, M.D., had this to say, *“The collaboration across organizations resulted in something greater than the individual parts and is a model for death certification.”* In April, the first Minnesota death record was certified with cause and manner of death completed by exchanging data via a new application programming interface. Under their ELC plan, Minnesota intends to expand interoperability with additional medical examiner and coroner offices to eventually bring all offices on board.

### **Invitation to Participate in NCHS Organized Quarterly Testing Events**

Jurisdictions are invited to participate in NCHS organized quarterly testing events that are intended to provide jurisdictions with an opportunity to refine their health systems strengthening efforts with FHIR based interoperability. These events are free of cost, less formal than traditional connectathon events, and focus on assisting jurisdictions with achieving the milestones highlighted in their ELC cooperative agreement project plan. Jurisdictions are encouraged to participate in more than one event in a year.

Participating in these events will be a productive way for jurisdictions and their technical partners to become familiar with the VRDR Implementation Guide (IG) and to get comfortable in using some of the tools in place to achieve interoperability using FHIR (libraries, testing framework, etc). Starting on May 24<sup>th</sup>, NCHS has begun organized preparation calls during optional weekly Office Hours calls in advance of the June organized testing event.

The testing opportunity will take place over two half-days (tentatively from 1pm to 5pm ET). Ensuring that jurisdictional technical staff are available to attend on both days will also be important to make sure jurisdictions get the most benefit. The dates are:

### **Invitation to participate in pilot testing with NCHS (internal systems)- Early July to late August 2022**

NCHS is seeking states to participate in pilot testing related to FHIR during July and August of 2022. Although the primary goal of the pilot is to test NCHS’ internal systems and perform data quality checks as we move to modernizing mortality data with FHIR, it will also be an

opportunity to help participating states move closer to their modernization goals. NCHS requests participation of a variety of states (those with “home-grown” and different vendor-based EDRS systems) that can pilot test with NCHS and its technical partner MITRE in systems refinement. Pilot testing will be a 5-phased testing and will include testing 1) the ability to send and receive clean mortality records, 2) handing of records with deficiencies, 3) handling changes to existing records, 4) volume testing, and 5) manual coding. Participating states do not need to commit to being among the first to certify with FHIR. In order to participate, states need to be able to send and receive mortality records via FHIR messages (consistent with the 1.3 version STU2 VRDR IG and associated tools).
