¹ Beneficiaries include those who were enrolled or received services through Medicaid or the Children's Health Insurance Program (CHIP). Separate CHIP beneficiaries are included for 2011 and subsequent years.

² Medicaid managed care enrollment data include individuals in state health care reform programs that expand eligibility beyond traditional Medicaid eligibility standards. The managed care enrollment data include enrollees receiving comprehensive and limited benefits. Managed care enrollment for 2000 is as of June 30 and the U.S. total includes data for the territories. Data for 2010 and 2011 are as of June 30. Data for 2012 are not available. Data for 2013 are as of July 1. Michigan's 2013 enrollment data are derived from two data sources and may not be consistent with earlier years. Managed care enrollment data may change year to year due to a variety of factors, including changes in waiver programs, outreach efforts, and data reporting practices.
