This table presents four measures of physical activity that are of interest to the public health community: the percentage of adults who met the federal 2008 guidelines for both aerobic activity and muscle strengthening; the percentage who met neither the aerobic -activity guidelines nor the muscle-strengthening guideline s; the percentage who met the aerobic-activity guidelines; and the percentage who met the muscle-strengthening guideline s. Persons who met neither the aerobic-activity nor the muscle-strengthening guideline s were unable to be active, were completely inactive, or had some aerobic or muscle-strengthening activities but amounts were insufficient to meet the guidelines. The percentage of persons who met the aerobic-activity guidelines includes those who may or may not have also met the muscle-strengthening guideline s. Similarly, the percentage of persons who met the muscle-strengthening guidelines includes those who may or may not have also met the aerobic-activity guidelines. The federal 2008 guidelines recommend that for substantial health benefits adults perform at least 150 minutes ( 2 hours and 30 minutes) a week of moderate-intensity, or 75 minutes ( 1 hour and 15 minutes) a week of vigorous-intensity aerobic physical activity, or an equivalent combination of moderate- and vigorous-intensity aerobic activity. Aerobic activity should be performed in episodes of at least 10 minutes, and preferably should be spread throughout the week.
