Persons were considered uninsured if they were not covered by private health insurance, Medicare, Medicaid, Medical Assistance, TRICARE or other military health care, veteran's coverage through the Veteran's Administration, or other government coverage. People with Indian Health Service coverage only are considered uninsured by ACS. See Appendix II, Health insurance coverage; Uninsured. Standard errors were computed with replicate weights using 80 balanced repeated replicate weights (BRR) with a Fay-modified BRR adjustment factor of 0.5.
