Starting with 2017 data, the American Hospital Association (AHA) changed its methodology to include all general and specialty hospitals licensed by the appropriate state agency and accredited by one of the following: The Joint Commission, DNV GL Healthcare, Center for Improvement in Healthcare Quality, or Medicare. AHA applied the new methodology to 2013–2016 data. Data are shown based on the prior (1) and new (2) methodology for 2015 for comparison. Data for 2015(2), 2017, and beyond are based on the new definition. Because of the change in methodology, data may not be comparable across the two time periods. See Appendix II, Hospital.
