

DAVID B. GRAY Dr. Gray has conducted research on the ICIDH, ICIDH-2, and ICF for six years. This research has resulted in three measures that relate to the A/P and E portions of the ICF which have been applied to community receptivity, mobility impaired individuals' participation in life activities pre and post interventions and environmental barriers and facilitator subjective reporting. He represented NIH from 1993 to 1995 during the early revision meetings, and worked extensively with Canadian ICF experts, including Patrick Fougere, Jerome Bickenbach, and Adele Furrie. He successfully hosted a NACC meeting in St. Louis in 1997, which included a number of Canadian ICF experts (NCHS Contract). This meeting was held on campus at Washington University, and the University provided excellent facilities in support of this conference. Dr. David Gray was the U.S. Field Trial Coordinator for the ICIDH-2 Beta-1 trials in 1997-1998 (NCHS Contract), and he is well known by every major ICF researcher in the U.S. and Canada. He represented the U.S. on the WHO Environmental Task Force that produced the framework for the ICF Environment codes, and is internationally recognized. He partners well and has authored and co-authored many scientific papers on disability classification. He is co-P.I. (with Trish Saleeby) on an NCHS/CDC contract to develop the ICF Clearinghouse.

PATRICIA WELCH SALEEBY Patricia Welch became Patricia Welch Saleeby on December 7, 2002, and everyone calls her "Trish". In a few months she will defend her dissertation, and we will then call her "Dr. Trish". Trish has been actively involved with the ICF since 1997. She served as the Research Assistant to Dr. David Gray, U.S. Field Trial Coordinator for the ICIDH-2 Beta-1 trials in 1997-1998. She assisted Dr. Gray in preparing a final report on U.S. Field Trial activities and presented part of this report at the WHO ICIDH-2 meeting in Tokyo, Japan in 1998. In the summer of 1998, she co-conducted a focus group examining the subjective aspects of ICIDH-2 at the Japan College of Social Work with Dr. Hisao Sato. She continued as a Research Assistant on the ICIDH-2 Beta-2 field-testing, and co-conducted a field test comparing the ICIDH-2 Beta-2 version to the Canadian Quebec model. Dr. Gray and Ms. Welch co-authored an article, "Comparing perspectives of people with disabilities and professionals on the ICIDH-2 Beta-1." She currently is working on another article examining the application of the ICF to social work. She has served as Rapporteur for the WHO ICIDH-2 meeting in London in 1999. She has attended and presented at the recent NACC meeting in Toronto on the application of the ICF to the social work field. She has presented and lectured on the ICF and its use at multiple conferences and at several universities. She is co-P.I. (with David Gray) to develop the ICF Clearinghouse.
