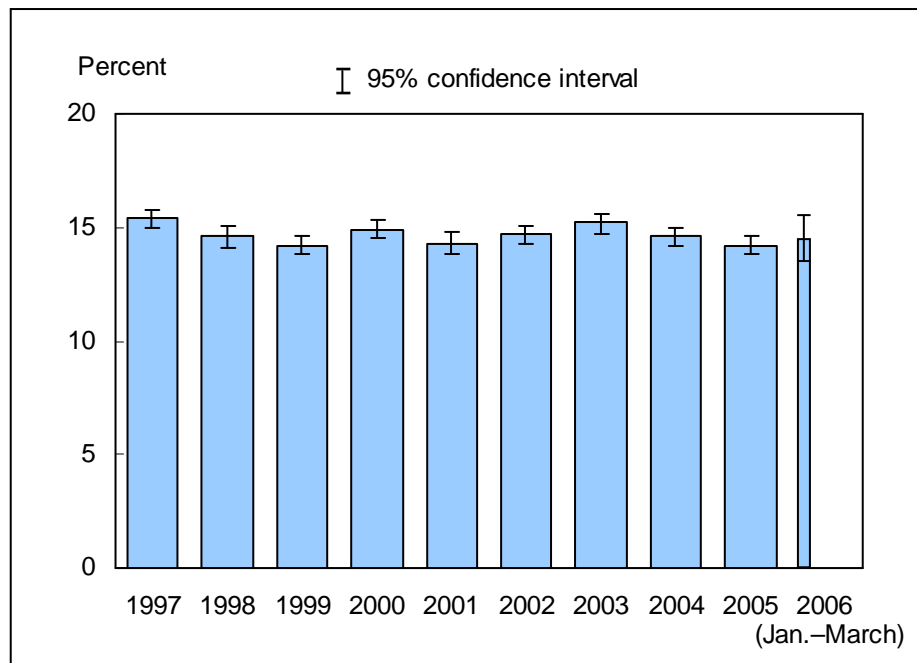


**Figure 1.1. Percentage of persons of all ages without health insurance coverage at the time of interview: United States, 1997–March 2006**

A person was also defined as uninsured if he or she had only Indian Health Service coverage or had only a private plan that paid for one type of service such as accidents or dental care. The analyses excluded persons with unknown health insurance status (about 1% of respondents each year). The data on health insurance status were edited using an automated system based on logic checks and keyword searches. For comparability, the estimates for all years were created using these same procedures. The resulting estimates of persons without health insurance coverage are generally 0.1–0.2 percentage points lower than those based on the editing procedures used for the final data files. Beginning with the 2003 data, the National Health Interview Survey (NHIS) transitioned to weights derived from the 2000 census. In this Early Release, estimates for 2000–2002 were recalculated using weights derived from the 2000 census. See “About This Release” and Table II in the Appendix for more details.

In quarter 3 of 2004, two additional questions were added to the NHIS insurance section to reduce potential errors in reporting Medicare and Medicaid status. Persons aged 65 years and over not reporting Medicare coverage were asked explicitly about Medicare coverage, and persons under 65 years of age with no reported coverage were asked explicitly about Medicaid coverage. Depending on responses to these two questions, respondents may have been reclassified. Estimates of uninsurance for 2004 are calculated both without using the additional information from these new questions (noted as Method 1 in the data table) and with using the responses to these new questions (presented in the figure above and noted as Method 2 in the data table). Beginning in 2005, all estimates are reported using Method 2. See “About This Release” for additional information.

DATA SOURCE: Family Core component of the 1997–2006 NHIS. The estimate for 2006 was based on data collected from January through March. Data are based on household interviews of a sample of the civilian noninstitutionalized population.

■ In early 2006, the percentage uninsured at the time of interview was 14.5% (95% confidence interval = 13.47–15.49%), which was not significantly different from the 2005 estimate of 14.2%.

■ The annual percentage uninsured at the time of interview was 15.4% in 1997, 14.6% in 1998, 14.2% in 1999, and 14.9% in 2000. The estimate increased from 14.3% in 2001 to 15.2% in 2003, and then decreased to 14.2% in 2005.

The number of uninsured persons was calculated as the percentage of uninsured persons multiplied by the total weighted population, including persons with unknown coverage. The age-specific numbers of uninsured may not add to their respective totals due to rounding. Age-adjusted estimates for persons under 65 years of age for this Healthy People 2010 Leading Health Indicator are adjusted using the projected 2000 U.S. population as the standard population using three age groups: under 18 years, 18–44 years, and 45–64 years. Beginning with the 2003 data, NHIS transitioned to weights derived from the 2000 census. In this Early Release, estimates for 2000–2002 were recalculated using weights derived from the 2000 census. - In early 2006, the percentage uninsured at the time of interview was 16.4% (42.1 million) for persons under age 65 years, 19.2% (35.3 million) for persons aged 18–64 years, and 9.3% (6.8 million) for children under age 18 years.
- For children under age 18 years, the annual percentage uninsured at the time of interview decreased from 13.9% in 1997 to 8.9% in 2005.
- For adults aged 18–64 years, the annual percentage uninsured at the time of interview decreased from 1997 to 1999, followed by an increase from 1999 to 2003, and another decrease from 2003 to 2005.

A small number of persons were covered by both public and private plans and were included in both categories. 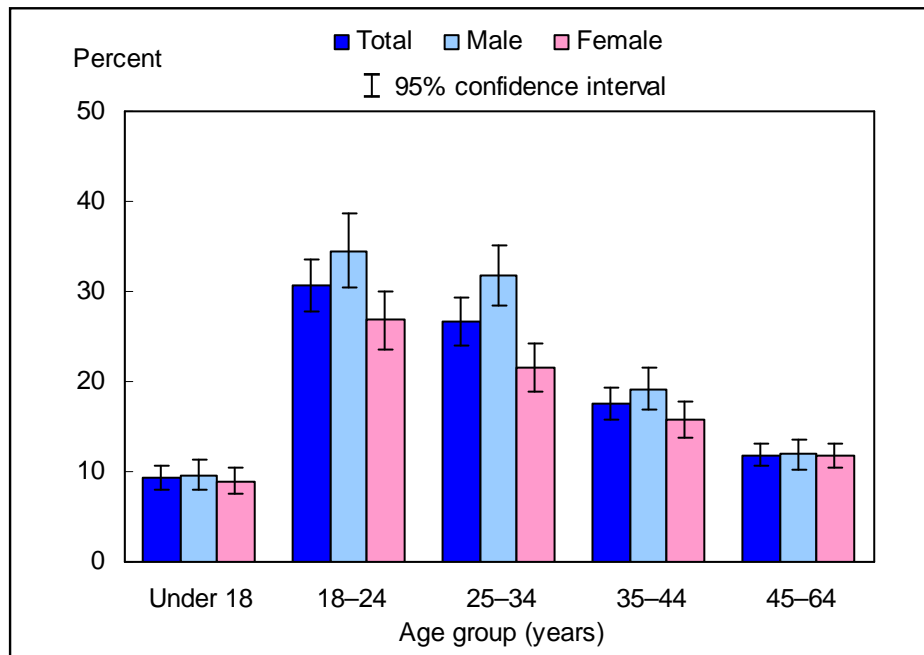

- In early 2006, 18.2% of persons under age 65 years were covered by public health plans, and 66.8% were covered by private health insurance plans.
- For persons aged 18–64 years, after a period of decrease from 1997 to 1999, there was an increasing trend in public coverage from 1999 to early 2006. There was an increase from 1997 to 1999, followed by a generally decreasing trend from 1999 to early 2006 in private coverage for this age group.
- For children under age 18 years, after a period of decrease from 1997 to 1999, there was an increasing trend in public coverage from 1999 to early 2006. An increase from 1997 to 1999 was followed by a decreasing trend from 1999 to early 2006 in private coverage for this age group.

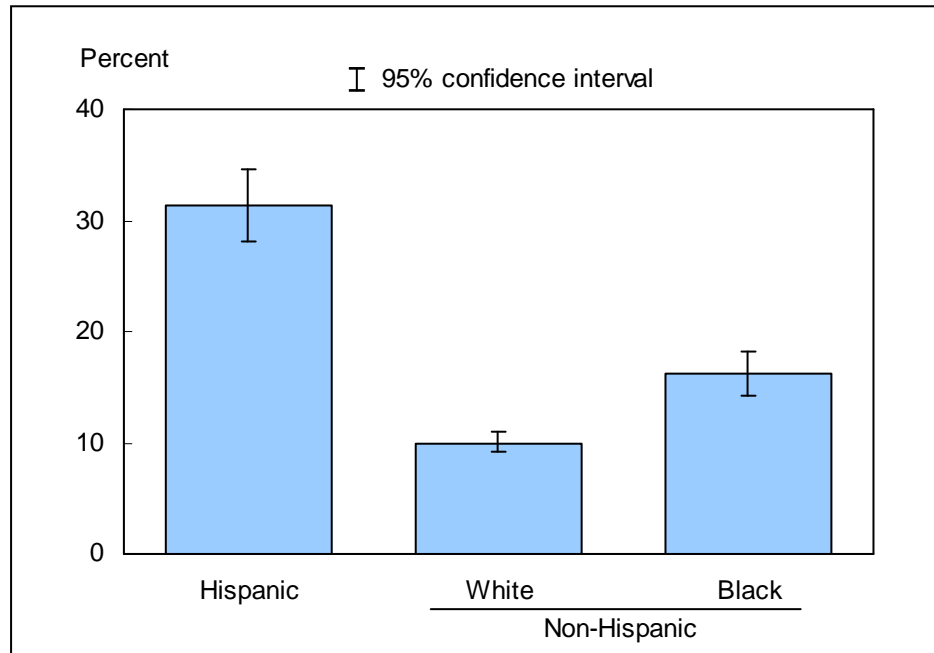

- For both sexes combined, the percentage uninsured at the time of interview was highest among persons aged 18–24 years (30.7%) and lowest among persons under age 18 years (9.3%) and aged 45–64 years (11.8%). Starting at age 18 years, younger adults were more likely than older adults to lack health insurance coverage.

- Among adults in the age groups 18–24 years, 25–34 years, and 35–44 years, men were more likely than women to lack health insurance coverage at the time of interview.

■ After adjusting for age and sex, the percentage uninsured at the time of interview was 31.4% for Hispanic persons, 10.1% for non-Hispanic white persons, and 16.2% for non-Hispanic black persons.

■ Hispanic persons were most likely to be uninsured at the time of interview, followed by non-Hispanic black persons and non-Hispanic white persons.

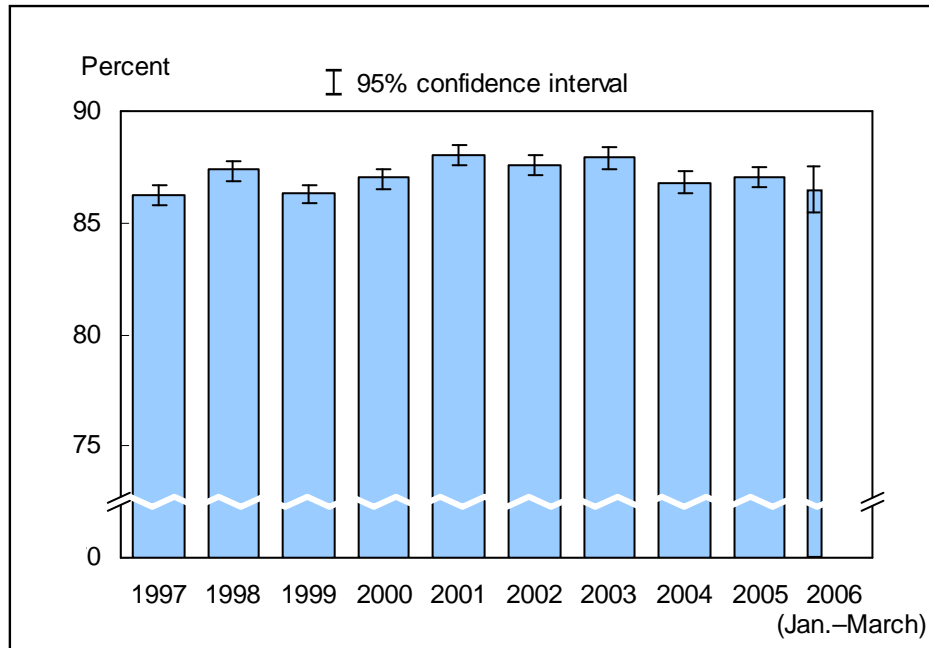

**Figure 2.1. Percentage of persons of all ages with a usual place to go for medical care: United States, 1997–March 2006**



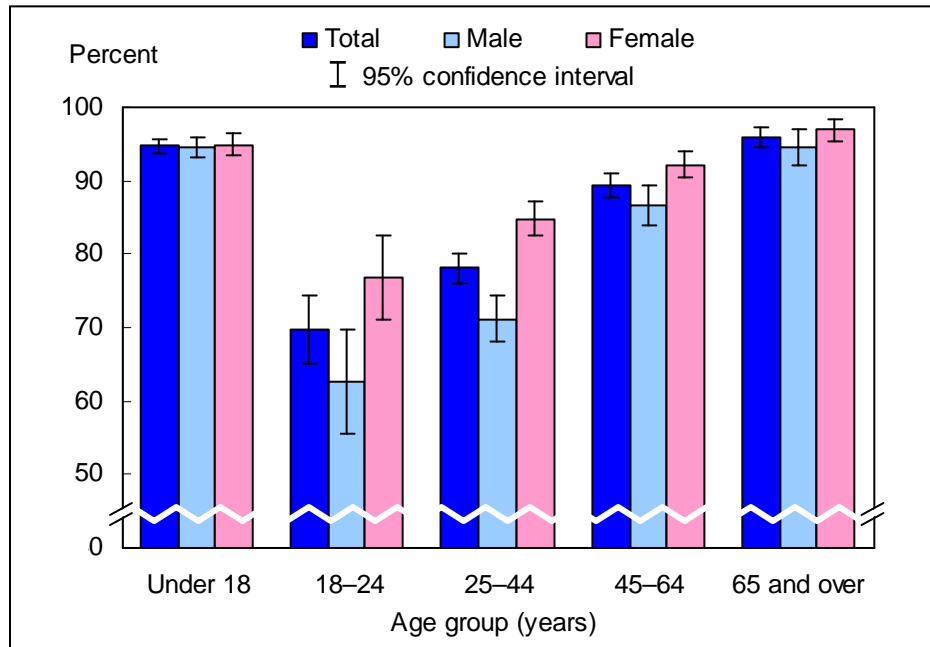

■ In early 2006, the percentage of persons who had a usual place to go for medical care was 86.5% (95% confidence interval = 85.46–87.45%), which was not significantly different from the 2005 estimate of 87.0%.

■ The annual percentage of persons of all ages who had a usual place to go for medical care was 86.2% in 1997, 87.4% in 1998, 86.3% in 1999, 87.0% in 2000, 88.0% in 2001, 87.6% in 2002, 87.9% in 2003, 86.8% in 2004, and 87.0 in 2005.

**Figure 2.2. Percentage of persons of all ages with a usual place to go for medical care, by age group and sex: United States, January–March 2006**

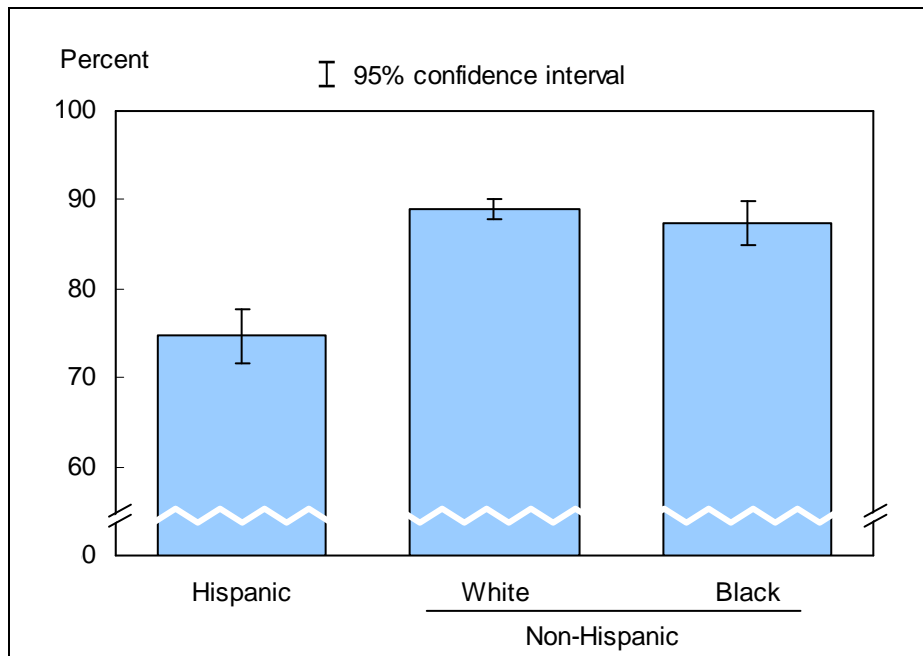

- Of the five age groups, persons aged 18–24 years were least likely to have a usual place to go for medical care. Children under age 18 years were more likely than adults aged 18–64 years to have a usual place to go for medical care.
- Among those aged 18 years and over, the percentage of persons having a usual place to go for medical care increased with age.
- For adults aged 18–64 years, men were less likely than women to have a usual place to go for medical care.

- After adjusting for age and sex, the percentage of persons with a usual place to go for medical care was 74.7% for Hispanic persons, 89.0% for non-Hispanic white persons, and 87.4% for non-Hispanic black persons.
- Of the three race/ethnicity groups, Hispanic persons were least likely to have a usual place to go for medical care.

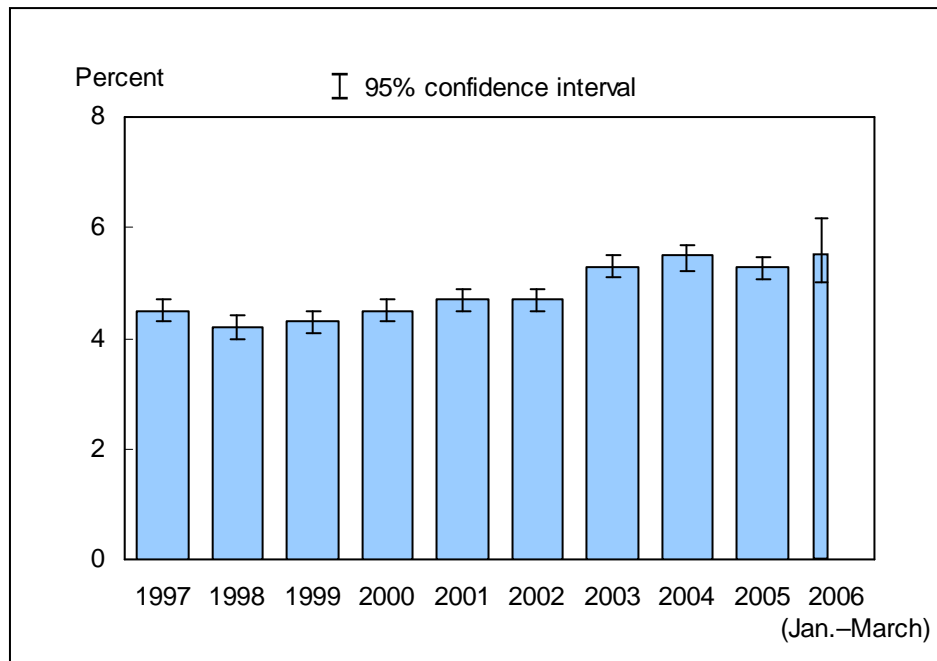

**Figure 3.1. Percentage of persons of all ages who failed to obtain needed medical care due to cost at some time during the past 12 months: United States, 1997–March 2006**



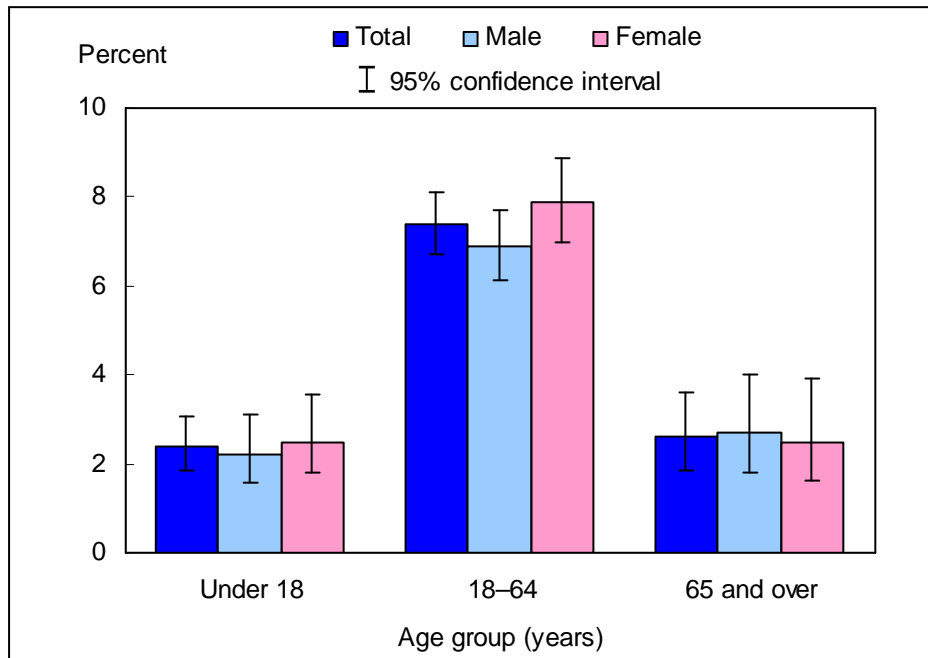

- In early 2006, 5.5% (95% confidence interval = 5.00–6.15%) of the population was unable to obtain needed medical care due to cost at some time during the past 12 months, which was not significantly different from the 2005 estimate of 5.3%.
- From 1998 to 2004, there was an increasing trend in the annual percentage of persons who experienced this lack of access to medical care (4.2% in 1998 to 5.5% in 2004).

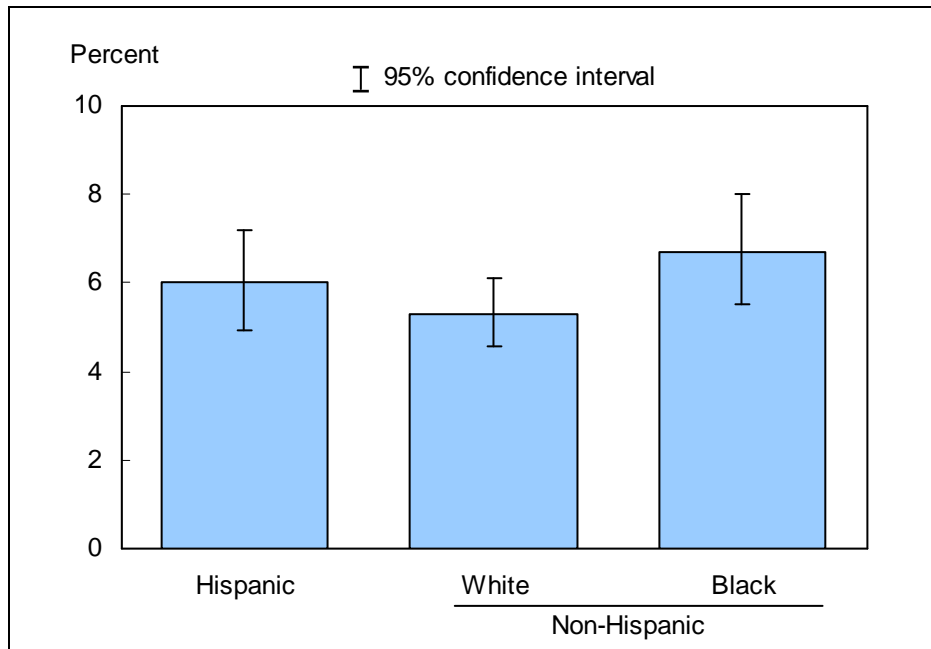

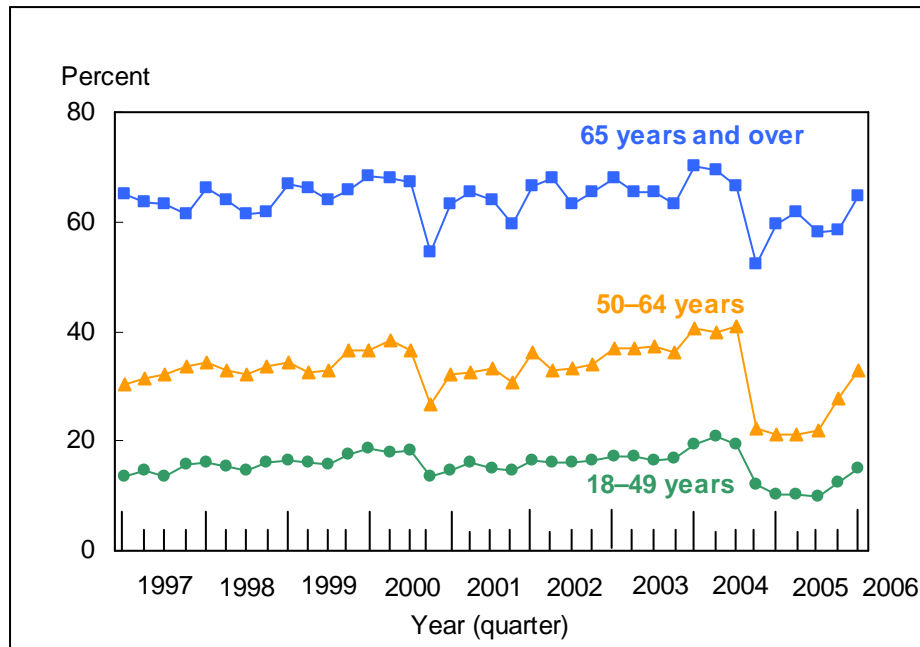

■ In the first quarter of 2006, the percentage of adults who had received an influenza vaccination during the past 12 months was 64.7% for persons aged 65 years and over, 33.0% for persons aged 50–64 years, and 15.0% for persons aged 18–49 years.

■ For all three age groups, first quarter estimates in 2006 were higher than first quarter estimates in 2005, but still lower than first quarter estimates in 2004. An influenza vaccination shortage occurred during the 2004–05 flu season (8). Previous delays in availability of the flu shots also occurred in the fall of 2000 and, to a lesser extent, in the fall of 2001 (9,10).

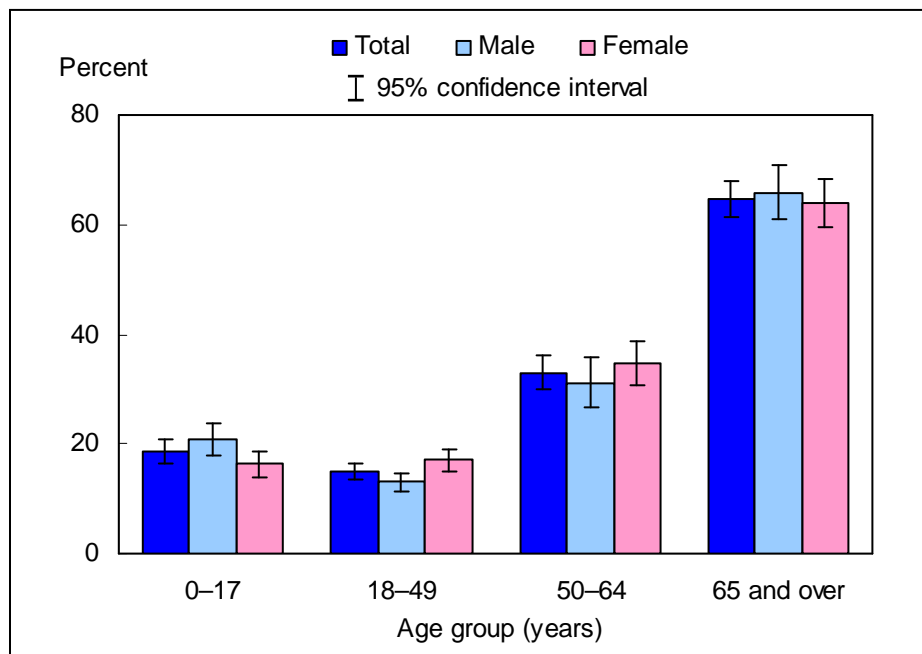

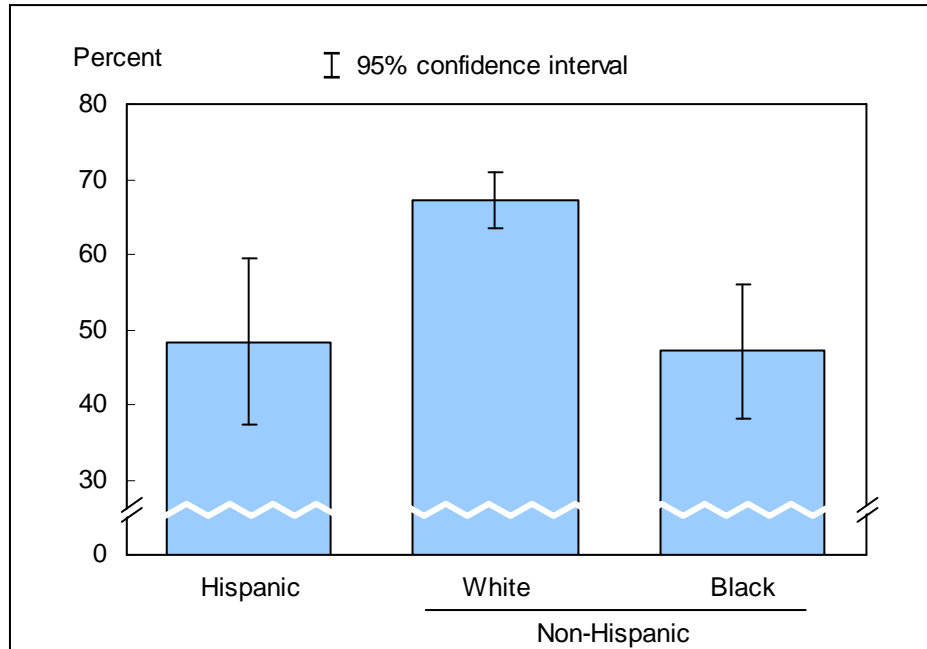

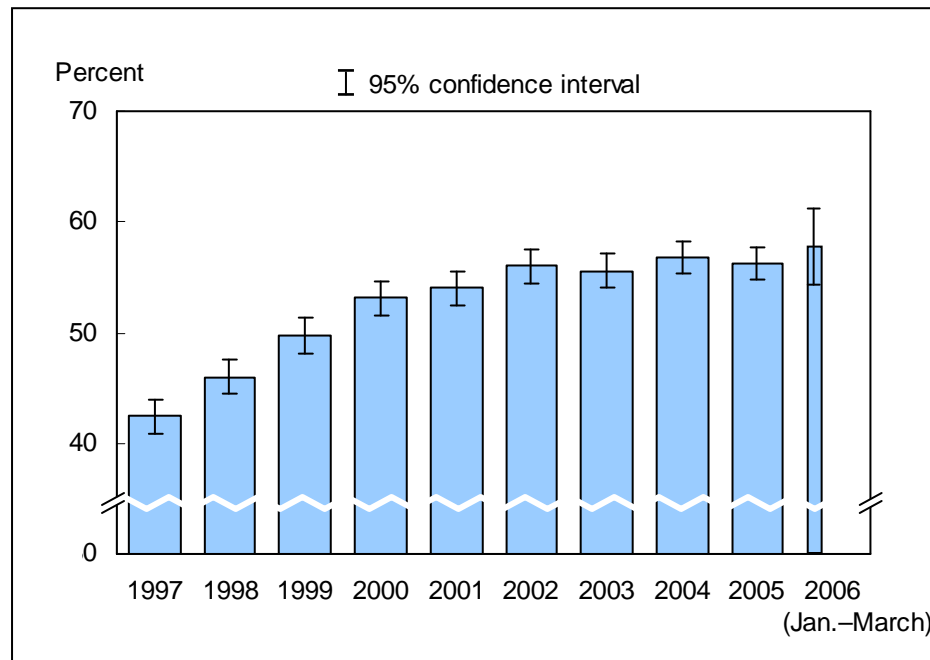

**Figure 5.1. Percentage of adults aged 65 years and over who had ever received a pneumococcal vaccination: United States, 1997–March 2006**



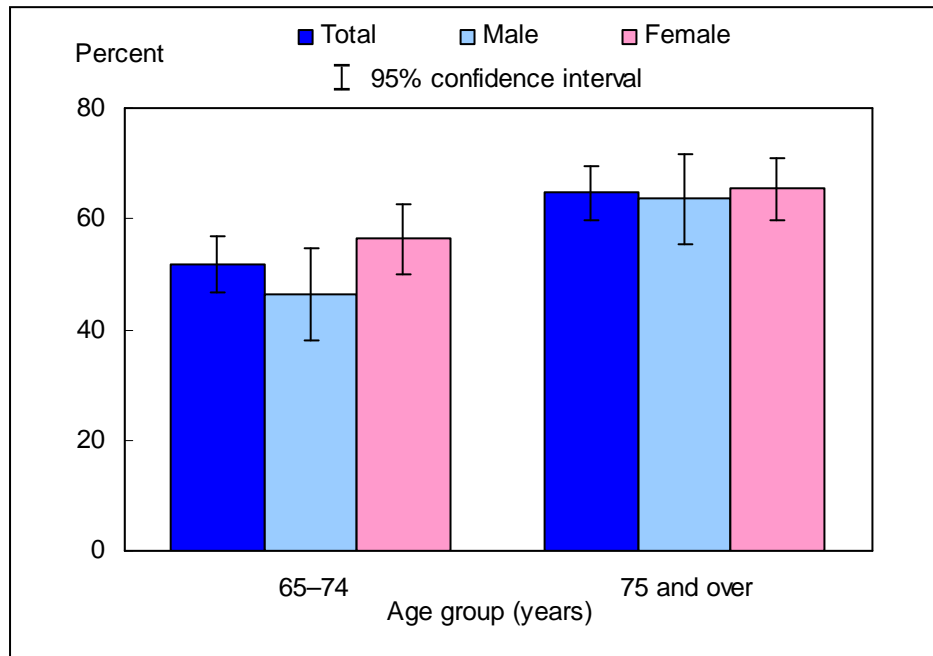

**Figure 5.2. Percentage of adults aged 65 years and over who had ever received a pneumococcal vaccination, by age group and sex: United States, January–March 2006**



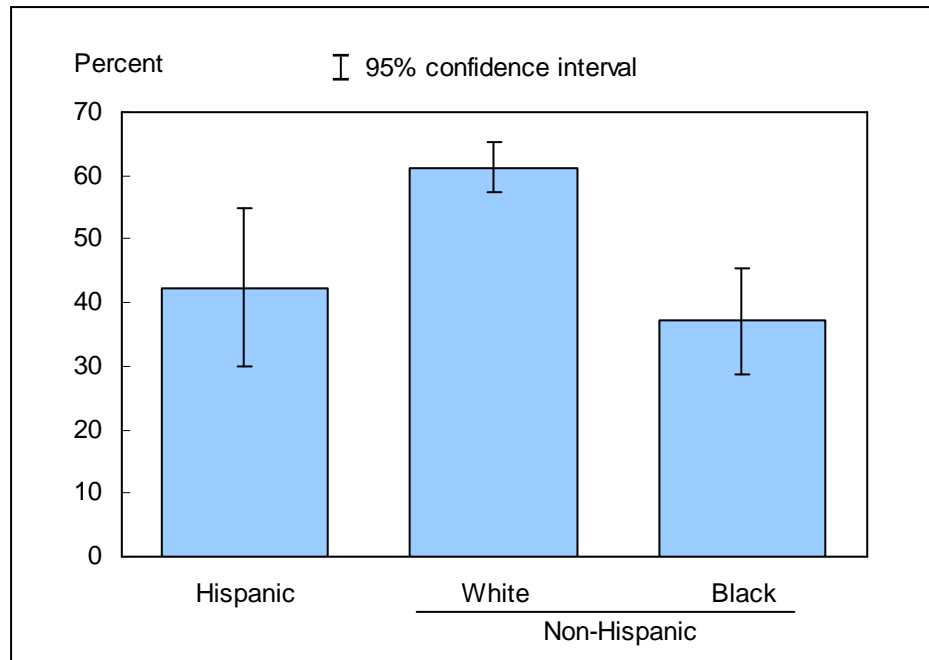

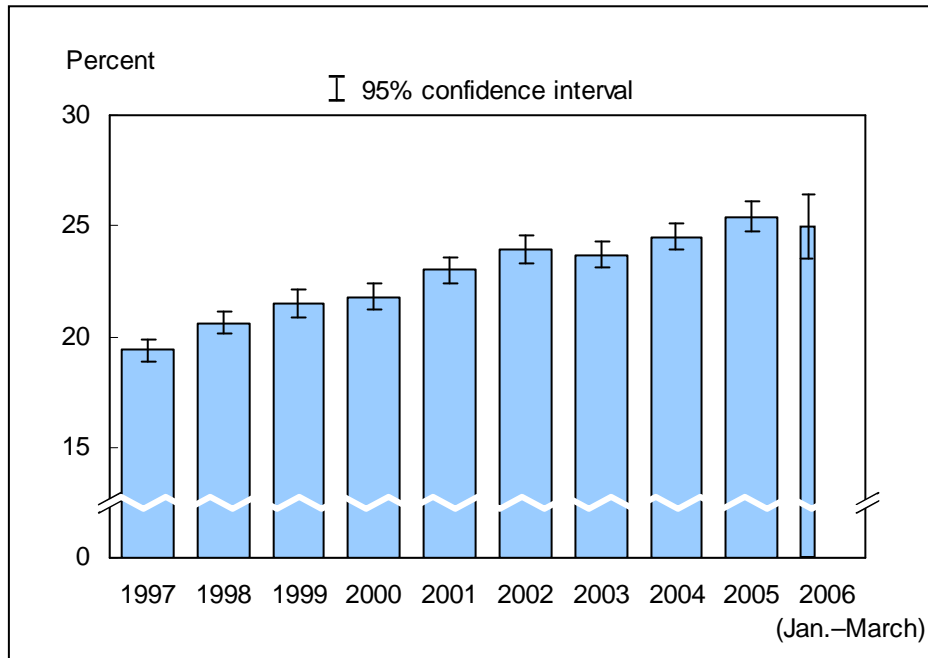

**Figure 6.1. Prevalence of obesity among adults aged 20 years and over: United States, 1997–March 2006**



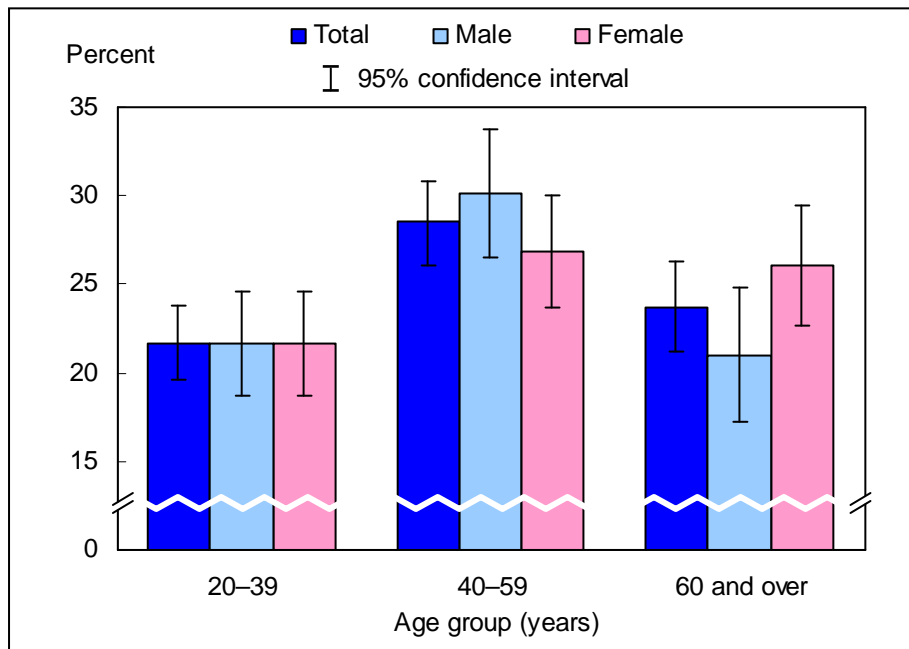

**Figure 6.2. Prevalence of obesity among adults aged 20 years and over, by age group and sex: United States, January–March 2006**

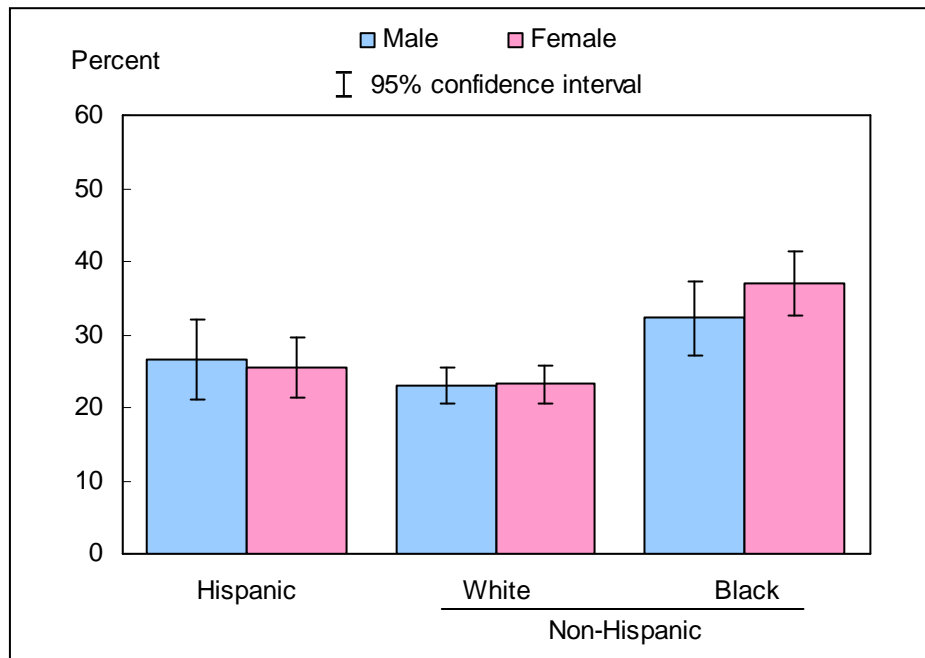

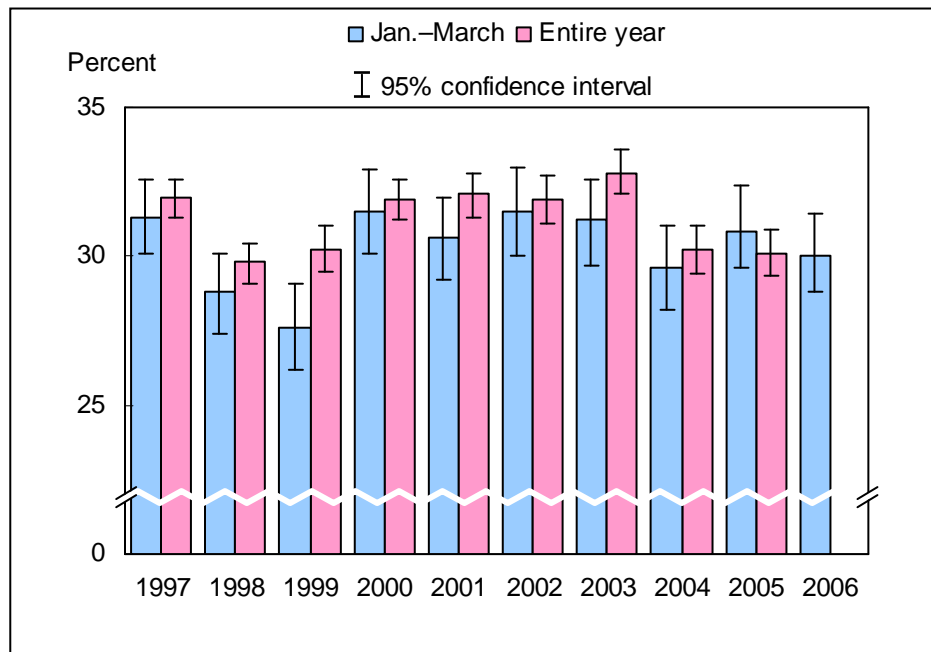

**Figure 7.1. Percentage of adults aged 18 years and over who engaged in regular leisure-time physical activity: United States, 1997–March 2006**

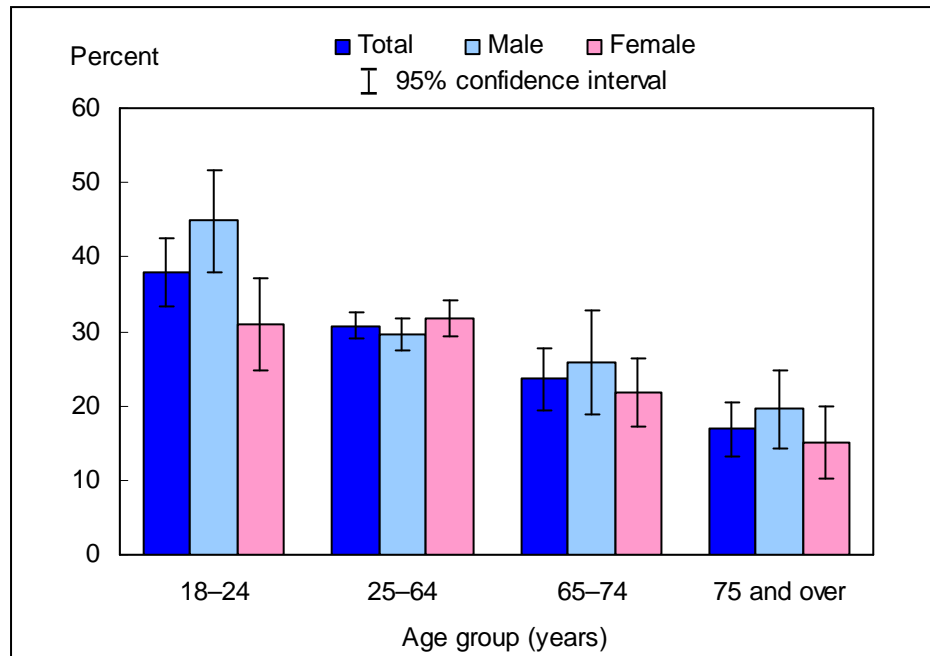

**Figure 7.2. Percentage of adults aged 18 years and over who engaged in regular leisure-time physical activity, by age group and sex: United States, January–March 2006**

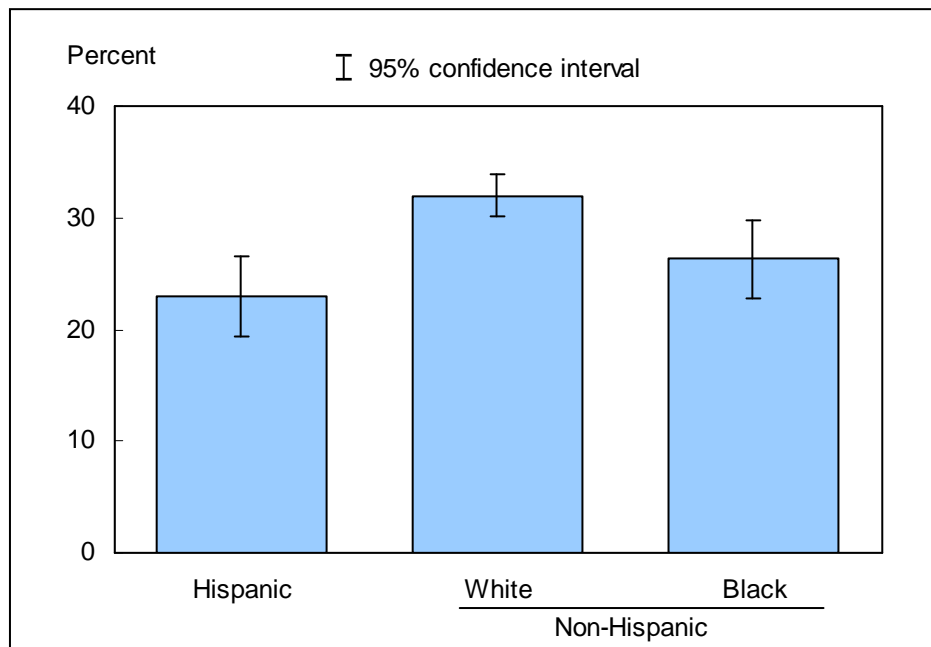

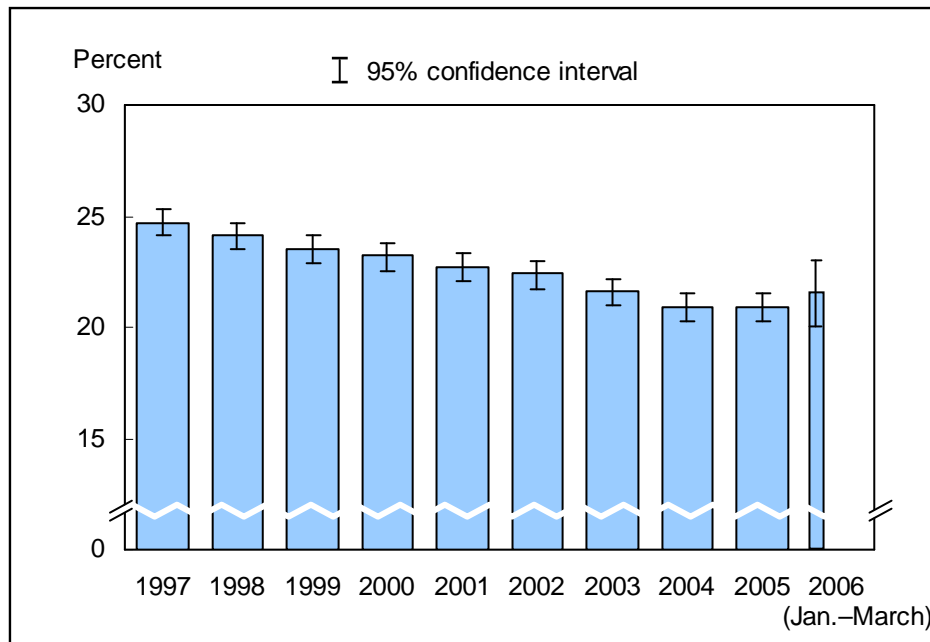

**Figure 8.1. Prevalence of current smoking among adults aged 18 years and over: United States, 1997–March 2006**

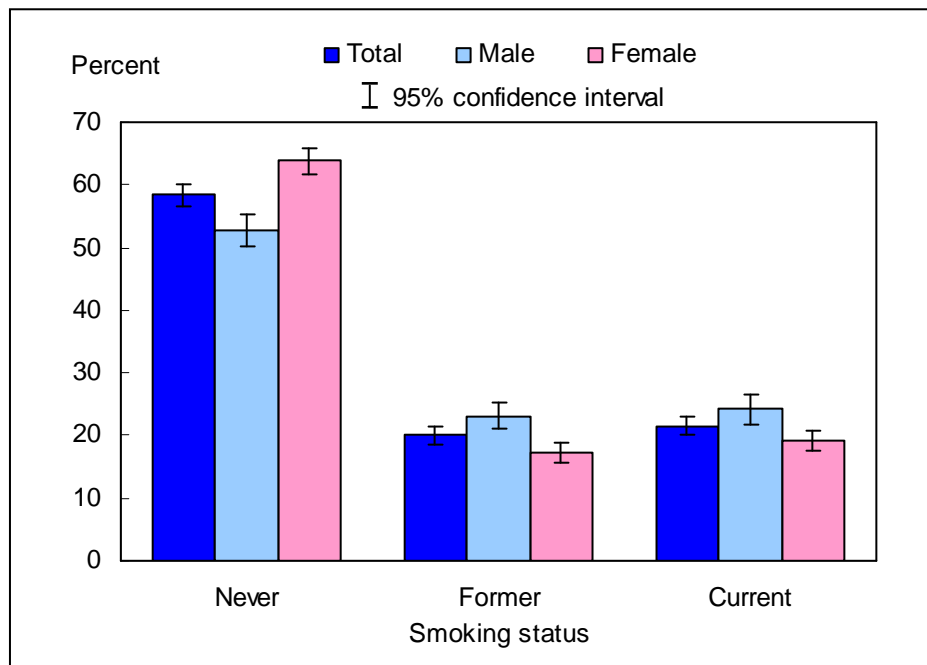

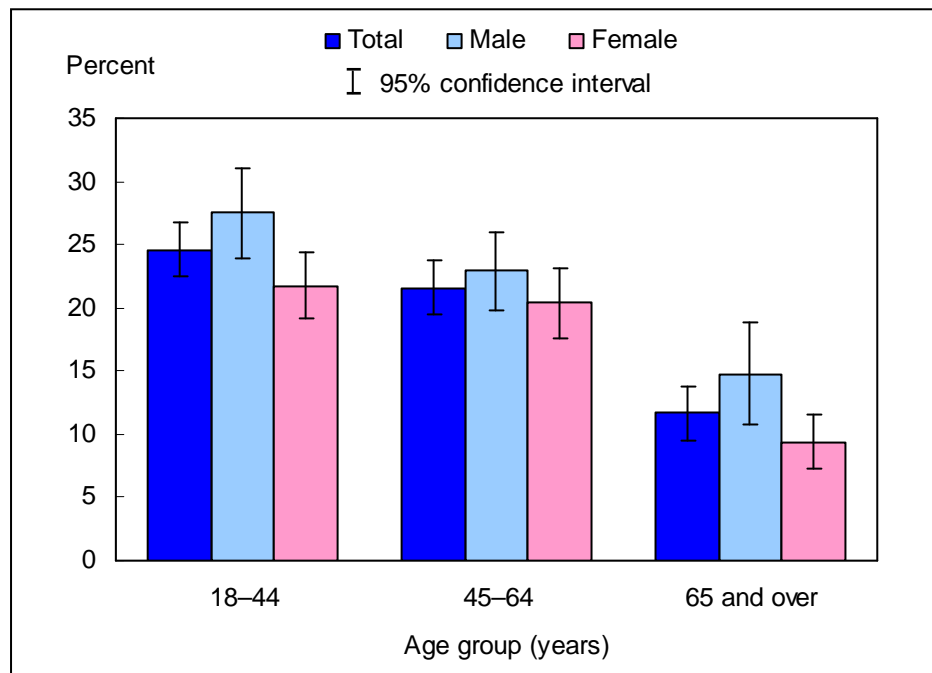

**Figure 8.3. Prevalence of current smoking among adults aged 18 years and over, by age group and sex: United States, January–March 2006**

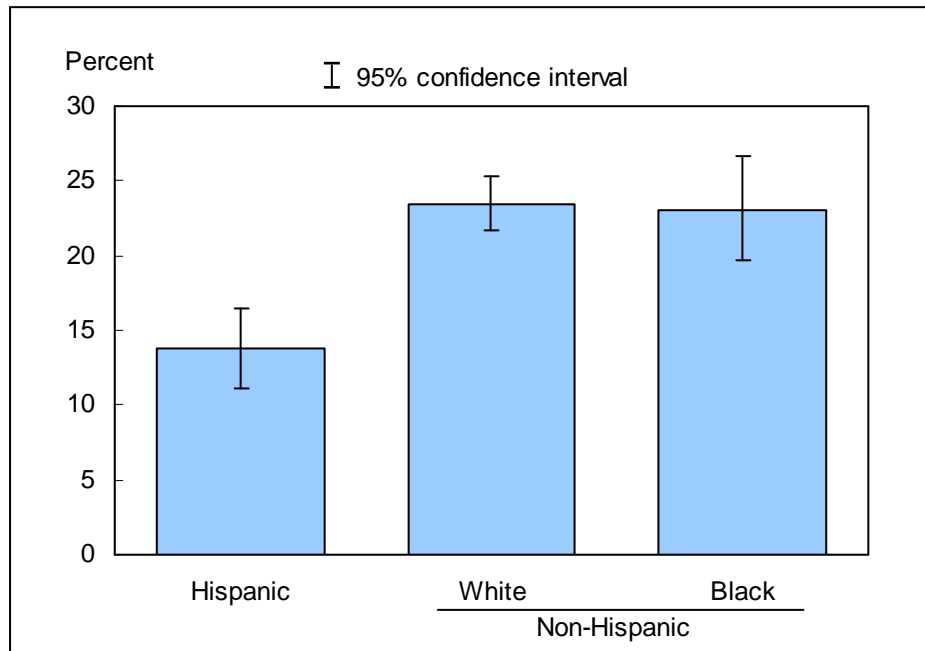

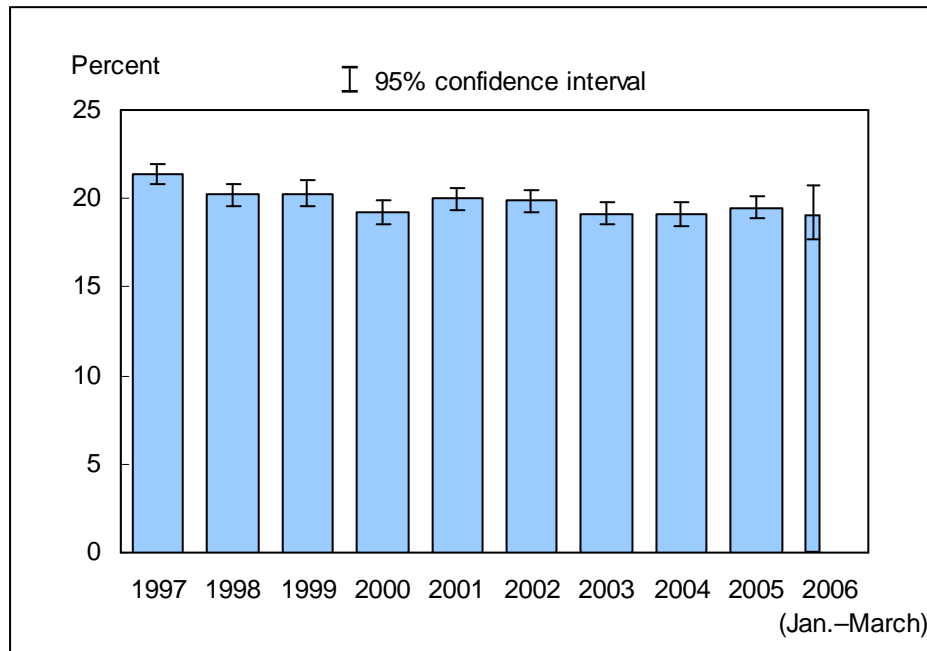

**Figure 9.1. Percentage of adults aged 18 years and over who had five or more drinks in 1 day at least once in the past year: United States, 1997–March 2006**

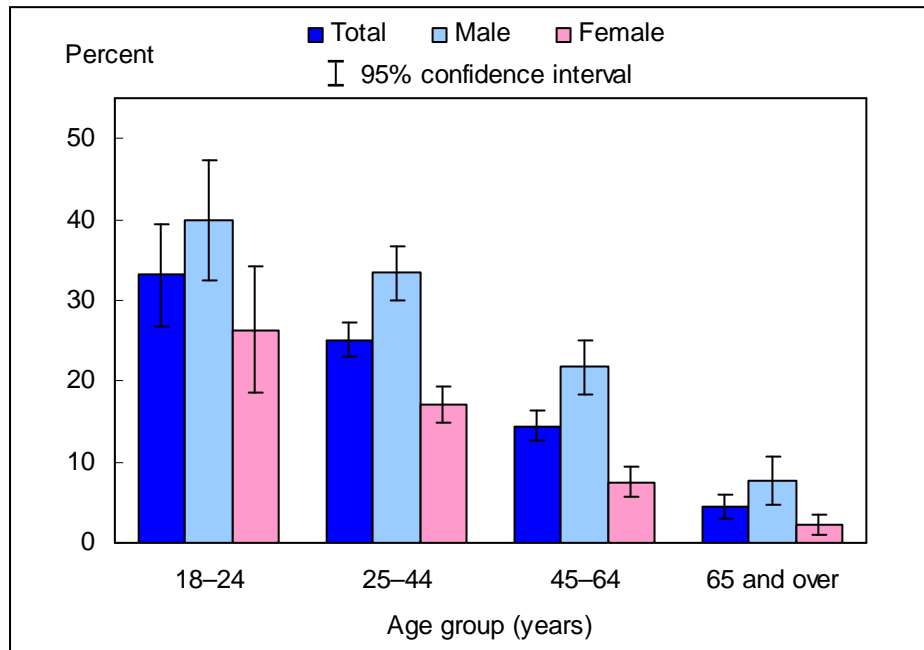

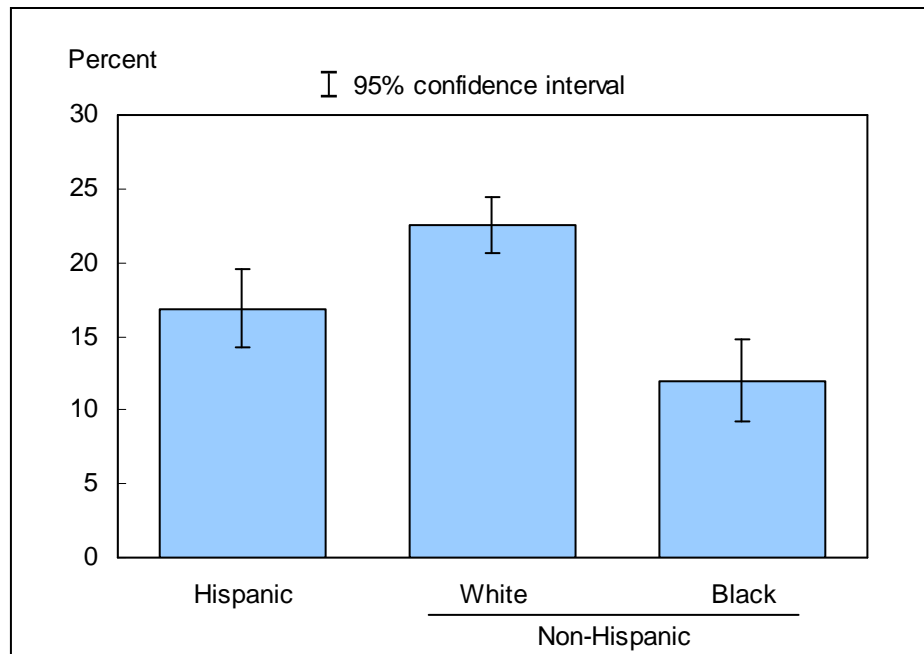

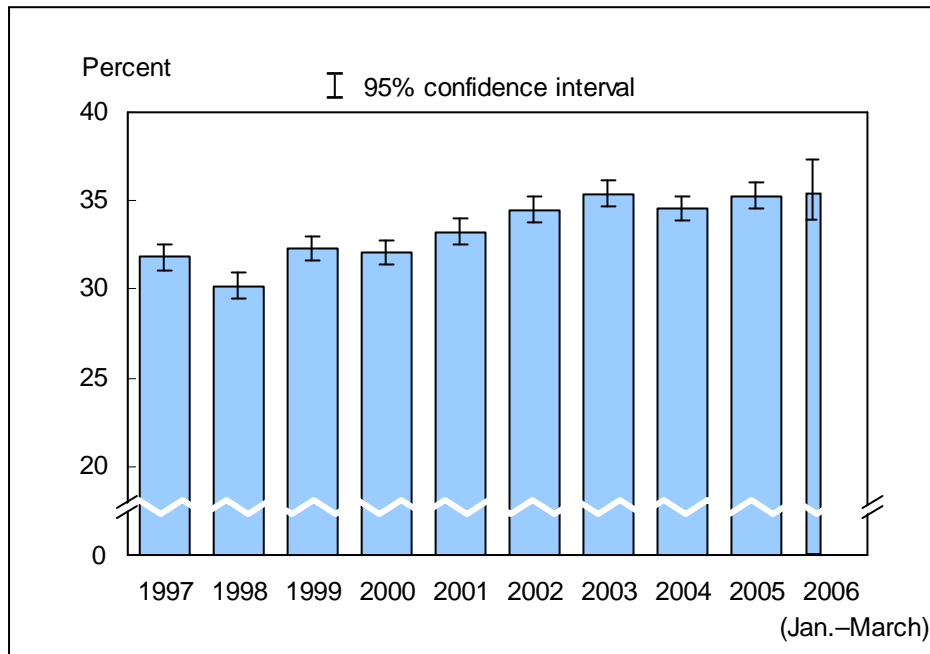

**Figure 10.1. Percentage of adults aged 18 years and over who had ever been tested for human immunodeficiency virus: United States, 1997–March 2006**



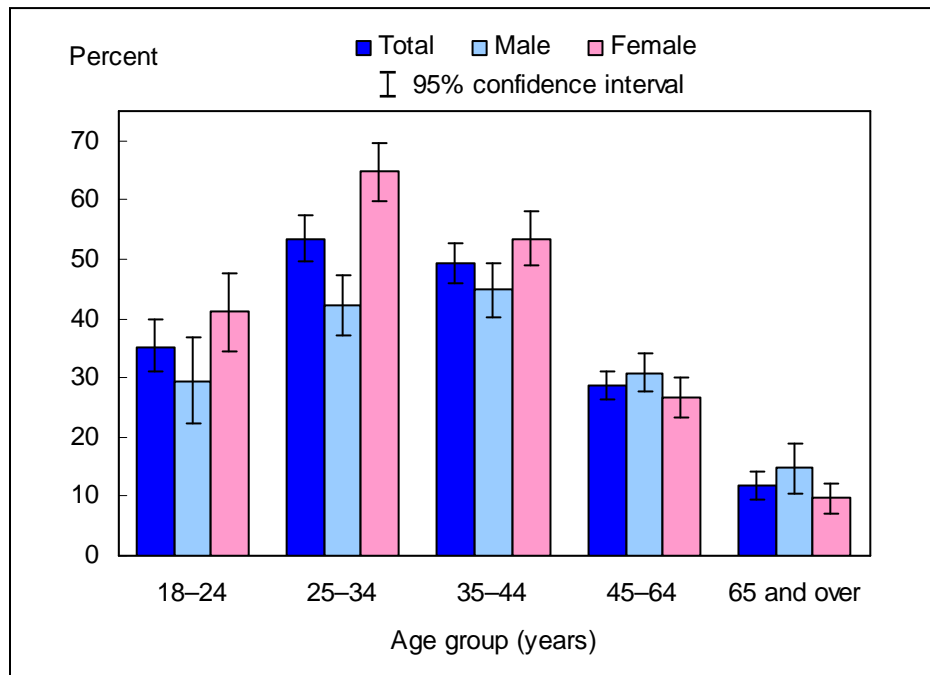

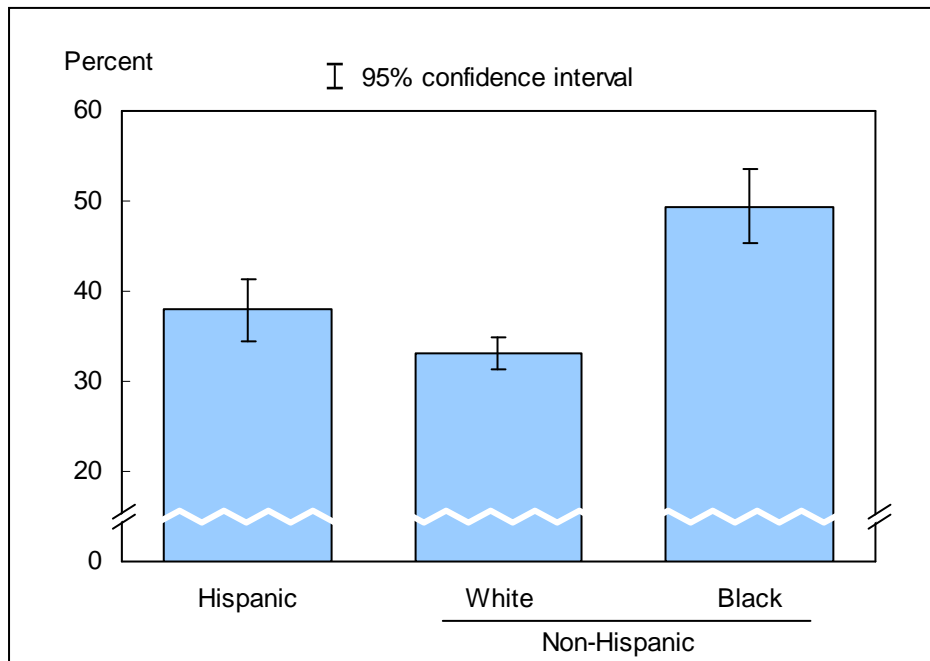

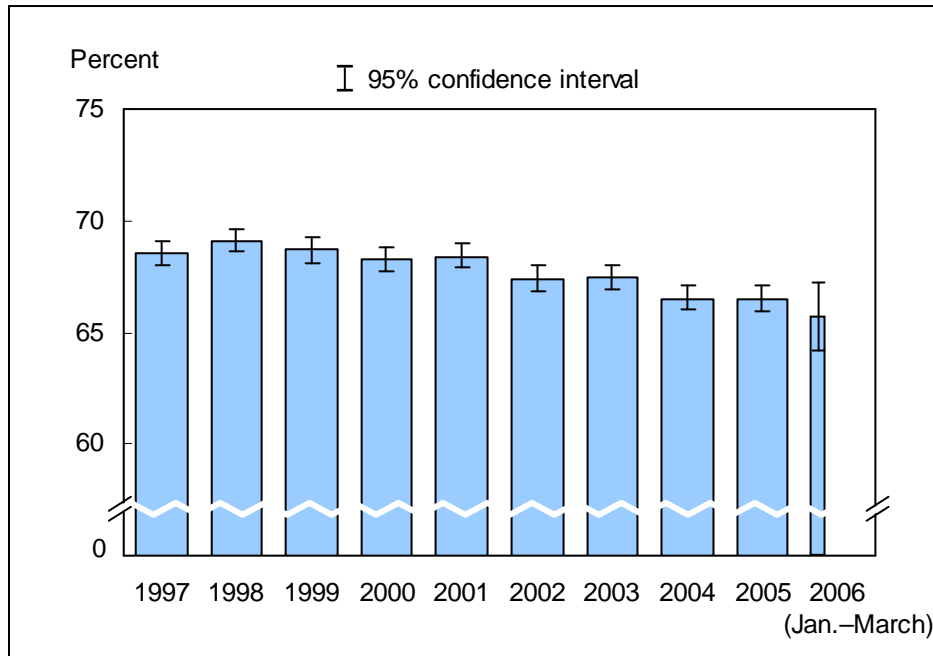

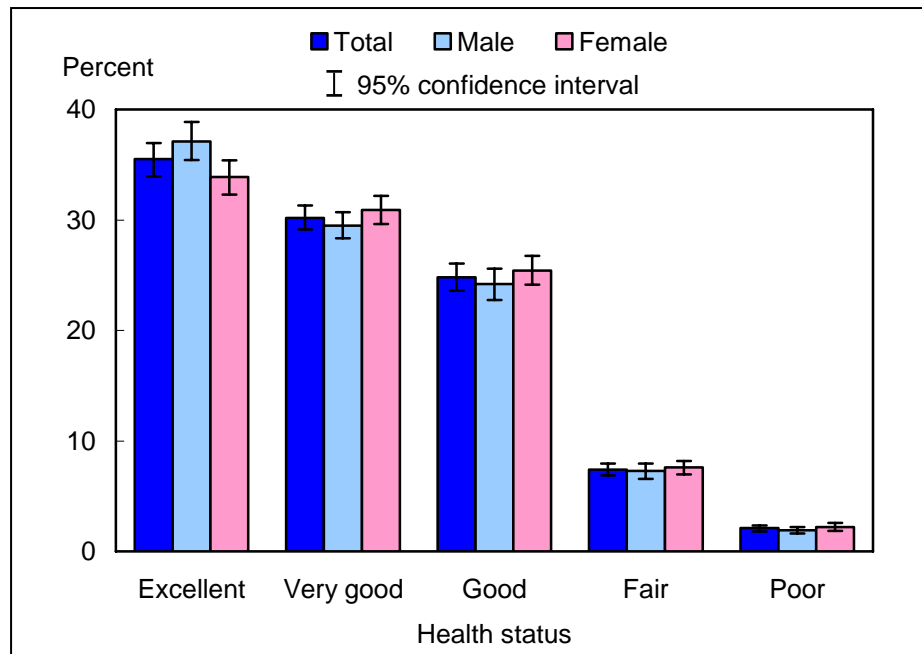

**Figure 11.2. Percent distribution of respondent-assessed health status, by sex for all ages: United States, January–March 2006**



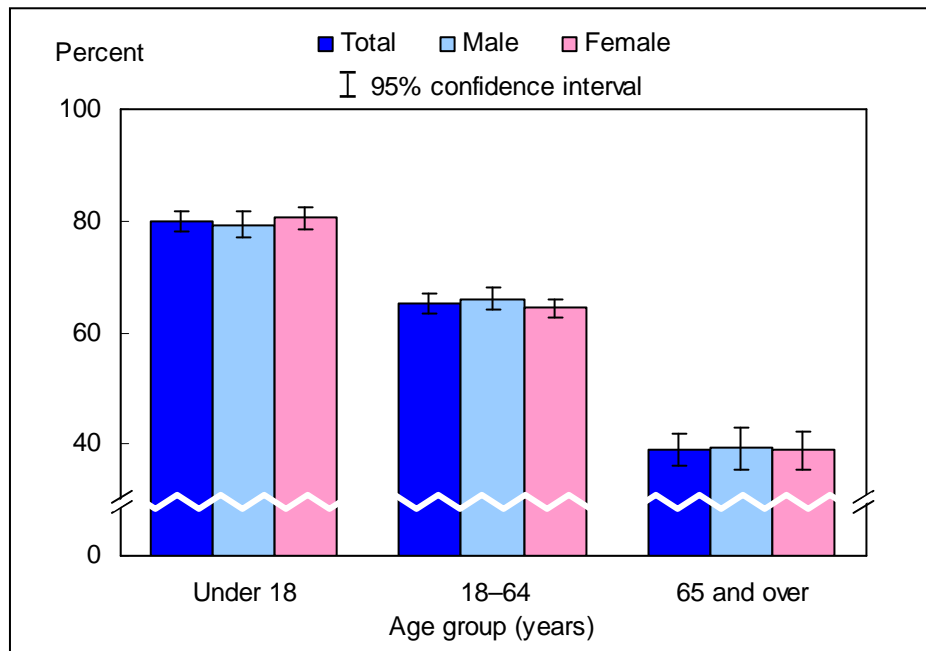

**Figure 11.3. Percentage of persons of all ages who had excellent or very good health, by age group and sex: United States, January–March 2006**



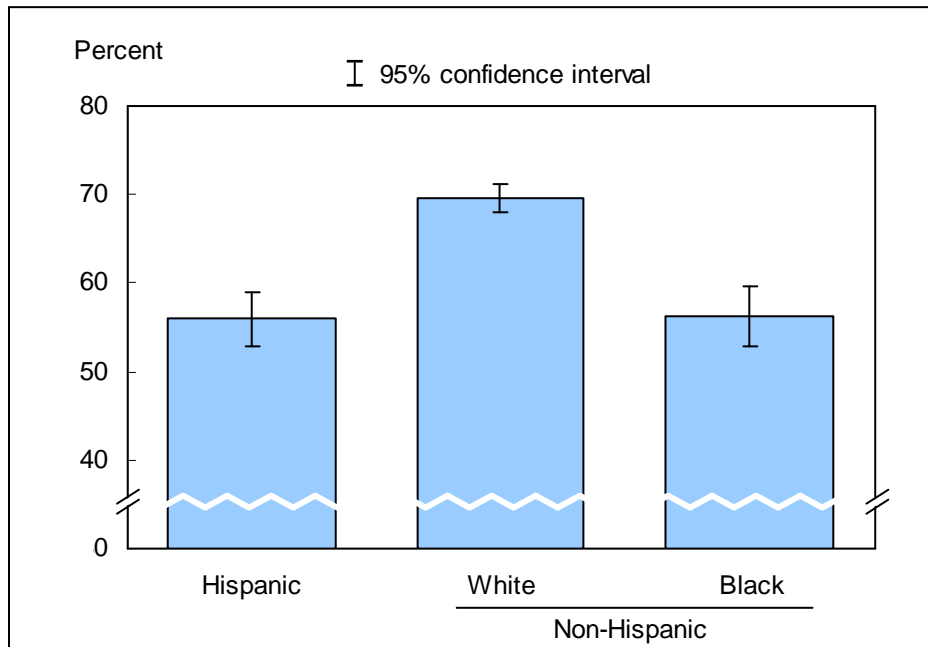

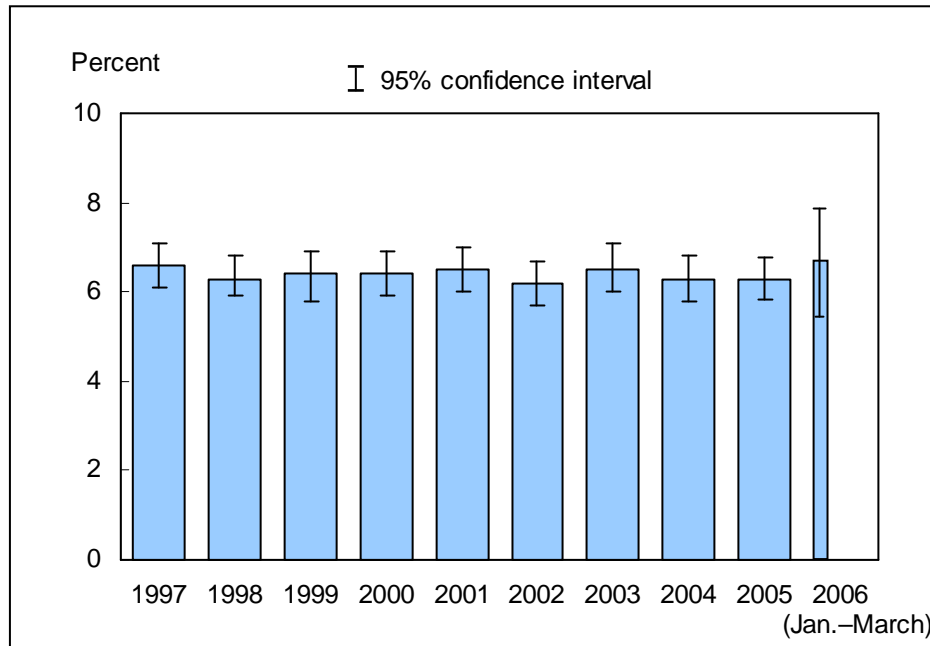

**Figure 12.1. Percentage of adults aged 65 years and over who need help with personal care from other persons: United States, 1997–March 2006**



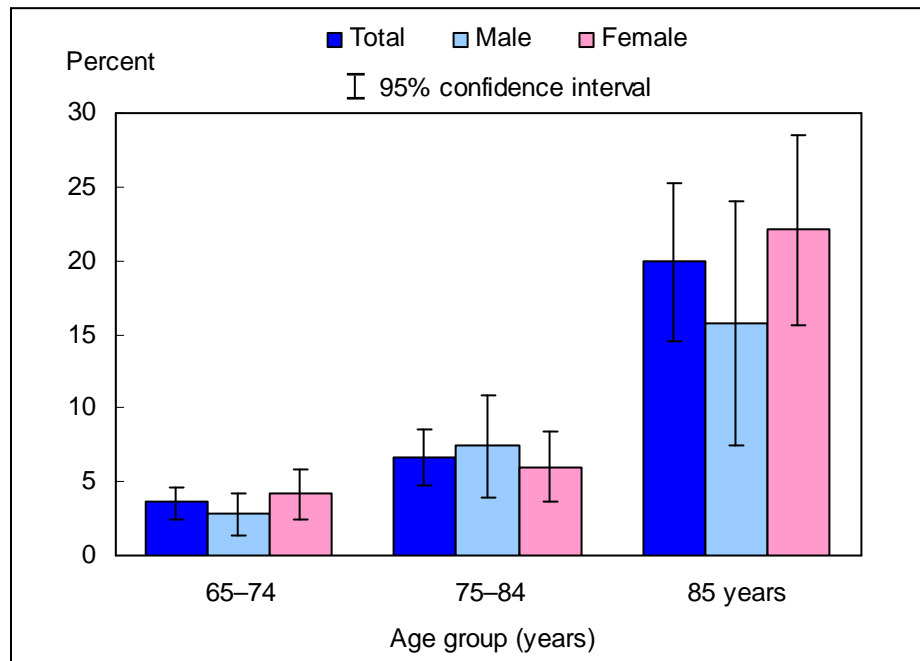

**Figure 12.2. Percentage of adults aged 65 years and over who need help with personal care from other persons, by age group and sex: United States, January–March 2006**

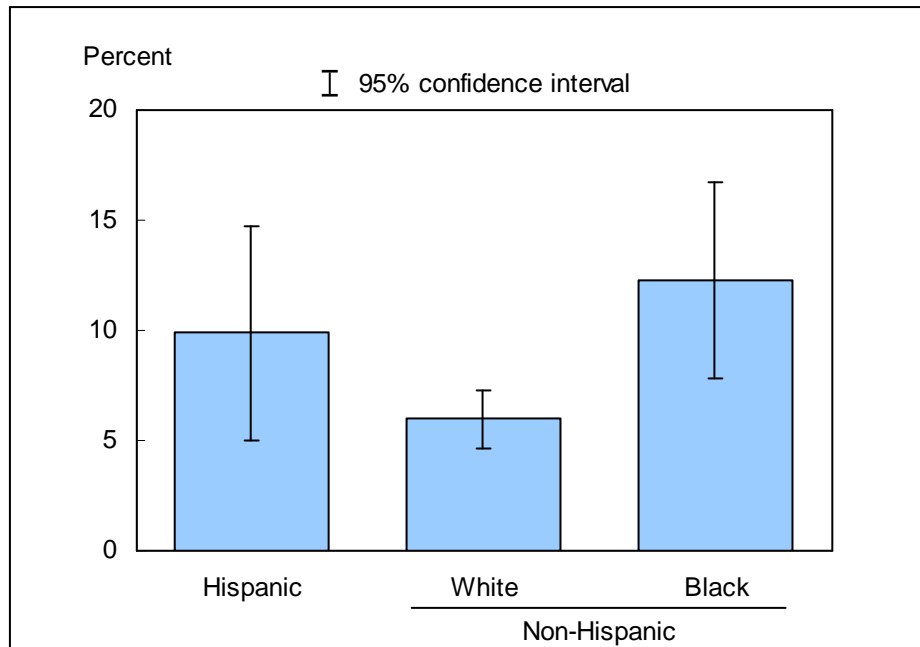

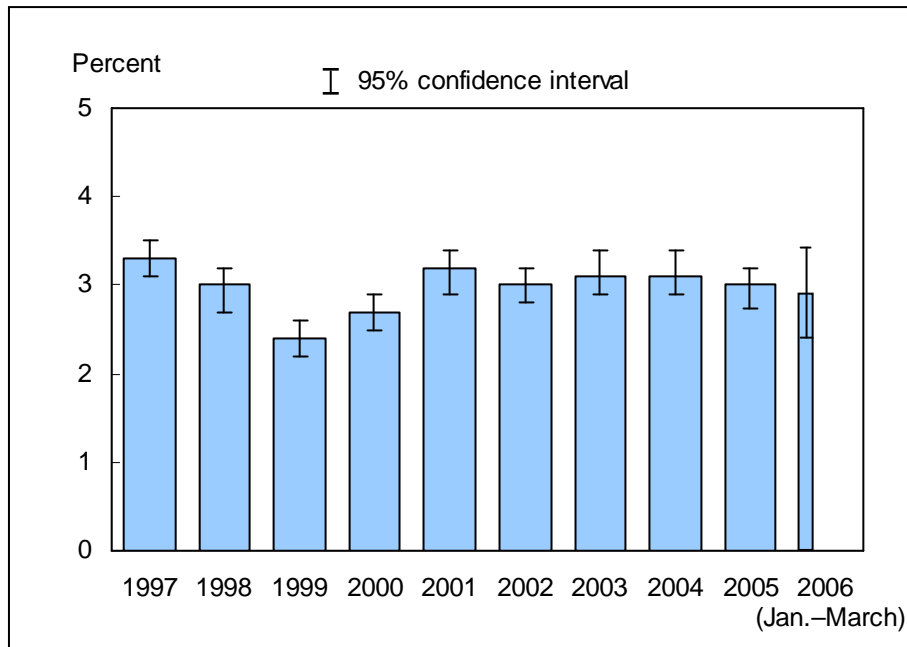

**Figure 13.1. Percentage of adults aged 18 years and over who experienced serious psychological distress during the past 30 days: United States, 1997–March 2006**



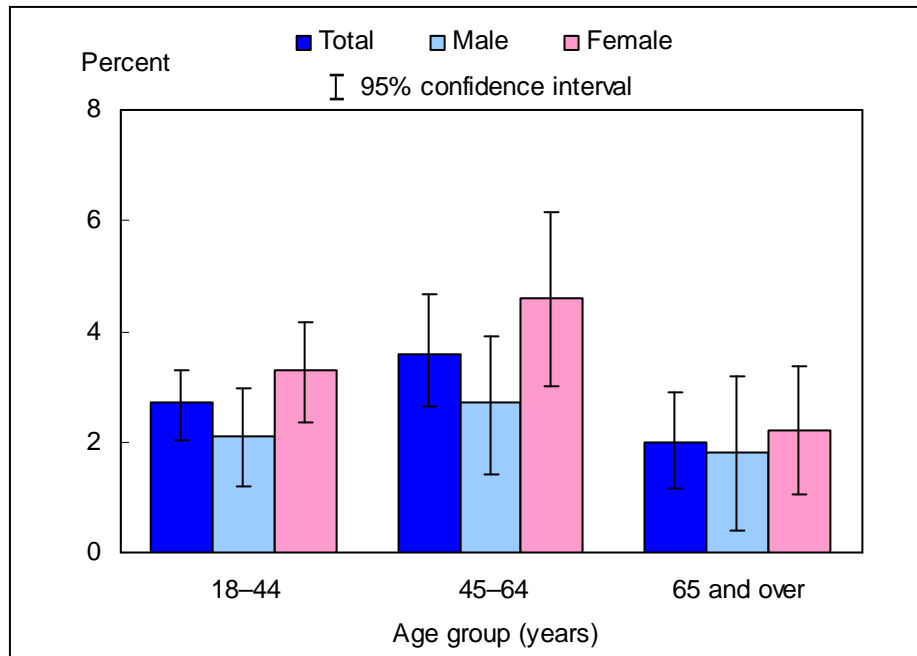

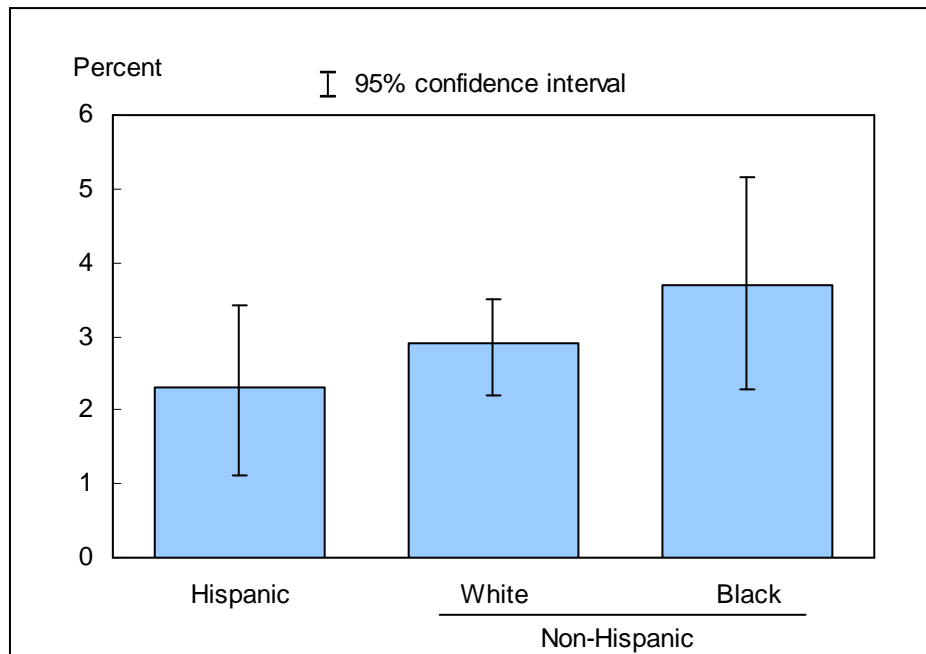

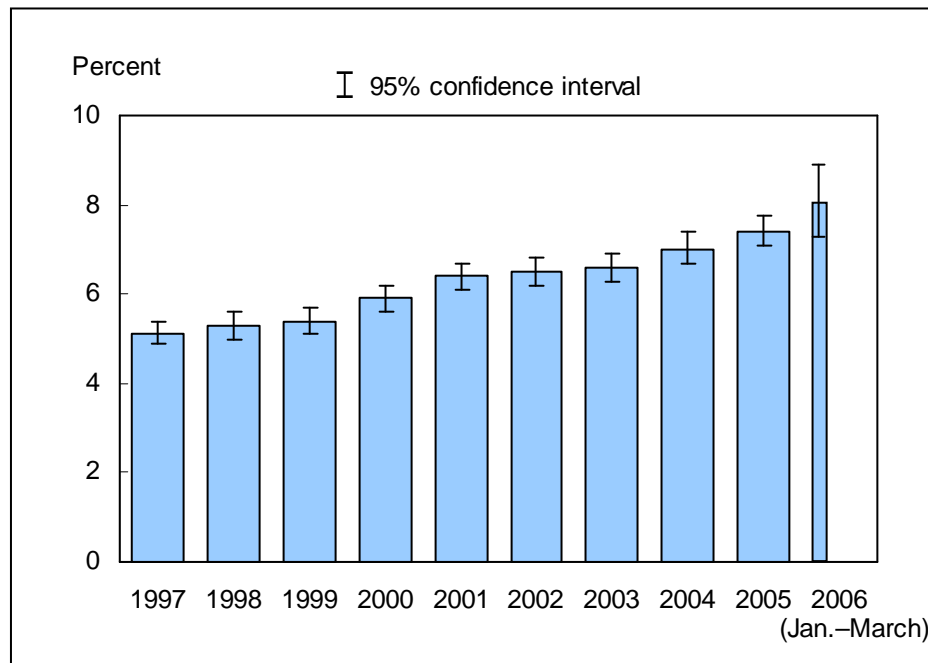

**Figure 14.1. Prevalence of diagnosed diabetes among adults aged 18 years and over: United States, 1997–March 2006**

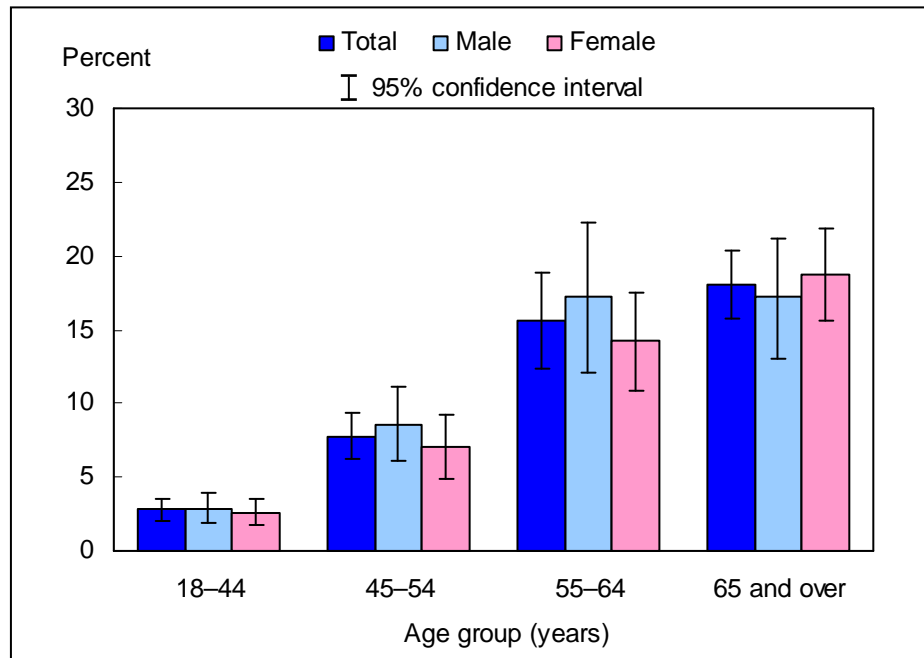

**Figure 14.2. Prevalence of diagnosed diabetes among adults aged 18 years and over, by age group and sex: United States, January–March 2006**

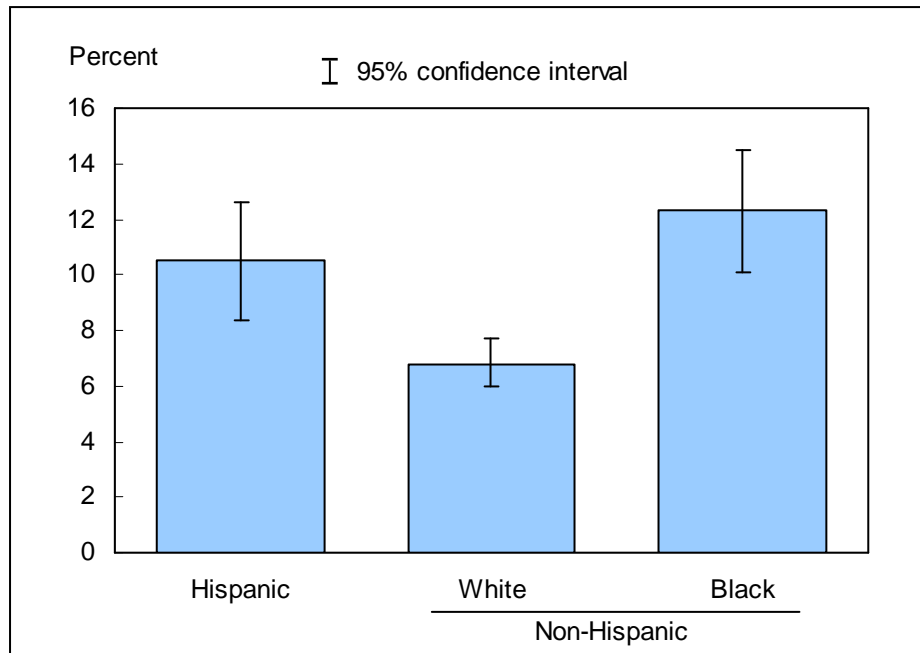

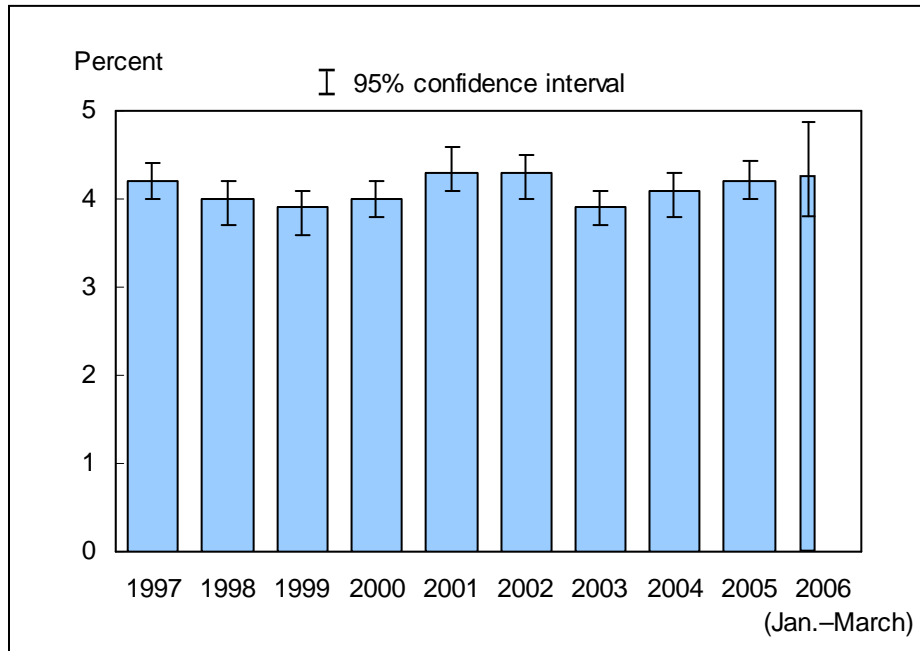

**Figure 15.1. Percentage of persons of all ages who experienced an asthma episode in the past 12 months: United States, 1997–March 2006**



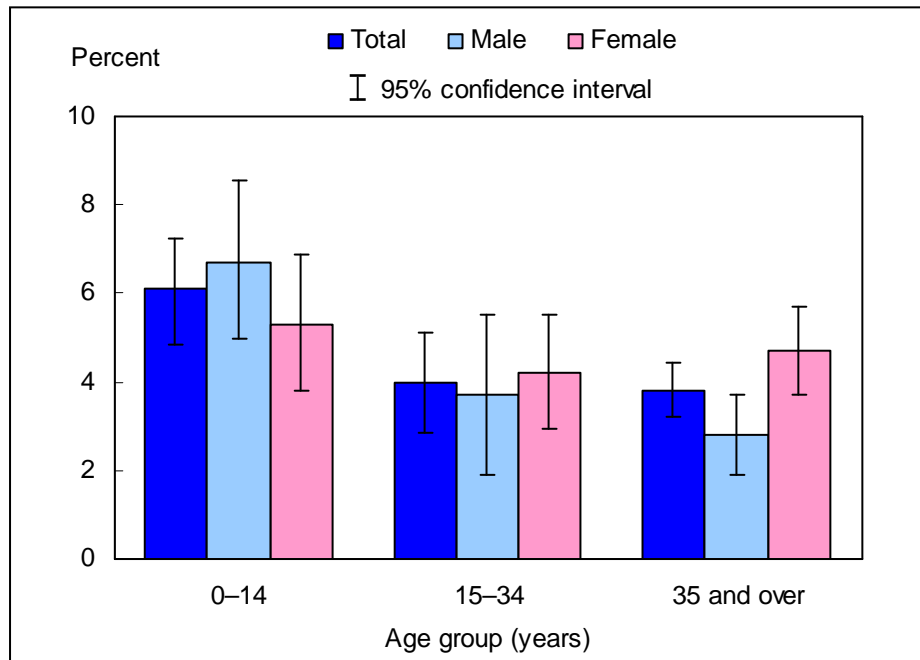

**Figure 15.2. Percentage of persons of all ages who experienced an asthma episode in the past 12 months, by age group and sex: United States, January–March 2006**



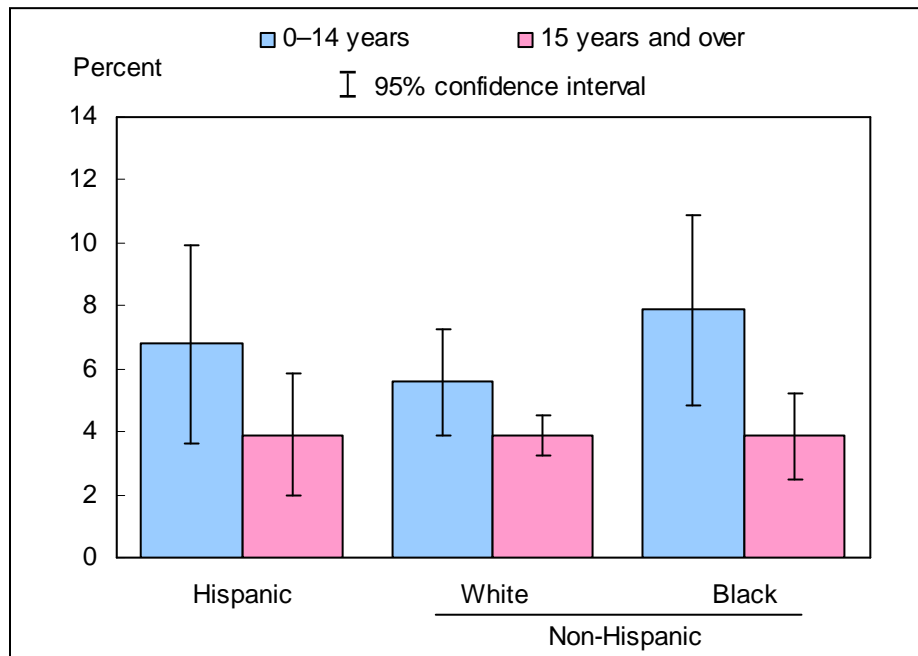

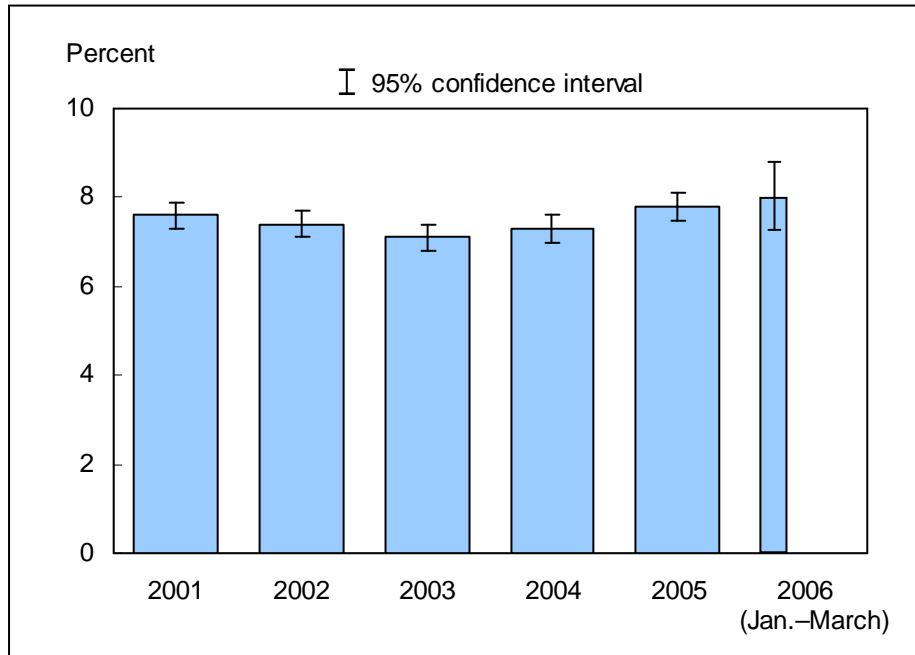

**Figure 15.4. Prevalence of current asthma among persons of all ages: United States, 2001–March 2006**



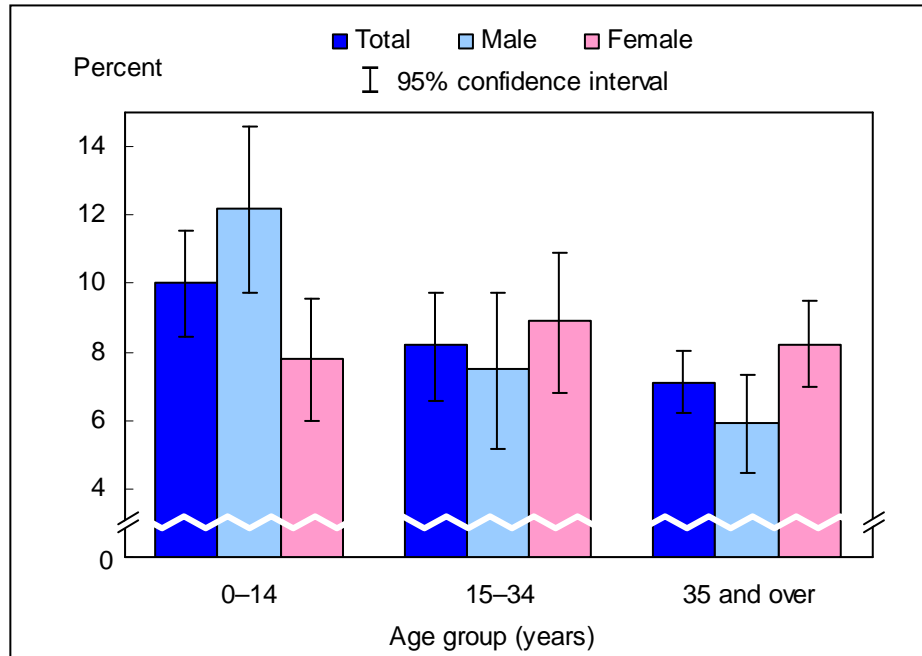

**Figure 15.5. Prevalence of current asthma among persons of all ages, by age group and sex: United States, January–March 2006**



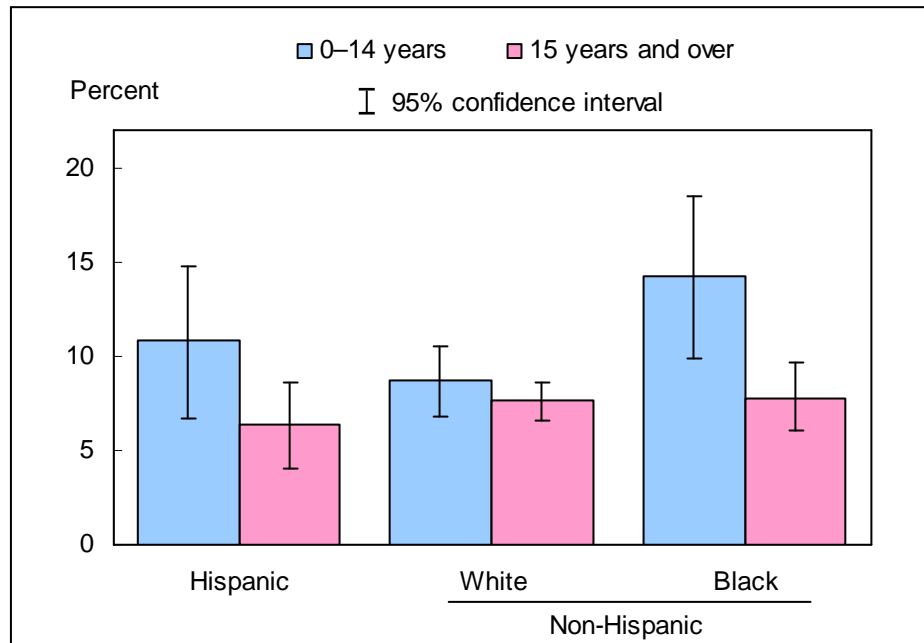
