Pooled proportions for each CMS region are calculated as the number of healthcare personnel (HCP) vaccinated at their facility plus the number who provided documentation of vaccination elsewhere, divided by the total number of HCP in that group reported as working at the facilities for one day or more from October 1 through March 31, and multiplied by 100. HCP are reported by each facility in which they work; therefore, individuals may be counted more than once.

*Inpatient rehabilitation facilities (IRFs) include freestanding facilities and Centers for Medicare and Medicaid Services-certified IRF units of acute care hospitals.
