#### Changes to Healthcare Personnel Safety Component (HPS)

<b>Analysis and Reporting</b>	<p><b>New Covid 19 Reports for Staff:</b> Two new Line Listings are available to track to track whether COVID-19 data was submitted during each month (line listing 1) and quarter (line listing 2) during the time they were enrolled in NHSN. The new report names can be found under the CMS Reports -&gt; Skilled Nursing Facility (SNF QRP) folder as follows:</p> <ul style="list-style-type: none"> <li>Line Listing - Monthly Completion Report HCP COVID-19 Vaccination CMS SNF QRP Beginning 2024_Q1</li> <li>Line Listing - Quarterly Completion Report HCP COVID-19 Vaccination CMS SNF QRP Beginning 2024_Q1</li> </ul> <p>The existing COVID-19 CMS Rate Report has been moved to a new Archived folder.</p>

#### Changes to Healthcare Preparedness Component (HP)

<b>Login</b>	The <b>Healthcare Preparedness Component</b> is currently unavailable until further notice as a menu option when logging into the NHSN application.
<b>Daily Facility Operating Status (DFOS)</b>	The <b>Daily Facility Operation Status</b> UI is currently unavailable until further notice.

#### Changes to Long Term Care Component (LTC)

<b>Alerts</b>	The "View My COVID-19 Vaccination Summary DQ" alert that appears on the NHSN homepage for LTC facilities has been renamed to "View My Respiratory Pathogens and Vaccination Summary DQ". This renamed alert reflects that the data quality checks accessible through the alert encompasses COVID-19, Influenza, and RSV data quality checks.

This impacts the following:</p> <ul style="list-style-type: none"> <li>For the <b>"By Procedure" SIR Report</b>, the variables are now the following: orgID, CCN, procCode, summaryYH (this variable can change depending on the time grouping chosen by user), procCount, infCountAdultAll, numPredAdultAll, SIRAll, SIRAll_pval, SIRAll95CI.</li> <li>For the <b>"By Surgeon" SIR Report</b>, the variables are now the following: orgid, CCN, surgeoncode, summaryYH (this variable can change depending on the time grouping chosen by user), procCount, infCountAdultAll, numPredAdultAll, SIRAll, SIRAll_pval, SIRAll95CI.</li> </ul>

This score is based on questions from the NHSN annual survey. Presentation of this data may mirror similar functions for displaying the Core Elements for Antibiotic Stewardship.</p>
<b>Import/Export</b>	<p><b>Bed Capacity:</b> A download API is now available for States/Jurisdiction or Vendors to export reported Bed Capacity data via an API.</p> <p><b>Hospital Respiratory Data (HRD):</b> The CSV Export and API for HRD were updated with the following time parameter options to download history:</p> <ul style="list-style-type: none"> <li>• One week</li> <li>• Two weeks</li> <li>• One month</li> <li>• Six months</li> <li>• All History</li> </ul>
<b>Infectious Diseases of Public Health Concern (IDPHC)</b>	<p>When selecting the menu option for <b>Infectious Diseases of Public Health Concern (IDPHC)</b>, a soft alert will appear notifying the user that the UI is not available for reporting. This UI will be unavailable until further notice.</p>
<b>Reporting Plan</b>	<p><b>VAE</b> has been removed from the monthly reporting plan for HOSP-PSYCH and CMS-certified IPF Units in the Add Monthly Reporting Plan page. This prevents Inpatient Psychiatric Hospitals (HOSP-PSYCH) and CMS-certified IPF Units from adding VAE reporting plans.</p>
