The following update responds to SC&A's February 3, 2016 comments on Matrix Issue #6: Decontamination and Decommissioning. The original SC&A comment was:

<u>Issue 6 – The decontamination and decommission (D&D) era of Pinellas operations is not sufficiently addressed.</u>

In the January 2016 SC&A response, this issue was open at the 11/19/2012 WG meeting.

SC&A Comment

The SME from January 2012 interviews indicated that all the contract employees were monitored by Pinellas RadSafe, before, during and after the D&D operations. Issue remained open pending NIOSH receipt of confirmatory D&D monitoring records from Albuquerque (11/19/2012 transcript, pp. 53–54).

During the February 11, 2016 Pinellas Working Group (WG) meeting, NIOSH described its Site Research Data Base (SRDB) holdings for the site. NIOSH has captured 5161 references in the SRDB. This represents an exhaustive search for Pinellas records and includes records searches at Albuquerque. Accordingly, the WG had placed this issue in abeyance until delivery of the Sandia National Laboratories (SNL) finding aid. NIOSH received the finding aid on March 1, 2016 and assessed its usefulness based on key word searches.

The key words used to search the finding aid are in the following table. The key words used were chosen to determine if there was any information related to health physics; site radioactive materials; site decontamination and decommissioning (D&D); and, radiation protection was in the finding aid.

During the 2008, 2010 and 2014 data captures at SNL and Morgantown (Legacy Management holdings), NIOSH captured 103 documents (see attached listing). Of the 44 documents captured in 2010, only one provided information (SRDB 86965) useful to the Pinellas TBD efforts. The 2010 and 2014 data capture efforts exhausted the known cache of unclassified documents.

The latest SNL finding aid of Pinellas holdings lists 50 boxes containing various documents that, based upon the title of the documents, mostly relate to plant operations. However, NIOSH did note that the SNL finding aid contains some document titles that indirectly could be of potential value (e.g., *The Helium3 Release and Retention Characteristics and the Stoichiometric Behavior of Aged Tritided Uranium, Uranium Oxide and Uranium-Aluminum Samples*). While these titles relate to possible source terms, they do not relate to D&D or radiation safety programmatic knowledge.

Based on our review, NIOSH believes that none of the documents in the SNL finding aid will add to our understanding of the D&D activities at Pinellas.
