- □ Obesity: Body mass index (BMI) of 30 kg/m² or higher.
- Body mass index (BMI): A calculated measure of weight relative to height, defined as body weight in kilograms divided by height in meters squared.



#### Source of the Data

- The data were collected through the Behavioral Risk Factor Surveillance System (BRFSS), an ongoing, state-based, telephone interview survey conducted by state health departments with assistance from CDC.
- □ Height and weight data used in the BMI calculations were self-reported.



BRFSS Methodological Changes Started in 2011


- New sampling frame that included both landline and cell phone households.

#### Summary

- No state or territory had a prevalence of obesity less than 25%.
- 8 states and the District of Columbia had a prevalence of obesity between 25% and <30%.
- □ 22 states had a prevalence of obesity between 30% and <35%.
- 17 states, Puerto Rico, and Virgin Islands had a prevalence of obesity between 35% and <40%.
- 2 states (Mississippi and West Virginia), and Guam had a prevalence of obesity
   40% or greater.
