U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES Centers for Disease Control and Prevention (CDC) "Public Health and Social Services Emergency Fund" Public Health Emergency Response (PHER) Phase II Funding for Vaccination Campaign Planning

I. Authorization and Intent

Announcement Type: Supplemental – Type 3 Funding Opportunity Number: CDC-RFA-TP09-90201-H1N109 Catalog of Federal Domestic Assistance Number: 93.069 Application Deadline: August 13, 2009 Authority: Sections 317(a) and (e) of the Public Health Service Act, as amended, [42 U.S.C. §§ 247b(a), (e)]

Purpose

Additional pandemic influenza preparedness funding is available through the Public Health and Social Services Emergency Fund to upgrade state and local preparedness and response capacity. These funds, known as PHER Phase II funds, supplement the \$260 million provided to state and local health departments through the Public Health Emergency Response grant (PHER Phase I) for vaccination planning and for laboratory testing, epidemiology, surveillance, and other associated pandemic preparedness and response activities. A total of \$248 million in PHER Phase II funding is available to further accelerate planning for a national vaccination campaign for H1N1 influenza in the fall of 2009.

The PHER Phase II funding is intended to provide additional resources to augment the mass vaccination planning and implementation preparedness activities described in the PHER Phase I funding opportunity announcement (FOA) released by CDC on July 9, 2009. PHER Phase II funding also may be used for vaccine delivery, vaccine administration, and related communications planning and implementation.

The PHER Phase I FOA described activities expected of awardees with respect to pandemic influenza planning and response, providing guidance in two specific areas:

 Focus Area 1: Vaccination, Antiviral Distribution/Dispensing and Administration, Community Mitigation, and Other Associated Pandemic Preparedness and Response Activities; and,
 Focus Area 2: Laboratory, Epidemiology, Surveillance, and Other Associated Pandemic Preparedness and Response Activities. This PHER Phase II award provides additional resources for Focus Area 1 only, with a special emphasis on mass vaccination readiness. Funding is not provided for Focus Area 2 activities. This document is not intended to specify new mass vaccination-related activities, but rather to accelerate the speed in which these activities can be accomplished with additional funding. The goal of this additional funding is to assure readiness at the state and local levels for implementation of a large-scale mass vaccination campaign against H1N1 influenza expected to begin in the fall of 2009. Prior to requesting these PHER Phase II funds, awardees should review the objectives described in the PHER Phase I FOA as well as the additional information provided below.

Awardees are expected to assess mass vaccination readiness through a variety of methods, including but not limited to:

- Reviewing after-action reports (AARs) of previous exercises/real events; and,
- Identifying preparedness gaps by using the CDC Gap Analysis Tool (scheduled to be distributed to PHER awardees on or before August 11, 2009).

Background

On April 26, 2009, the Acting Secretary of Health and Human Services declared a public health emergency as a result of the detection of 20 known cases of individuals infected by a swine-origin influenza A virus, now known as novel H1N1 influenza, in the United States. On June 11, 2009, the World Health Organization declared the first pandemic in more than 40 years in recognition of widespread, sustained human-to-human transmission of the virus in multiple regions around the globe. In light of the threat the pandemic poses to the nation's public health and security, Congress appropriated funding, through the 2009 Supplemental Appropriations Act, for the Public Health and Social Services Emergency Fund to prepare for and respond to an influenza pandemic. This funding provides the U.S. Department of Health and Human Services (HHS) and other federal and state agencies with resources to respond to ongoing and emerging outbreaks of novel H1N1 influenza virus in the United States, protect the public health, accelerate efforts in responding to the current global influenza pandemic, and prepare for additional waves of the current pandemic or outbreaks of other avian, swine, and human influenza viruses.

II. Program Implementation

Recipient Activities

Awardees are expected to use this additional funding for accelerated H1N1 influenza vaccination planning and response activities described in Focus Area 1 of the PHER Phase I FOA (see below), to assess their current capabilities in pandemic influenza response, and to address remaining gaps in mass vaccination planning.

Focus Area 1: Vaccination, Antiviral Distribution/Dispensing and Administration, Community Mitigation, and Other Associated Pandemic Preparedness and Response Activities. The purpose of Focus Area 1 is to conduct accelerated planning activities to identify and address gaps in existing plans and to initiate implementation of activities in preparation for a possible mass vaccination campaign. During a pandemic, reducing transmission can be accomplished by increasing immunity to the virus through vaccination and reducing exposure to the virus. Community mitigation measures could also reduce people's exposure to the virus throughout all phases of the vaccine campaign. Awardees should plan for both vaccination and community mitigation activities, which can be complemented by use of antiviral drugs. Costs for training and education of the public health workforce to support these activities will be approved if they are within the scope of the grant.

Recommended awardee activities include development of comprehensive communication strategies regarding vaccine planning and implementation, as well as all other suggested activities outlined in the PHER Phase I FOA, as summarized below:

- Vaccination planning for public health-organized clinics
- Identifying and engaging private-sector partners for potential vaccine administration
- Defining potential vaccine-receiving sites
- Enhancing cold-chain capacity where needed
- Safety monitoring
- Tracking vaccine and vaccine supplies
- Monitoring and reporting of vaccine doses administered
- Initiating contracts with community vaccinators and others for early implementation activities
- Communications planning
- Planning for potential antiviral distribution/dispensing and administration
- Community mitigation planning and strategies
- Community planning and exercising

III. Award Information and Requirements

Eligible Applicants

Financial assistance is available only to the 62 eligible applicants of PHER Funding Opportunity Announcement CDC-RFA-TP09-902-H1N109.

Funding

CDC will administer a total of \$248 million in PHER Phase II funding to support accelerated planning for a national vaccination campaign for H1N1 influenza in the fall of 2009. To assure that all awardees have sufficient resources to conduct the activities described in this guidance, the formula for this award will include base funding plus additional funding based on population estimates (**Appendix 1**).

IV. Content and Form Submission

Application Requirements

To assure that awardees have ready access to the funds necessary for accelerated vaccination campaign planning, CDC will streamline the submission requirements for the

PHER Phase II awards. The requirements for the PHER Phase II application, to be submitted via <u>www.grants.gov</u>, include:

- A letter, co-signed by the applicant's preparedness program director, immunization program director, and authorized fiscal officer, requesting the *entire award* be allocated (see funding table in Appendix 1). The letter must include language that states that the applicant will submit the required gap analysis, work plan, and revised, combined PHER Phase I and Phase II budget on or before August 31, 2009.
- Form 424A
- A general budget with a budget justification describing how the applicant intends to use the **PHER Phase II** funding.

Application Deadline

Applications are due by 2 p.m. EDT on August 13, 2009, and are to be electronically submitted to www.grants.gov.

V. Award Administration Information

Award Notices

Funds are expected to be awarded on or before August 21, 2009. CDC may restrict up to 20% of the PHER Phase II funds until the applicant completes the additional requirements described below.

Reporting Requirements

All previously stated reporting requirements remain unchanged and in effect.

In addition, awardees must submit to PERFORMS by September 15, 2009, letters indicating they have comprehensive, up-to-date plans in place for a potential H1N1 influenza mass vaccination campaign. CDC does not plan at this time to require awardees to submit their mass vaccination plans for review.

Additional Requirements

On or before August 31, 2009, awardees must submit the following into PERFORMS:

- Gap Analysis: Using the gap analysis tool provided by CDC, awardees will identify any remaining gaps in state, local, territorial, and tribal pandemic preparedness in the two focus areas (vaccination, antiviral distribution/dispensing and administration, and community mitigation; and laboratory, epidemiology, and surveillance). The gap analysis is intended to help awardees identify priority areas for improvement and to determine how funds are to be directed.
- Work Plan: Awardees will use the results of the gap analysis to prioritize remaining gaps, determine which gaps are the most critical/highest priority areas and develop work plans to describe how these gaps will be addressed. Work plans will be for activities to be completed in 12 months.

• Detailed Budget: Awardees must develop a combined and detailed 12-month PHER (Phases I and II) budget for Focus Area 1. Awardees also must submit a separate, detailed PHER Phase I budget for Focus Area 2. Budgets should reflect how funds will be used to address any remaining gaps in pandemic preparedness identified through the gap assessment. Awardees may use a portion of their PHER funding (Phases I and II) to request direct assistance (DA) personnel.

<u>Note:</u> Awardees are only required to conduct one gap analysis and to develop one work plan that addresses both Phase I and Phase II activities. A timeline of important dates and deliverables is included in **Appendix 2**.

CDC recognizes that some jurisdictions may need access to more than 80% of the awarded funds prior to completing all of the August 31 deliverables. CDC *does not* encourage awardees to delay or slow progress toward completing preparation due to funding restrictions. Awardees that need additional funds over and above the 80% should discuss their needs with their Division of State and Local Readiness project officer. Additionally, awardees that need access to restricted funds are strongly encouraged to complete their gap assessments, work plans, and detailed budgets prior to August 31. Restrictions on all remaining funds will be lifted following receipt of an acceptable gap analysis, work plan, and detailed, combined budget.
