CDC's February 10 PHEP Connects Webinar Highlights FDA Emergency Response Authorities

CDC's next PHEP Connects webinar is scheduled for **1 p.m. EST on Wednesday, February 10**. The February webinar will provide an overview of



the U.S. Food and Drug Administration's (FDA's) emergency preparedness and response tools to facilitate access to critical medical countermeasures (MCMs) and provide related resources for emergency response stakeholders. Presenters Brooke Courtney and Andrea Gormley from the FDA will discuss emergency use authorizations (EUAs) and provide an overview of FDA's COVID-19 response EUA efforts, as well as other emergency response authorities.

FEMA Prioritizes Funding for STLT Vaccination Sites

The Federal Emergency Management Agency (FEMA) is immediately prioritizing funding for state, tribal, local, and territorial vaccination (STLT) sites in efforts to help remove funding as a barrier to large-scale vaccination operations. The FEMA funding can support gaps not covered by other sources of COVID-19 supplemental funding or other CDC-provided funding. The FEMA COVID-19 Vaccination Planning FAQ describes eligibility guidance on activities related to vaccines. Immunization supplemental funding to jurisdictions should be the primary source of funding for vaccination activities. However, CDC encourages jurisdictions to engage with their state emergency operations staff regarding projects within the scope of this FEMA opportunity.

CDC COVID-19 Vaccine Communication Toolkits for CBOs and Essential Workers Now Available

COVID-19 vaccines will be available to essential workers and other community members soon. CDC has designed two toolkits to help build confidence in this new vaccine.

- COVID-19 Vaccination Communication Toolkit for Community-Based Organizations
- COVID-19 Vaccination Communication Toolkit for Essential Workers

The toolkits will help community-based organizations (CBOs) and employers educate community members and workers about COVID-19 vaccines, raise awareness about the benefits of vaccination, and address common questions and concerns. The toolkits contain a variety of resources, including key messages, an educational slide deck, FAQs, posters/flyers, newsletter content, a plain language vaccine factsheet that is available in eight languages, template letters, social media content, and vaccination sticker templates.

CDC encourages partners to adapt the key messages to the language, tone, and format that will resonate with their members or constituents. Partners may place their organizations' logos on materials that have a "Your Logo Here" square, but they should retain the CDC URL (www.cdc.gov).

PHAP Host Site Application Period to Close in February

CDC's Public Health Associate Program (PHAP) is currently accepting host site applications from interested organizations. The application deadline is **February 16**. Managed by CDC's Center for State, Tribal, Local, and Territorial Support, PHAP is a two-year, on-the-job training program for early-career public health professionals. State, tribal, local, and territorial public health departments; nongovernmental organizations; public health institutes and associations; academic institutions; and CDC quarantine stations can all apply to be PHAP host sites. Prospective host sites must be able to host an associate from October 2021 to October 2023.

PHAP associates can extend the reach of CDC programs while providing vital workforce support to public health agencies. The PHAP website contains helpful program and host site application information, including recorded webinars, information about eligibility, answers to frequently asked questions, and testimonials from previous host sites.
