CDC Modifies PHEP Operational Readiness Review Implementation Plan

On May 26, CDC provided information on modifications to implementation plan for the new PHEP Operational Readiness Review (ORR) system. The system will **not** open on July 1 and roll out will occur later in Budget Period 3 (BP3). Training webinars that began April 21 and were scheduled to continue over the next few months will be placed on hold until further notice.

CDC's Next PHEP Connects Webinar Scheduled for June 9

CDC's next PHEP Connects webinar, "New Jersey's Logistical Challenges in Responding to COVID-19 and Methods to Overcome Them," is scheduled for **1 p.m. on Wednesday, June 9**. This webinar will feature New Jersey's Department of Health Medical Countermeasures Bureau and its solutions to address the numerous logistical and inventory management challenges during the COVID-19 response. Marinee Temme, MCM

Bureau Chief and SNS coordinator, will discuss how the department tackled significant storage challenges in an existing warehouse, resolved a disposal issue while saving hundreds of thousands of dollars, and converted the problems into justification for major enhancements to a new facility under construction. Lawrence L. Heidenberg, MCM inventory management and technology coordinator, will then discuss the massive challenges surrounding COVID-19 inventory management and tracking, deficits under the existing system, the research into high-end technology options, and the ultimate selection that created a dynamic statewide inventory management system which provides critical real-time inventory reporting spanning all partners from state to local levels. Recipients Reminded of PERFORMS Browser Migration to Microsoft Edge in July

CDC anticipates that PERFORMS will transition from Internet Explorer to Microsoft Edge in July. To prepare for this upcoming transition, CDC encourages all recipients using PERFORMS to work with their respective IT departments to ensure Microsoft Edge is installed on computers used to access the PERFORMS system.

On August 17, Microsoft online services will no longer support Internet Explorer. With this change, PERFORMS will **not** be accessible using Internet Explorer. Recipients should ensure the Microsoft Edge browser is installed on their computers for a smooth transition.

June 3 COCA Call Focuses on Evaluating and Caring for Patients with Post-COVID Conditions CDC's next Clinician Outreach and Communication Activity (COCA) call will be held from 2 p.m. to 3 p.m. EDT on Thursday, June 3. During this call, clinicians will learn about CDC's new interim guidance which provides a framework for healthcare providers in their initial assessment, evaluation, management, and follow-up of persons with possible post-COVID conditions. Post-COVID conditions refer to the wide range of physical and mental health consequences experienced by some patients that are present four or more weeks after SARS-CoV-2 infection, including by patients who had initial mild or asymptomatic acute infection. Post-COVID conditions are still being characterized and include symptoms such as cognitive difficulties, fatigue, headache, dyspnea, and palpitations. Subject matter experts, physicians, and patient representatives from across the United States collaborated to develop the new guidance. Rapid recognition by healthcare providers of patients with post-COVID conditions and multidisciplinary care using the assessments and approaches described in this guidance could improve the wellbeing and treatment of people with post-COVID conditions. FDA Authorizes Additional COVID-19 Outpatient Treatment

The U.S. Food and Drug Administration (FDA), on May 26, issued an emergency use authorization (EUA) for an additional investigational COVID-19 outpatient treatment. This therapy is authorized by the Food and Drug Administration for emergency use for those with mild to moderate cases of COVID-19 who are at high risk of becoming seriously ill. Monoclonal antibody therapy augments the immune system's attack on the virus and may block the virus that causes COVID-19 from attaching to human cells, making it more difficult for the virus to reproduce and cause harm. The next CDC virtual instructor-led RealOpt© training session on vaccination and point-of-dispensing (POD) sites will be held at **1 p.m. EDT on Thursday**, **June 10.** Participants will learn the basic components of RealOpt©, a computer modeling program that determines POD or vaccination site staff requirements and examines process efficiencies based on site-specific configurations. With this tool, participants will learn to manipulate existing POD and vaccine flow models and how to run and interpret the performance reports. By the end of the session, participants will have learned how to build or modify their own models to identify where staff should be allocated and how to eliminate bottlenecks and optimize processing times.

CDC encourages POD and vaccination managers, local and state medical countermeasure planners, and other preparedness planners to register for a monthly training session. Registration for the RealOpt© training session is required through CDC TRAIN. Registration deadline is **seven days** prior to the course delivery date.

The last training session in this training series on vaccination and point-of-dispensing (POD) sites will be held on Thursday, July 8.
