

CDC Releases Interim Clinical Treatment Considerations for Severe Mpox Manifestations On March 3, CDC released a Morbidity and Mortality Weekly Report (MMWR) titled "Interim Clinical Treatment Considerations for Severe Manifestations of Mpox—United States, February 2023." The report provides updated clinical treatment considerations about using therapeutic countermeasures to treat severe mpox cases. Until data gaps are filled through randomized controlled studies and other carefully controlled research studies, this MMWR represents the best available information about human mpox treatment.
