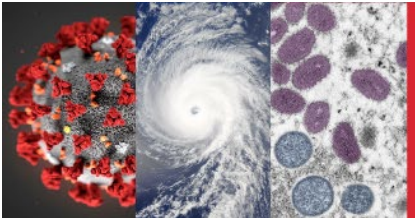

### **NACCHO to Host Webinar on Role of Local Public Health Workforce in Healthcare IPC**

The National Association of County and City Health Officials (NACCHO) will host a webinar on “The Role of Local Public Health Workforce in Healthcare IPC” from **2 p.m. to 3 p.m. EDT on Tuesday, September 19**. Participants will learn about the role and needs of the local public health workforce in healthcare infection prevention and control (IPC). These IPC practices aim to prevent and control the spread of infections, including healthcare-associated infections, antimicrobial resistant pathogens, and emerging infectious diseases, in healthcare settings. Local health departments play a critical role as frontline staff in supporting IPC in healthcare facilities.

NACCHO partners [WE Public Health](#) and [Cardea](#) will highlight the findings of a workforce environmental scan that characterized local health’s role in IPC and an assessment to identify essential skills to enhance local IPC workforce capacity and build impactful partnerships. These programs include Temporary Assistance for Needy Families (TANF), Community Services Block Grant (CSBG), Low Income Home Energy Assistance Program (LIHEAP), and Social Services Block Grant (SSBG). ### **September 21 COCA Call Highlights Algorithms for Diagnosing Endemic Environmental Fungal Diseases**

CDC will conduct a COCA call from **2 p.m. to 3 p.m. EDT on Thursday, September 21**. During this COCA call, CDC presenters will discuss the endemic mycoses blastomycosis, coccidioidomycosis (Valley fever), and histoplasmosis, which are environmental fungal diseases that are frequently misdiagnosed. Participants will learn about these infections’ epidemiology and diagnostic challenges. Participants will also be introduced to new clinical diagnostic algorithms to address these challenges and improve the timely diagnosis of blastomycosis, coccidioidomycosis, and histoplasmosis.

### **ACIP Approves Updated COVID-19 Vaccine Recommendation**

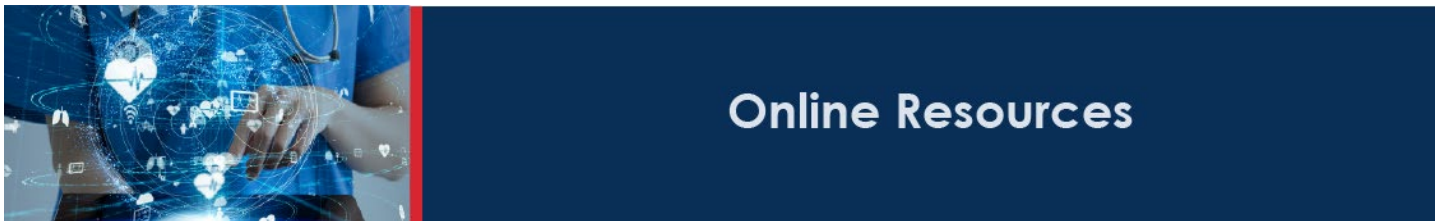
CDC has adopted the [Advisory Committee on Immunization Practices’ \(ACIP\)](#) recommendation that everyone ages six months and older get the updated COVID-19 vaccine. ACIP approved the recommendation during its

September 12 meeting. The updated COVID-19 vaccine is effective against the most commonly circulating variants, including BA.2.86, which CDC is closely monitoring. CDC expects the updated COVID-19 vaccine will be available in the United States this week and will be widely available through healthcare providers and pharmacies.

The ACIP will meet at **10 a.m. EDT on Friday, September 22**, to discuss maternal respiratory syncytial virus (RSV) recommendations. Visit CDC's [Respiratory Virus Updates](#) webpage for the latest science and recommendations on this topic.
