

New RFA Available to Enhance Local Forecasting and Analytics Capabilities

The National Association of County and City Health Officials (NACCHO), with support from CDC's Center for Forecasting and Outbreak Analytics, announced a new request for applications (RFA), Technical Assistance to Enhance Forecasting and Analytics Capabilities for Local Health Departments. The RFA is seeking a consultant or consulting firm to assist NACCHO with providing technical assistance to selected local health departments to strengthen capacity to integrate forecasting and analytical tools into infectious disease outbreak planning and response. The project will involve implementing tools and methodologies to enable local health departments to proactively predict and analyze disease outbreaks, thereby improving public health response and mitigating the impact of infectious diseases.

Completed applications must be submitted to phinformatics@naccho.org by 11:59 p.m. EDT on Tuesday, October 31. NACCHO will notify recipients on November 15, with an anticipated contract start date of December 1. The contract will conclude June 30, 2024.

FEMA and the American Red Cross created Preparedness Game, Super-Prepared Penguin Expansion Pack and Penguin Penguin Points Score Sheet. These resources are available for free digital download and mail order. This new game is a companion to the Preparedness Activity Book created by FEMA and the American Red Cross to teach young children about emergency preparedness.

Federal Select Agent Program Implements New Congressional Notification Process

CDC's Division of Regulatory Science and Compliance (DRSC), formerly the Division of Select Agents and Toxins (DSAT), is implementing a new Congressional notification process regarding any events or incidents at federal laboratory facilities involving the theft, loss, or release of select agents or toxins This requirement was codified in the <u>Prepare for and Respond to Existing Viruses, Emerging New Threats, and Pandemics Act (42 USC 262a(k)(1); Public Law 117-328, effective December 29, 2022.</u>

Such notifications must occur within 72 hours of the incidents This law also requires CDC to notify the committees of any measures taken to mitigate the risk to public health and any review of the circumstances to ensure corrective action is taken to prevent further events. Congress established the new requirements to enhance transparency, oversight, and accountability in managing select agents and toxins and to ensure swift and appropriate measures are taken to safeguard public health and safety.

CDC will soon begin submitting the required reports to the Committee on Health, Education, Labor, and Pensions of the Senate and the Committee on Energy and Commerce of the House of Representatives. As part of the new notification process, CDC also plans to notify PHEP directors in the jurisdictions in which the incidents occur. The first report will include all prior reports of thefts, losses, or releases from federal entities since December 29, 2022, the effective date of the new requirement.

ASPR Updates Strategic National Stockpile Office Name

To ensure consistency across programs, the Administration for Strategic Preparedness and Response (ASPR) will continue using the historical designation of "SLTT" when referencing state, local, tribal, and territorial jurisdictions. Effective October 6, the Strategic National Stockpile (SNS) will ensure all internal and external correspondence referring to jurisdictional partners uses the SLTT abbreviation. As part of this effort,

SNS is updating the name of its recently established office to the Office of State, Local, Tribal, and Territorial (SLTT) Preparedness.
